SELF-REGULATORY ORGANIZATIONS

ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

Pursuant to Rule 19b-4 under the Securities Exchange Act, the American, Midwest, New York and Philadelphia Stock Exchanges filed with the Commission proposed rule changes (SR-AMEX-90-20, SR-MSE-90-16, SR-NYSE-90-43 and SR-PHLX-90-33) which the Commission has approved on an accelerated basis that extend, until October 31, 1991, circuit breaker rules that will be activated during volatile market conditions. Publication of the approval is expected in the Federal Register during the week of October 29. (Rel. 34-28580)

APPROVAL OF PROPOSED RULE CHANGE

On October 26, the Commission approved a proposed rule change (SR-NASD-89-25) of the National Association of Securities Dealers under Section 19(b) of the Act and Rule 19b-4 thereunder that creates a new system, the ACT system, to facilitate the comparison and clearance of inter-dealer over-the-counter equity trades. Publication of the release is expected in the Federal Register during the week of November 5. (Rel. 34-28583)

Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
