UNLISTED TRADING PRIVILEGES GRANTED

Orders have been issued granting the applications of the following exchanges for unlisted trading privileges in securities which are listed and registered on one or more other national securities exchanges and are reported in the consolidated transaction reporting system: Midwest Stock Exchange - 8 issues (Rel. 34-28696); and Pacific Stock Exchange - 9 issues (Rel. 34-28697).

UNLISTED TRADING PRIVILEGES SOUGHT

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGES

Proposed rule changes have been filed under Rule 19b-4 of the Securities Exchange Act by the American Stock Exchange: SR-AMEX-90-26 to approve on a permanent basis the Exchange's position limit exemption for hedged equity options positions (Rel. 34-28692); and SR-AMEX-90-25 to list and trade options based on the EURO TOP-100 Index, a broad-based stock market index based on the performance of 100 leading European companies (Rel. 34-28693). Publication of the notices is expected in the Federal Register during the week of December 17.

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

Under Rule 19b-4 of the Securities Exchange Act, the National Association of Securities Dealers filed with the Commission a proposed rule change (SR-NASD-90-60) which has been approved on an accelerated basis. The rule change extends until December 31, 1991 circuit breaker rules that will be activated during volatile market conditions. Publication of the approval order is expected in the Federal Register during the week of December 17. (Rel. 34-28694)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

On November 26, the National Association of Securities Dealers filed a proposed rule change (SR-NASD-90-64) that amends the Rules of Practice and Procedure for the Automated Confirmation Transaction Service (ACT) to add Consolidated Quotation Service issues to the securities eligible for ACT processing. Publication of the order is expected in the Federal Register during the week of December 17. (Rel. 34-28702)

Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
