U.S. SECURITIES AND
EXCHANGE COMMISSION

ADMINISTRATIVE PROCEEDINGS

SANCTIONS IMPOSED AGAINST MERRY LAND & INVESTMENT COMPANY, INC.

The Commission issued an Order Instituting Proceedings under Section 15(c)(4) of the Securities Exchange Act of 1934 and Findings, Opinion and Order of the Commission against Merry Land & Investment Company, Inc. (MLIC). In its Order, the Commission found that MLIC violated Section 13(d) and Rule 13d-2 when MLIC failed to disclose accurately, and in a timely manner, MLIC's intent to initiate or support activities against the wishes of management of Bankers First Corporation (BFC), MLIC's intent to influence or control management of BFC, and MLIC's plan or proposal to nominate directors to the Board of BFC.

MLIC submitted an Offer of Settlement in which it consented to the findings contained in the Order, without admitting or denying such findings. (Rel. 34-26410)

CIVIL PROCEEDINGS

JONAS E. CURTISS AND NORMAN JEANNE PRODUCTIONS, INC. ENJOINED

The Commission announced that on December 29, 1988, Jonas E. Curtiss and Norma Jeanne Productions, Inc. (NJP) were permanently enjoined from violations of the registration and antifraud provisions of the Securities Act of 1933 and the antifraud provisions of the Securities Exchange Act of 1934 by U.S. District Judge Jim R. Carrigan, District of Colorado. Curtiss and NJP were also ordered to disgorge \$30,000 which, under the terms of the order, will be distributed to fully reimburse investors in NJP. The Final Judgment was entered by default.

Curtiss was chief executive officer of NJP, which was incorporated in California to market various products through use of the name or likeness of Norma Jeanne [sic] Baker, who was more commonly known as Marilyn Monroe. The Commission's Complaint alleged that in late 1987, Curtiss, NJP, and William Flynn, a registered representative in Denver against whom the Commission's case is still pending, offered for sale the unregistered securities of NJP through various means including an advertisement in Variety. The Commission also alleged that the three defendants made materially false and misleading statements, both orally and in writing, in connection with the offer for sale of the company's securities. (SEC v. William Flynn, et al., DCO, 88-C-1229). (LR-11954)

CRIMINAL PROCEEDINGS

MICHAEL R. BRYANT SENTENCED

The U.S. Attorney for the Northern District of Georgia and the Atlanta Regional Office announced that on December 16, 1988, U.S. District Judge Richard C. Freeman sentenced Michael R. Bryant of Roswell, Georgia to five years probation and ordered him to make restitution of \$149,002 for failing to make and keep, in connection with the business of Investment Management Associates, a registered investment adviser owned and controlled by Bryant, certain records as prescribed by the books and records provisions of the Investment Advisers Act of 1940, namely, securities purchase and sale journals, cash receipts and disbursement records, general and auxiliary ledgers, trial balances, financial statements, and internal audit work papers, said records being required as necessary and appropriate in the public interest and for the protection of investors. Bryant previously pled guilty on November 4, 1988 to a criminal information charging one count of violations of the recordkeeping provisions of the Investment Advisers Act. (U.S. v. Michael R. Bryant, Criminal Information No. CR-88-501A, USDC NDGA). (LR-11953)

INVESTMENT COMPANY ACT RELEASES

ABT GROWTH AND INCOME TRUST

An order has been issued on an application filed on behalf of various existing - future investment companies for which Palm Beach Capital Management, Ltd. or C. Financial Services, Inc. serve as investment adviser, sub-investment adviser, administrator or distributor, for an order approving certain exchange offers. (Rel. IC-1671 - Dec. 28, 1988)

EQUITABLE MONEY MARKET ACCOUNT, INC.; EQUITABLE TAX-FREE ACCOUNT, INC.; MARKETAMERICA TRUST

Orders have been issued declaring that Equitable Money Market Account, Inc.; Equitable Tax-Free Account, Inc.; and MarketAmerica Trust have ceased to be investment companies. (Rel. IC-16718; IC-16719; IC-16721 - Dec. 28, 1988)

LA CAISSE CENTRALE DESJARDINS DU QUEBEC

A notice has been issued giving interested persons until January 23 to request a hearing on an application filed by La Caisse centrale Desjardins du Quebec for an order exempting it from all provisions of the Investment Company Act to enable it to issue and sell its debt securities in the United States without registering as an investment company under the Act. (Rel. IC-16720 - Dec. 28, 1988)

HOLDING COMPANY ACT RELEASES

MASSACHUSETTS ELECTRIC COMPANY

An order has been issued authorizing a proposal by Massachusetts Electric Company and its parent, New England Electric System (NEES), whereby NEES will make capital contributions to Mass Electric in an aggregate amount not to exceed \$30 million through December 31, 1990. (Rel. 35-24792 - Dec. 28, 1988)

NATIONAL FUEL GAS COMPANY

A supplemental order has been issued authorizing National Fuel Gas Company, a registered holding company, to issue and sell its common stock under its two stock option plans up to an aggregate amount of 1.6 million shares and to extend the terms of the Plans to December 7, 1988. The notice of this proposal contained an order permitting a proposal by National to solicit proxies in connection with a shareholder vote on amendments to the Plans, at a meeting scheduled for February 16, 1989. (Rel. 35-24793 - Dec. 28, 1988)

LISTING, DELISTING AND UNLISTED TRADING ACTIONS

UNLISTED TRADING GRANTED

Orders have been issued granting the application of the following stock exchanges for unlisted trading privileges in the common stock of the specified number of issues which are listed and registered on one or more other national securities exchanges and are reported in the consolidated transaction reporting system: Midwest Stock Exchange - 24 issues. (Rel. 34-26405); and the Philadelphia Stock Exchange - 13 issues. (Rel. 34-26406)

SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by Midwest Clearing Corporation (SR-MCC-88-9) to establish its "Y" accounts for processing correspondent transactions. (Rel. 34-26403)

ACQUISITIONS OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
