### STAFF STUDY RELEASED DISCUSSING THE EFFECTS OF PROPOSED TAX LEGISLATION ON THE OCTOBER 1987 MARKET BREAK

A study by two SEC staff economists, Mark Mitchell and Jeffrey Netter, was released today that examines the effect of the introduction of legislation that would have imposed a tax on takeovers on the October 1987 decline in the stock market. (Press Release 89-27)

## CIVIL PROCEEDINGS

---

### MONTAINGE TRUST AND L & P HOLDINGS, LTD. ENJOINED BY DEFAULT

The Commission announced that on April 19 the U.S. District Court for the District of Columbia (Hon. Norma H. Johnson), on the Commission's motion, entered a Final Judgment of Permanent Injunction by Default against Montaigne Trust and L & P Holdings, Ltd. (also known as L and P Holdings, Inc.) permanently restraining and enjoining them from failing to file or causing the failure to file Schedules 13D and Forms 3 and 4 and from further violations of Sections 13(d) and 16(a) of the Securities Exchange Act of 1934 and the rules thereunder.

In its February 8, 1988 Complaint, the Commission alleged, among other things, that defendants failed to file required Schedules 13D and Forms 3 and 4 with respect to their ownership of Palmer Financial Corporation's common stock and that of its predecessor, Transworld Energy Corporation. (SEC v. Palmer Financial Corporation, et al., Civil Action No. 88-305-NHJ, DDC 1988). (LR-12082)

## SELF-REGULATORY ORGANIZATIONS

---

### APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change filed by: The Boston Stock Exchange (SR-BSE-86-3) to update certain of its rules and eliminate outdated material. (Rel. 34-26767); The Government Securities Clearing Corporation (SR-GSCC-89-2) authorizing it to enhance its comparison system by implementing a trade cancellation feature. (Rel. 34-26768); and The New York Stock Exchange (SR-NYSE-89-3) authorizing it to adopt a trade resolution system that would automate its trade comparison. (Rel. 34-26773)

### NOTICE OF PROPOSED RULE CHANGE

The National Association of Securities Dealers filed a proposed rule change under Rule 19b-4 (SR-NASD-89-15) that would amend Schedule C to its By-Laws to require members to submit applications for and maintain registrations of only such persons who intend to engage, or are engaged, in the investment banking or securities business for members. Publication of the proposal is expected to be made in the Federal Register during the week of May 1. (Rel. 34-26776)

### IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The American Stock Exchange filed a proposed rule change which became effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. The proposal (SR-Amex-89-9) relates to a delivery fee for delivery of shares to equity index participation holders. (Rel. 34-26778)

Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
