COMMISSION ANNOUNCEMENTS

LEGISLATIVE PROPOSAL TO AMEND INVESTMENT ADVISERS ACT RELEASED

The Commission today released a legislative proposal that would amend the Investment Advisers Act of 1940 primarily by adding a new section that would authorize the Commission to register one or more national investment adviser associations to provide a self-regulatory mechanism for investment advisers subject to Commission oversight. These associations would establish qualification and business practice standards, perform inspections and enforce compliance with the law. In releasing the proposal, David S. Ruder, Chairman of the Commission, noted, "The Commission believes that it is important to extend the same basic protections that now prevail in other segments of the securities industry."

CARREL APPLICATIONS NOW BEING ACCEPTED

Pursuant to the rules of the PUblic Reference Room that went into effect last November, the status of carrel allocations and telephone privileges for recognized user organizations (information dissemination companies) is to be reviewed each January and July. Applications for reserved carrels and telephone privileges will be accepted until June 28, 1989. Application forms are available in the Public Reference Room. Information dissemination companies that are unable to pick up forms in Washington may submit applications by writing to April Keyes, Chief, Public Reference Branch, Securities and Exchange Commission, 450 Fifth Street, NW, Room 1024, Mail Stop 2-6 and should include a brief description of the business, business address and telephone, the name of a person who will serve as on-site contact in the Room, and the names of all persons who work everyday in the Room. The application must be reviewed and signed by a responsible company official. Any company that does not currently have an employee in the Room everyday must certify that it will have a staff member on-site no later than July 30, 1989 in order to be eligible for consideration for carrel and telephone privileges. The Commission intends to continue to reserve approximately 15 carrels for the general public. Questions concerning application procedures may be addressed to Ms. Keyes at (202) 272-7450.

ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS INSTITUTED AGAINST WILLIAM R. BEACH

The Commission instituted public administrative proceedings under Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 against William R. Beach, a former registered representative, to determine what, if any, remedial action is appropriate and in the public interest. The Order alleges that Beach was convicted on September 27, 1988, on four counts of mail fraud in violation of 18 U.S.C. \$1341, in connection with his scheme to defraud persons by selling non-existent certificates of deposit [U.S. v. William R. Beach, N.D. Indiana, Hammond Division, Case No. HCR 88-0010-01]. Beach is presently serving 33 months in federal prison, and is under order to pay restitution in the amount of \$889,250. A hearing will be scheduled to take evidence on the staff's allegations and to afford an opportunity to present any defenses thereto. (Rel. 34-26919)

ROWNSTONE-SMITH SECURITIES CORP., MICHAEL L. DONNELLY 1974 \$100,000 UNDER ORDER OF DISGORGEMENT

The Atlanta Regional and Miami Branch Offices announced that on June 6 Brownstone -Smith Securities Corp., a registered broker-dealer, and its president, Michael L. Donnelly of Pompano Beach, Florida, paid \$100,000 under a Final Judgment of Permanent Injunction, which required defendants Brownstone-Smith and Donnelly to disgorge profits of \$100,000 by June 9, 1989. Brownstone-Smith, which has ceased its opera-

tions, formerly maintained its office in Fort Lauderdale, Florida. the Final Judgment permanently enjoins the defendants from further violations of the books and records provisions of the federal securities laws.

The Commission's complaint alleges that between February 1987 and January 1988, the defendants: (1) sold certain securities at excessive, undisclosed mark-ups over the prevailing market price of the securities; (2) failed to disclose to customers Brownstone-Smith's domination and control of the market for certain securities; and (3) manipulated trading prices of certain securities. The complaint further alleges that Brownstone-Smith, aided and abetted by Donnelly, failed to maintain records indicating the times at which transactions with its customers were ordered or effected. The defendants consented to the Final Judgment without admitting or denyig the allegations in the complaint. (SEC v. Brownstone-Smith Securities Corp. and Michael L.
