RULES AND RELATED MATTERS

EXEMPTION FROM REGISTRATION REQUIREMENTS OF SECURITIES BY RESOLUTION FUNDING CORPORATION

The Commission issued an order, pursuant to express statutory authority granted under Public Law No. 101-73, the Financial Institutions Reform, Recovery, and Enforcement Act of 1989, granting an exemption from the registration requirements of Section 5 of the Securities Act of 1933 for the \$30 billion of debt securities to be offered and sold by the Resolution Funding Corporation. (Rel. 33-6844)

The Commission also adopted an emergency rule defining the securities to be issued as "exempted securities" for purposes of the Securities Exchange Act of 1934 [see Rel. 34-27231].

EMERGENCY RULE 3a12-10 ADOPTED

The Commission adopted emergency Rule 3a12-10 under the Securities Exchange Act of 1934 defining the securities issued by the Resolution Funding Corporation as "exempted securities" for purposes of those provisions of the Exchange Act that by their terms do not apply to an "exempted security" or to "exempted securities." (Rel. 34-27231)

The Commission also issued an order exempting the offers and sales of the securities to be issued from the registration requirements of the Securities Act of 1933 [see Rel. 33-6844].

ADMINISTRATIVE PROCEEDINGS

ORDER MODIFYING PRIOR ORDER

The Commission ordered that the Order Instituting Proceeding under Sections 15(b)(4) and (6) of the Securities Exchange Act of 1934 and Findings and Order of the Commission against Jefferies & Company, Inc. and Boyd L. Jefferies, entered on March 10, 1987, be modified to allow Jefferies & Co. until September 15 to submit the report of an outside reviewer required by the Order.

Respondents consented to the Order without admitting or denying the allegations contained therein. The Order, among other things, required Jefferies & Co. to comply with the undertakings contained in its Offer of Settlement. Jefferies & Co. undertook, among other things, to submit to the Commission a report and recommendations of an outside consultant and, thereafter, to submit to the Commission the report of an outside reviewer concerning whether Jefferies & Co. had adopted and implemented the outside consultant's recommendations. Jefferies & Co. has requested that the time allowed for the submission of the outside reviewer's report be extended until September 15. The Commission determined that it is appropriate to grant Jefferies & Co.'s request. (Rel. 34-27206)

The Commission issued an Order Instituting Public Proceedings, Accepting Offer of Settlement, Making Findings and Conclusions, and Imposing Remedial Sanctions under Rule 2(e) of the Commission's Rules of Practice as to Noemi L. Rodriguez Santos. In the Order, the Commission found that Santos, a certified public accountant, prepared materially false and misleading financial statements for TRX Industries, Inc.; approved amendments to those financial statements; rendered a materially false and misleading opinion on each of those financial statements; and acted with scienter. The Commission concluded that Santos engaged in unethical or improper professional conduct and wilfully violated the antifraud provisions of the Securities Exchange Act of 1934 and Rule 10b-5. The Commission barred Santos from appearing or practicing before the Commission but allowed her to apply for reinstatement after five years upon a showing that she has satisfied certain educational and professional associational requirements. Santos, without admitting or denying the findings, consented to the July 12, 1989 Final Judgment enjoining her from violating the antifraud provisions [see LR-12150; AAER-234]. (Rel. 34-27209)

CIVIL PROCEEDINGS

FINAL JUDGMENT FILED AGAINST TORONTO-DOMINION BANK

The New York Regional Office today filed a Final Judgment which would enjoin The Toronto-Dominion Bank (TDB) from future violations of Section 7(d) of the Securities Exchange Act of 1934 and Regulation U promulgated by the Board of Governors of the Federal Reserve System (Federal Reserve Board). In addition, the Final Judgment would enjoin The Toronto-Dominion Trust Company (TDB Trust), subsidiary of TDB, from aiding and abetting future violations of Section 7(f) of the Exchange Act and Regulation X promulgated by the Federal Reserve Board. TDB and TDB Trust consented to the Final Judgment without admitting or denying the allegations in the Commission's Complaint. The Final Judgment would require that TDB and TDB Trust undertake certain remedial measures to reasonably prevent the relevant alleged violative conduct, and would further require that TDB conduct all of its securities clearance operations within the U.S. through TDB Trust or a Commission registered broker-dealer which is not affiliated with TDB in any manner, except contractually as a securities clearance agency. (SEC v. Hansen, et al., SDNY, 89 Civ. 5242, RO). (LR-12246)

AMENDMENT TO A PROPOSED RULE CHANGE

The National Securities Clearing Corporation filed an amendment to its proposed rule change (SR-NSCC-89-8) relating to the processing of basket trades. The amendment describes how NSCC will facilitate specialist involvement in New York Stock Exchange basket trading and amends NSCC's fees to reflect charges for processing basket trades. IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The Options Clearing Corporation filed a proposed rule change which became effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. The proposal (SR-OCC-89-11) consolidates OCC's Membership and Margin Committees. (Rel. 34-27211)
