## COMMISSION ANNOUNCEMENTS

---

### FOIA APPEAL OF HARVEY L. PITT

The General Counsel sent a letter to Harvey L. Pitt in response to his request for documents relating to sanctions in Commission enforcement proceedings. Pursuant to Exemption 5 of the FOIA, the FOIA Office had withheld certain portions of a computer printout and all of a draft, internal memorandum, which were responsive to Mr. Pitts' request.

The General Counsel affirmed in part and reversed in part. His letter of decision explains that the draft, internal memorandum was properly withheld pursuant to Exemption 5 because it falls within the deliberative process and attorney-client privileges. The printout and an appendix to the memorandum will, however, be released because both contain primarily non-exempt factual information. Certain portions of the printout that reflect opinions of the Commission staff were properly withheld pursuant to Exemption 5. A few additional portions of the printout identify individuals who were not charged with, or who have not been found to have engaged in, wrongdoing; such passages could reasonably be expected to constitute an unwarranted invasion of personal privacy and will be withheld pursuant to Exemption 7(C). ## CIVIL PROCEEDINGS

---

### EDWARD M. GRUSHKO ENJOINED

The Chicago Regional Office announced that on September 11 Judge Gessell, U.S. District Court for the District of Columbia, entered a Final Judgment of Permanent Injunction against Edward M. Grushko enjoining him from violating or aiding and abetting violations of the antifraud and periodic filing provisions. Grushko consented to the Injunction without admitting or denying the allegations in the Complaint.

The September 5 Complaint alleged that Grushko, a New York City securities attorney, was counsel to two blind pool issuers, GSS Ventures Capital Corp. and Green Mountain Venture Corp. (the predecessor of Sherwood Financial Ltd., later Max, Inc.) for purposes of preparing certain periodic filings. The Complaint further alleged that Grushko, as issuers' counsel, filed Forms 10-K, 10-Q, and 8-K which contained misstatements and omissions of material fact concerning the identity of persons in control of the issuer, the capitalization of the issuer, the true nature of certain proposed and actual transactions entered into by the issuers, the viability of proposed mergers, and changes in the officers and directors of the issuers. Further, the Complaint alleges that Grushko's conduct, as issuers' counsel, was at a minimum reckless. (SEC v. Edward M. Grushko, USDC DC, Civil Action No. 89-2477). (LR-12252)

## CRIMINAL PROCEEDINGS

---

### JOHN WORTHEN PLEADS GUILTY

The U.S. Attorney for the Southern District of California and the Denver Regional and Salt Lake Branch Offices announced that on September 11 John Worthen entered a plea of guilty to four counts of indictment charging him with criminal contempt of an Injunction entered in 1974. The Injunction prohibited Worthen from antifraud violations and from the sale of unregistered securities. The securities involved in the criminal contempt case were Western Pacific Technology, Inc. and Nordic Ltd., Inc.

Worthen, a recidivist penny stock promoter, is scheduled to be sentenced November 13. The criminal contempt statute under which Worthen was charged does not limit the amount of fine or imprisonment which the court may impose. (U.S. v. John E. Worthen, USDC SDCA, Criminal Action No. 87-1387-N). (LR-12253)
