CIVIL PROCEEDINGS

CIVIL INJUNCTIVE ACTION FILED AGAINST NEW AGE INDUSTRIES, INC.

The Commission filed a civil injunctive action on October 23 in the U.S. District Court for the District of Columbia against New Age Industries, Inc., a Florida blind pool corporation, with its principal executive offices in North Lauderdale, Florida.

The Complaint alleges that New Age violated Section 15(d) of the Securities Exchange Act of 1934, Rules 12b-25, 15d-1, 15d-11, and 15d-13, and Rule 463 under the Securities Act of 1933 because the company failed to file timely, accurate, and in proper form Annual, Quarterly, and Current Reports, Notifications of Late Filing, and Forms SR. Among other deficient filings made by New Age, it filed a Current Report on Form 8-K, stating that it had acquired GMO Petroleum Resources, Inc., but did not include audited and pro forma financial statements as required under Item 7 of Form 8-K. Subsequently, New Age filed a Current Report on Form 8-K with the Commission reporting that it had rescinded the purchase of GMO in its entirety.

The Commission is seeking to restrain and enjoin New Age from violating Sections 13(a) and 15(d) of the Exchange Act, Rules 12b-25, 13a-1, 13a-11, 13a-13, 15d-1, 15d-11, and 15d-13, and Rule 463 under the Securities Act, and ordering New Age to file a Final Report of the Offering of Securities and Use of Proceeds therefrom on Form SR.

Admitting the allegations in the Complaint, New Age simultaneously consented to the relief sought by the Commission. (SEC v. New Age Industries, Inc., USDC DC, Civil Action No. 89-2942). (LR-12277)

INVESTMENT COMPANY ACT RELEASES

CAPSTONE INTERNATIONAL SERIES TRUST

A notice has been issued giving interested persons until November 13 to request a hearing on an application filed by Capstone International Series Trust requesting an order exempting it from the provisions of Section 12(d)(1)(A) of the Investment Company Act to permit it to invest in securities of foreign banks and foreign insurance companies beyond the percentage limitations contained in that section. The order would also exempt Applicant from the provisions of Section 12(d)(3) of the Act and Rule 12d3-1 to permit it to invest in the equity securities of persons that, in their most recent fiscal year, derived more than 15% of their gross revenues from securities related activities but which securities do not satisfy the "margin security" requirement specified in Rule 12d3-1(b)(4). FIRST UTILITY FUND, INC.

A notice has been issued giving interested persons until November 13 to request a hearing on an application filed by First Utility Fund, Inc. for an order declaring that it has ceased to be an investment company. (Rel. IC-17185 - Oct. 19)

BOSTON FINANCIAL QUALIFIED HOUSING TAX CREDITS L.P. V

A notice has been issued giving interested persons until November 13 to request a hearing on an application filed by Boston Financial Qualified Housing Tax Credits L.P. V, a Limited Partnership, and its managing general partner, Arch Street V, Inc., exempting the Partnership from all provisions of the Investment Company Act. The Partnership will operate as a "two-tier" limited partnership by investing in other limited partnerships that in turn will engage in the development, ownership, and operation of housing for low and moderate income persons.
