INVESTMENT COMPANY ACT RELEASES

VARIABLE ACCOUNT A OF SKANDIA LIFE AMERICA CORPORATION

An order has been issued declaring that Variable Account A of Skandia Life America Corporation has ceased to be an investment company as defined by the Investment Company Act. (Rel. IC-17264 - Dec. 14)

HOLDING COMPANY ACT RELEASES

APPALACHIAN POWER COMPANY

A notice has been issued giving interested persons until January 2, 1990 to request a hearing on a proposal by Appalachian Power Company, an electric utility subsidiary of American Electric Power Company, Inc., a registered holding company, to alter the terms and conditions of installment payments for pollution control facilities, under an agreement between Appalachian and Mason County, West Virginia to reflect the terms of pollution control revenue bonds to be issued by the County. SELF-REGULATORY ORGANIZATIONS

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

On December 7, the Commission extended on an accelerated basis a proposed rule change filed by the Depository Trust Company (SR-DTC-89-01) authorizing DTC to institute on a pilot basis a new Rush Withdrawal Transfer (RWT) service. The approval order allows DTC to operate the service on a temporary basis until March 31, 1990. (Rel. 34-27518)

Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
