PNC FUND
GLENMEDE FUND, INC.

Orders have been issued granting exemption to the following applicants from Section 12(d)(3) of the Investment Company Act: PNC FUND (Applicant), its International Portfolio, Capital Appreciation Portfolio (formerly, the Equity Portfolio), (Rel. IC-17271); and any other present or future investment portfolios which will invest in securities of foreign issuers; and GLENMEDE FUND, INC. (Applicant), subject to certain conditions, to permit it to invest in the securities of certain foreign securities companies (Rel. IC-17275 - Dec. 20)

INTEGRATED CORPORATE INVESTORS FUND

An order has been issued under Section 8(f) of the Investment Company Act, declaring that Integrated Corporate Investors Fund, Inc. has ceased to be an investment company. (Rel. IC-17272 - Dec. 20)

VOYAGER VARIABLE ANNUITY ACCOUNT D CAL-WESTERN VARIABLE FUND C

Notices have been issued giving interested persons until January 16, 1990, to request a hearing on applications filed by the following applicants seeking orders under Section 8(f) of the Investment Company Act of 1940 declaring that applicants have ceased to be investment companies: VOYAGER VARIABLE ANNUITY ACCOUNT D (Rel. IC-17273 - Dec. 20); and CAL-WESTERN VARIABLE FUND C (Rel. IC-17274 - Dec. 20)

WESTERN LIFE INSURANCE COMPANY

An order has been issued exempting Western Life Insurance Company (Western Life), Variable Account C of Western Life Insurance Company (Account C), and AMEV Investors, Inc., from Sections 2(a)(32), 22(c), 26(a)(2)(C), 27(a)(3), 27(c)(1), 27(c)(2), and 27(d) of the Investment Company Act and Rules 22c-1, and 6e-3(T)(b)(12), (b)(13) and (d)(1)(ii) to the extent necessary to permit the issuance of certain flexible premium variable life insurance contracts that would allow Western Life to (1) credit the policyholder's account with a "policy value advance" and later recover the policy value advance from the assets of Account C through a \$4.00 monthly deduction and a daily deduction at an annual rate of .27% of the value of the policy's net assets; (2) deduct any premium tax charge not previously deducted as part of a contingent deferred charge; and (3) deduct sales charges, in part, by means of a constant \$4.00 monthly charge, and by means of charges that may cease and resume under certain circumstances. (Rec. IC-17276 - Dec. 20)

CANCELLATION OF INVESTMENT ADVISER REGISTRATIONS

The Commission has issued a notice giving interested persons until January 19, 1990 to comment regarding the proposed cancellation of certain investment adviser registrations for failure to comply with the filing requirements of Rule 204-1 under the Investment Advisers Act. (Rel. IA-1213)

UNLISTED TRADING SOUGHT

The Commission has approved proposed rule changes filed by the following exchanges for the specified purposes: American Stock Exchange (SR-AMEX-89-17) to require members effecting short sales to make prior arrangements to borrow the stock or obtain acceptable assurances that delivery can be made on settlement date (Rel. 34-27542) and (SR-AMEX-89-06) to adopt a new fine system for general rule violations (new Rule 590) and to amend its minor disciplinary rule violation enforcement and reporting plan under Section 19(d)(1) of the Securities Exchange Act (Rel. 34-27543); Depository Trust Company (SR-DTC-89-15) to amend DTC's International Institutional Delivery system to permit participation in the IID system by non-U.S. entities (Rel. 34-27545); and New York Stock Exchange (SR-NYSE-89-21) to revise listing fees for outstanding issues and debt American Depository Receipts (Rel. 34-27546)

NOTICE OF PROPOSED RILLE CHANGE

The National Association of Securities Dealers, Inc. (SR-NASD-89-57) has filed a proposed rule change under Rule 19b-4 that would require the issuer of each security designated for inclusion in the NASDAQ/National Market System to pay an annual participation fee of \$2,000 in addition to the current annual fee. Publication of the proposal is expected to be made in the <u>Federal Register</u> during the week of December 11. (Rel. 34-27544)
