PRESENTAION: CITY OF BELLEVUE

Alex O'Reily, Planner, City of Bellevue, provided an overview of the top human service needs of workers employed by Bellevue's small to middle-sized employers and asked Board members to identify gaps in services and barriers for the developmental disabilities community in Bellevue.

Bellevue City Council and the Human Services Commission asked staff to survey the business sector every two years to develop a comprehensive human services needs assessment report to help guide the decisions on how to allocate limited resources in the face of growing needs. The Board identified the following top three issues: Employment, Transportation, and Housing.

PRESENTATION: HOUSING OVERVIEW

Beth Boram, Housing Planner, Housing and Community Development, provided an overview of the King County Developmental Disabilities Division's collaboration with the King County Housing Finance Program for the development of new and affordable housing for persons with developmental disabilities.

OTHER BUSINESS

Ted Daniels suggested that the Board write a letter to the King County Parent Coalition to thank them for their commitment to the DD community.

LEGISLATIVE REPORT

Cathy Murahashi, King County Parent Coalition provided an update of the side-by-side comparison of the Governor, House, and Senate budget proposals and a Bill status report.

PLANNING COMMITTEE REPORT

Leo Finnegan reported that the Board created a topic list for future Planning Committee meetings and below are a few of the topics:

- Educate Board members on DD programs;
- Describe Vendor services (history, purpose, and goals);

- Board requested more information on Housing and suggestions on ways to encourage groups to assist residents with housing chores.
