



OREGON ENTRY POLICY FOR OVER-DIMENSION LOADS

Motor carriers transporting oversize or overweight loads that originate in Oregon must obtain a variance permit and the driver must possess that permit prior to transport.

Motor carriers entering Oregon with an oversize or overweight load must obtain a variance permit and the driver must possess that permit prior to entering the State *except* as provided in (1), (2) AND (3) below:

- (1) Enter Oregon at one of the Entry Points and travel directly to the corresponding ODOT Registration Office shown below.
- (2) Arrive during Registration Business Hours: 8AM to 5PM (except Farewell Bend - 7AM to 4PM); Monday through Friday*.
 *Closed on ALL State Observed Holidays: New Year's Day, Martin Luther King Day, President's Day, Memorial Day, Independence Day, Labor Day, Veteran's Day, Thanksgiving Day and Christmas Day. **Note:** All time is displayed in Pacific Time.

IMPORTANT: If you enter Oregon and the Registration Office is closed, you are subject to citation, a fine, AND you may not proceed until the driver possesses a variance permit.

Note: Drivers entering Oregon at any other location must obtain and possess their variance permits prior to entry. Registration services are *not* available at the Cascade Locks, Woodburn, or Klamath Falls scales.

(3) Dimensions or Weights do NOT exceed the following:

HEIGHT - 14 feet

WIDTH - 14 feet

PILOT VEHICLES - Unless operating with a front and rear pilot vehicle; warning lights as described in OAR 734-082-0036 are required when width exceeds 10' on a 2-lane highway or 12' on a 4-lane highway. Loads exceeding 12' on a 2-lane highway must use a front pilot vehicle.

LENGTH - 53-foot Semitrailer,
 75-foot Hauling Equipment for Truck-tractor/semitrailer combinations,
 105-foot Overall Length inclusive of Jeeps and Boosters

GROSS WEIGHT -
Non-Divisible Load: 200,000 pounds or Weight Table 5

Divisible load: must maintain legal axle and groups of axle weights and the total gross vehicle weight shall not exceed 105,500 pounds or the weights in Weight Tables 1 & 2.

 Closed on ALL State Observed Holidays* (listed above) and closed on Wednesdays, noon to 1PM.
- **ODOT Registration Offices** only issue annual permits to customers at specified Entry Points.

THIS POLICY does not authorize vehicles to operate in or enter Oregon prior to obtaining tax and registration credentials. Tax and registration services are available from Salem Registration Services – Call 503-378-6699, 24 hours a day, 7 days a week. Phone service is not available on New Year's Day, Thanksgiving Day, and Christmas Day.

Note: Limited registration services are available after hours, between 5PM and 8AM, on weekdays, weekends, and holidays.

THIS POLICY does not authorize a vehicle to exceed the size or weight limits posted on a highway. Due to road construction or other circumstances, highways may be temporarily closed or restricted to lesser dimensions or weight.
