OREGON AUTOMATIC EXTENSION FOR INDIVIDUALS AND EXTENSION PAYMENT COUPON

• Please read the instructions carefully. **Note to fiscal year taxpayers:** File Form 40-EXT by the regular due date of your return.

Use Form 40-EXT **only** if:

- You cannot file your Oregon return by April 15, 2004, **AND**
- You are making a tax payment to Oregon. (File Form 40-EXT with your payment even if you also filed a federal extension),
- OR**
- You are not filing a federal extension and you only need more time to file for Oregon only.

Complete the tax payment worksheet below to determine if you owe Oregon tax.

- Fill out the payment coupon below and mail your completed coupon and your payment to the Oregon Department of Revenue by April 15, 2004 to avoid late payment penalties.
- To help us speed processing, we ask that you **use blue or black ink** to fill out your coupon and check. **Do not use red ink or gel pens and do not postdate your check.**

REMEMBER, an extension of time to file your return is not an extension of time to pay your tax. If you do not pay at least 90 percent of your total tax liability by April 15, 2004, a 5 percent late payment penalty, plus interest, may be added to your tax due. If you do not file your return by August 15, 2004, you may be assessed an additional 20 percent penalty, plus interest.
