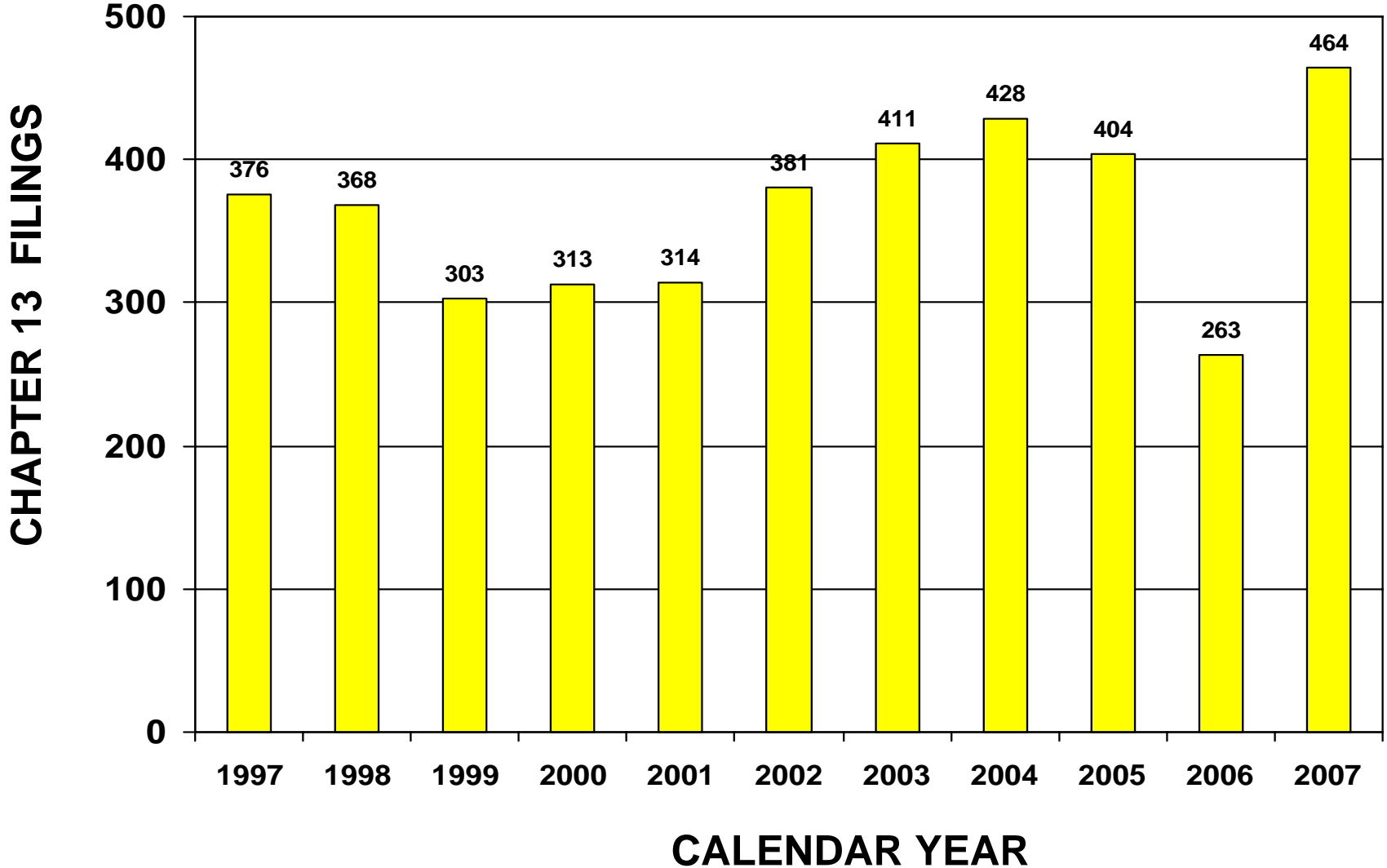

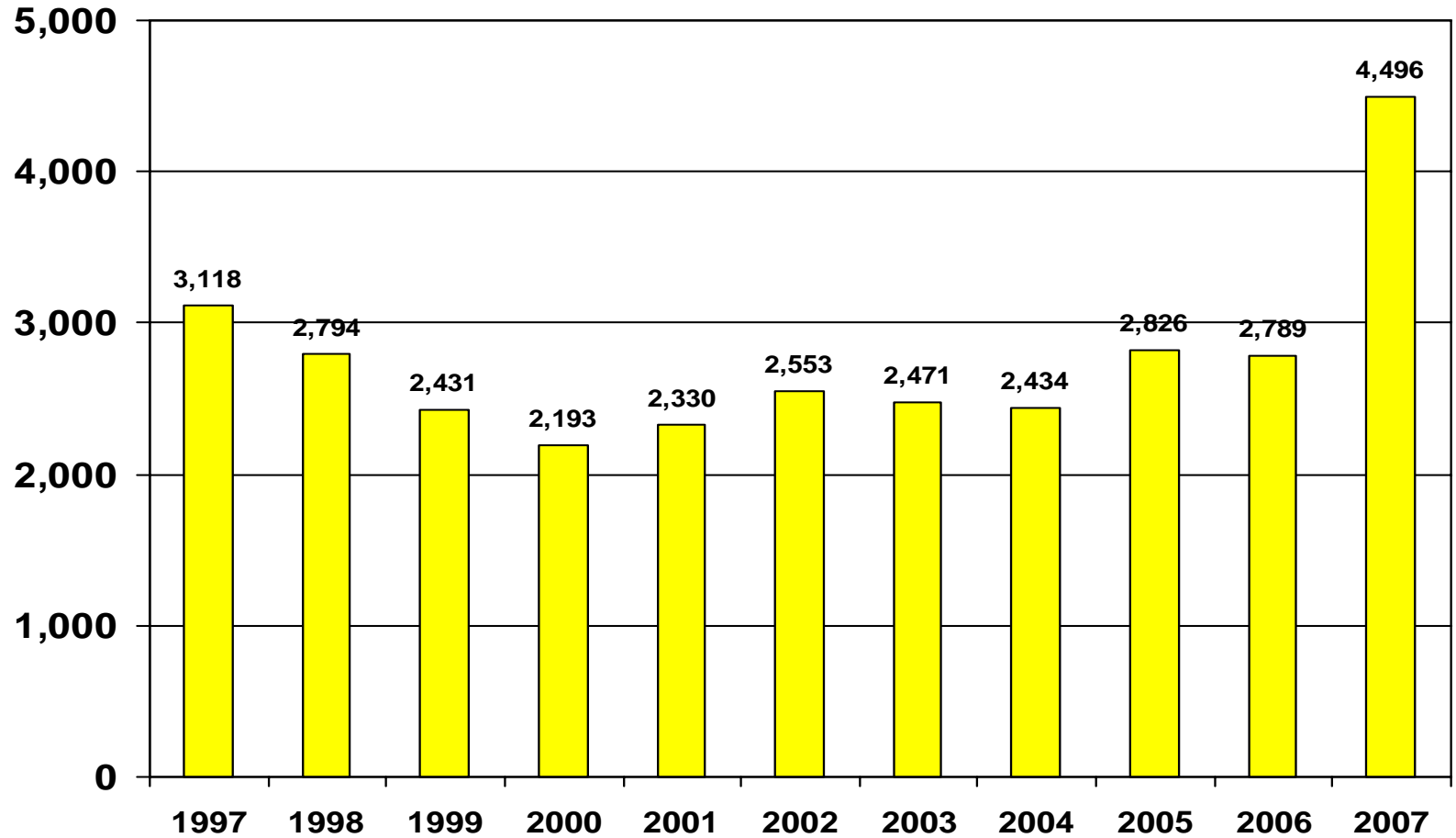
This chart shows chapter 13 case filings in Maine for calendar years 1997 through 2007. Chapter 13 filings averaged 366 per year during this period.

This chart shows chapter 13 case filings in Massachusetts for calendar years 1997 through 2007. Chapter 13 filings averaged 2,767 per year during this period.

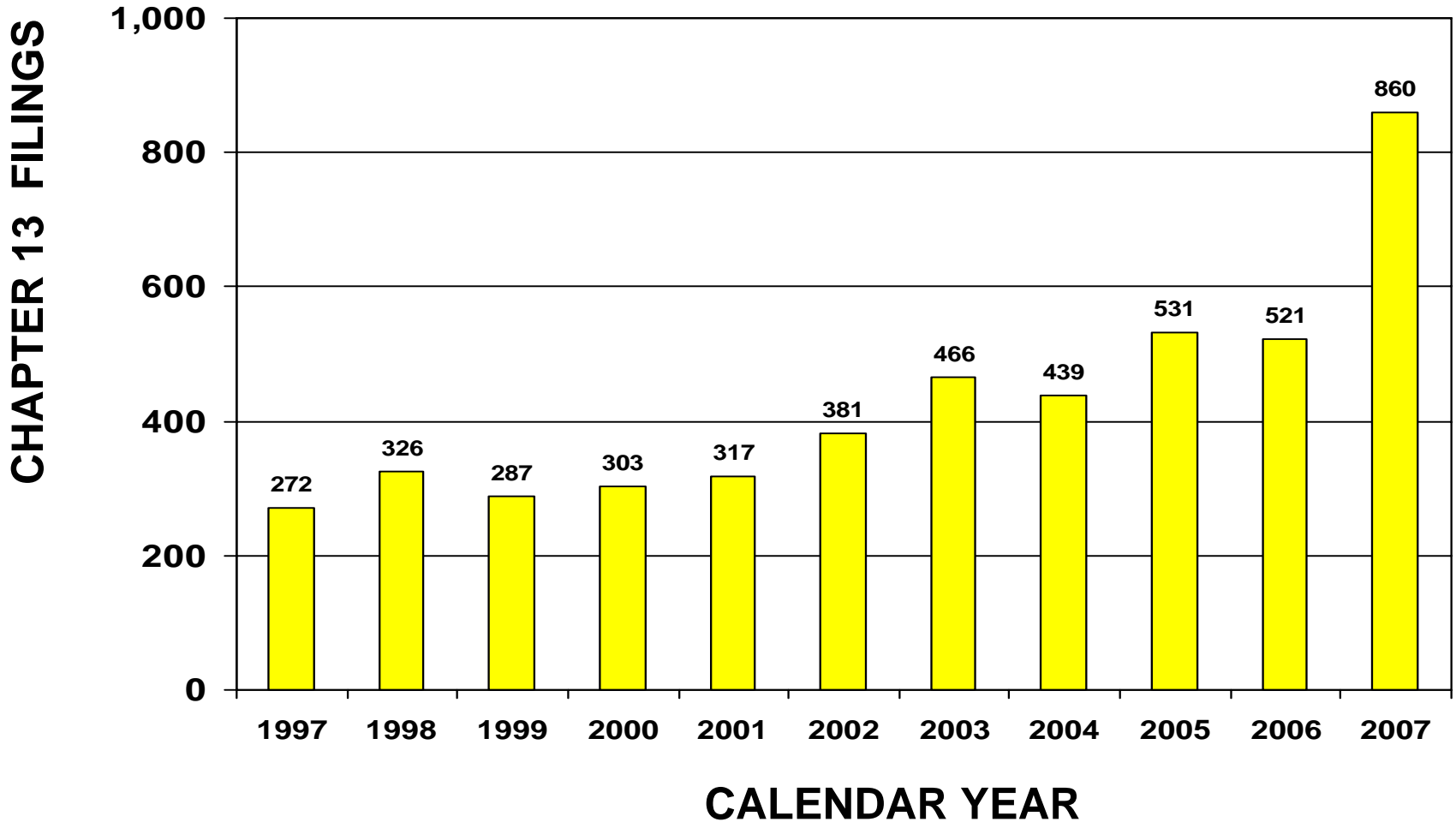

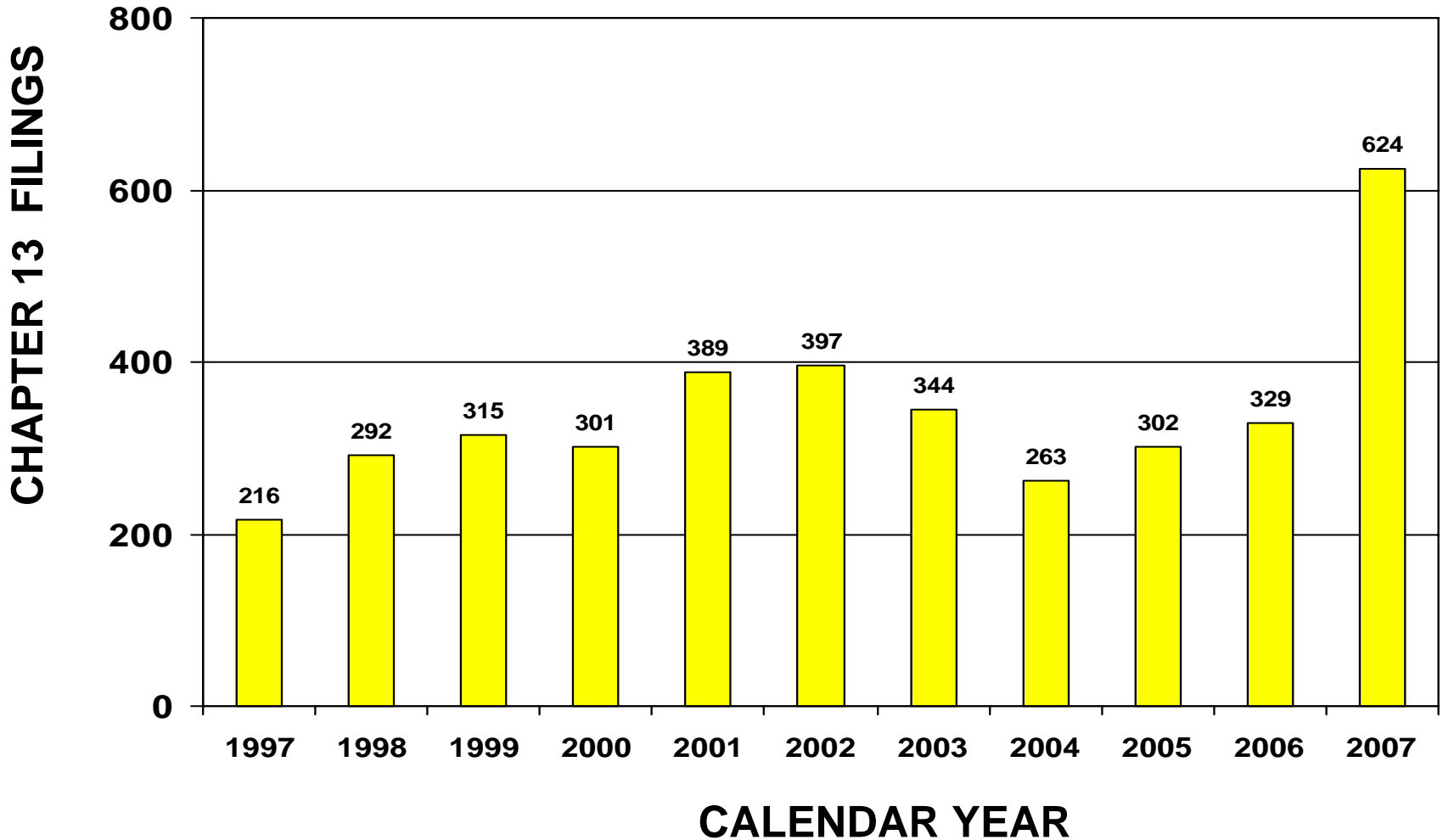

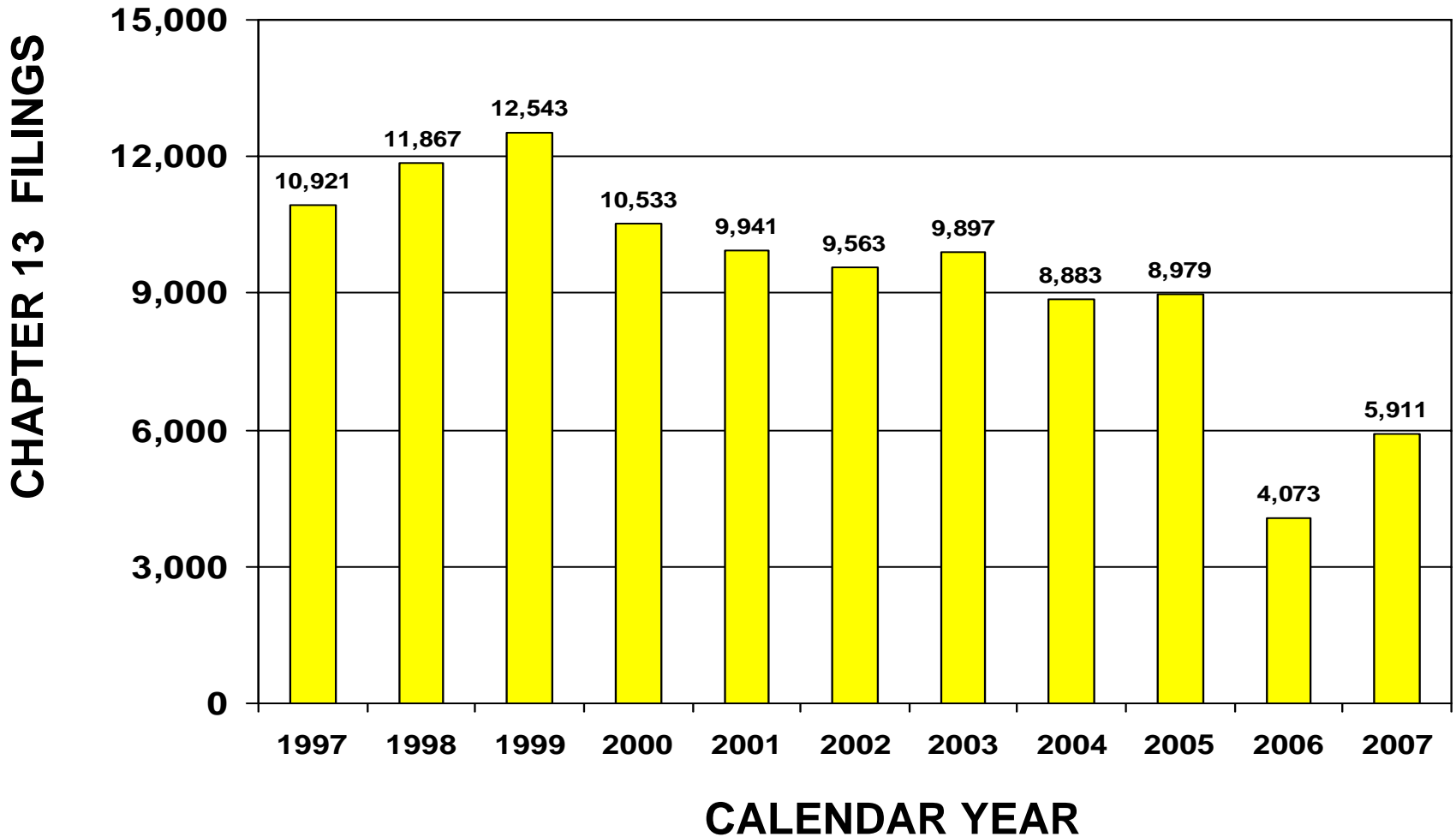

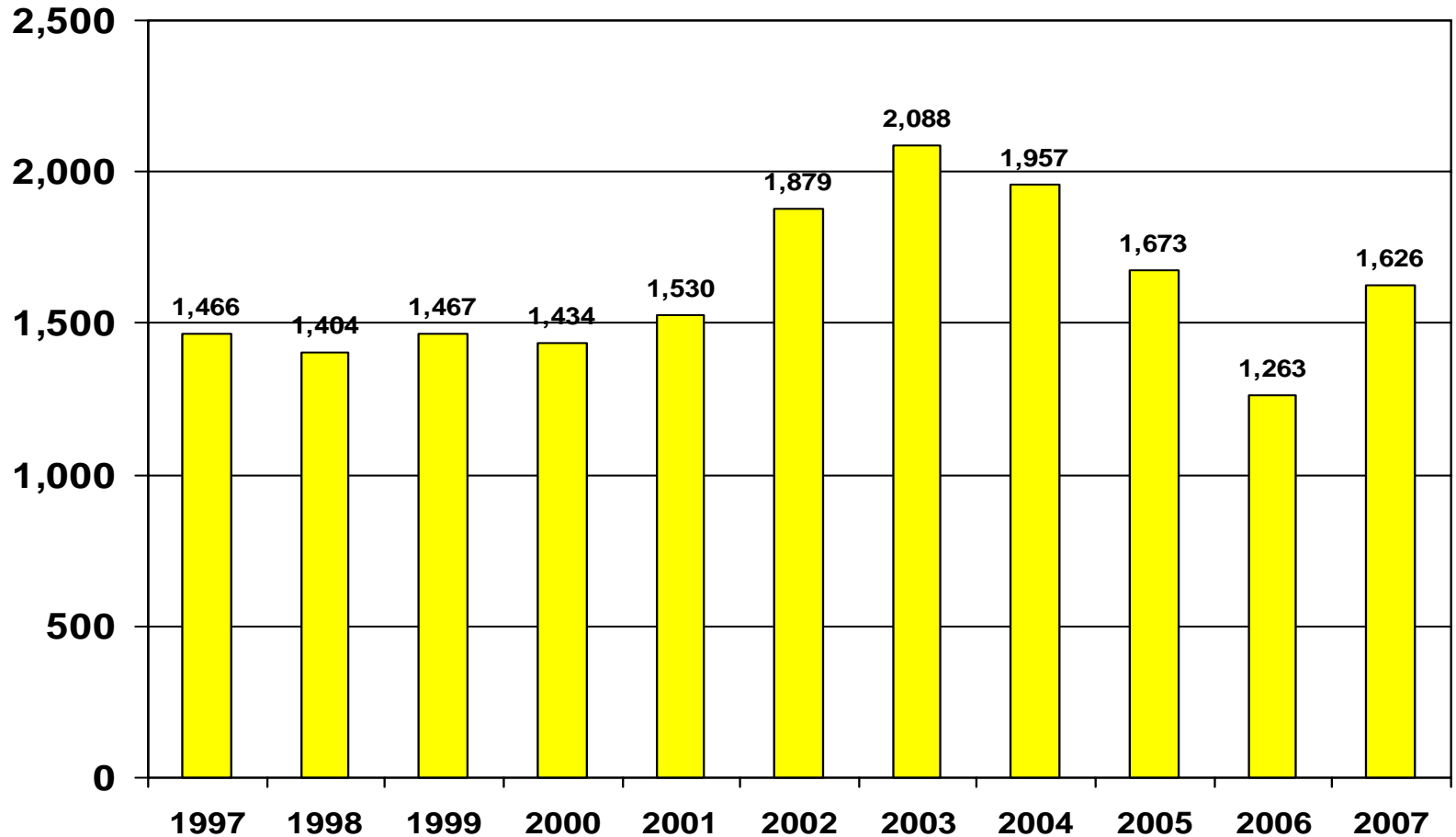

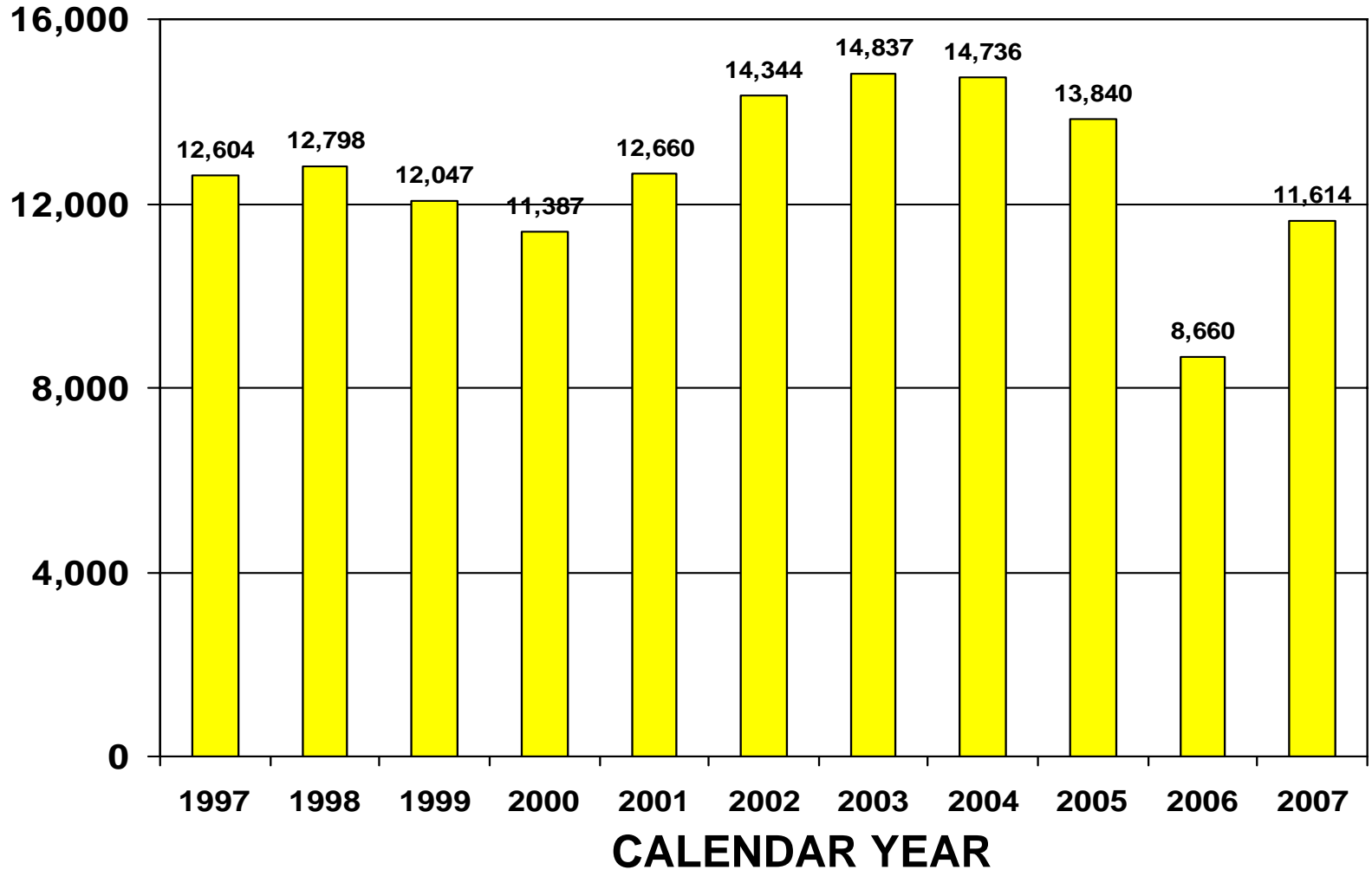

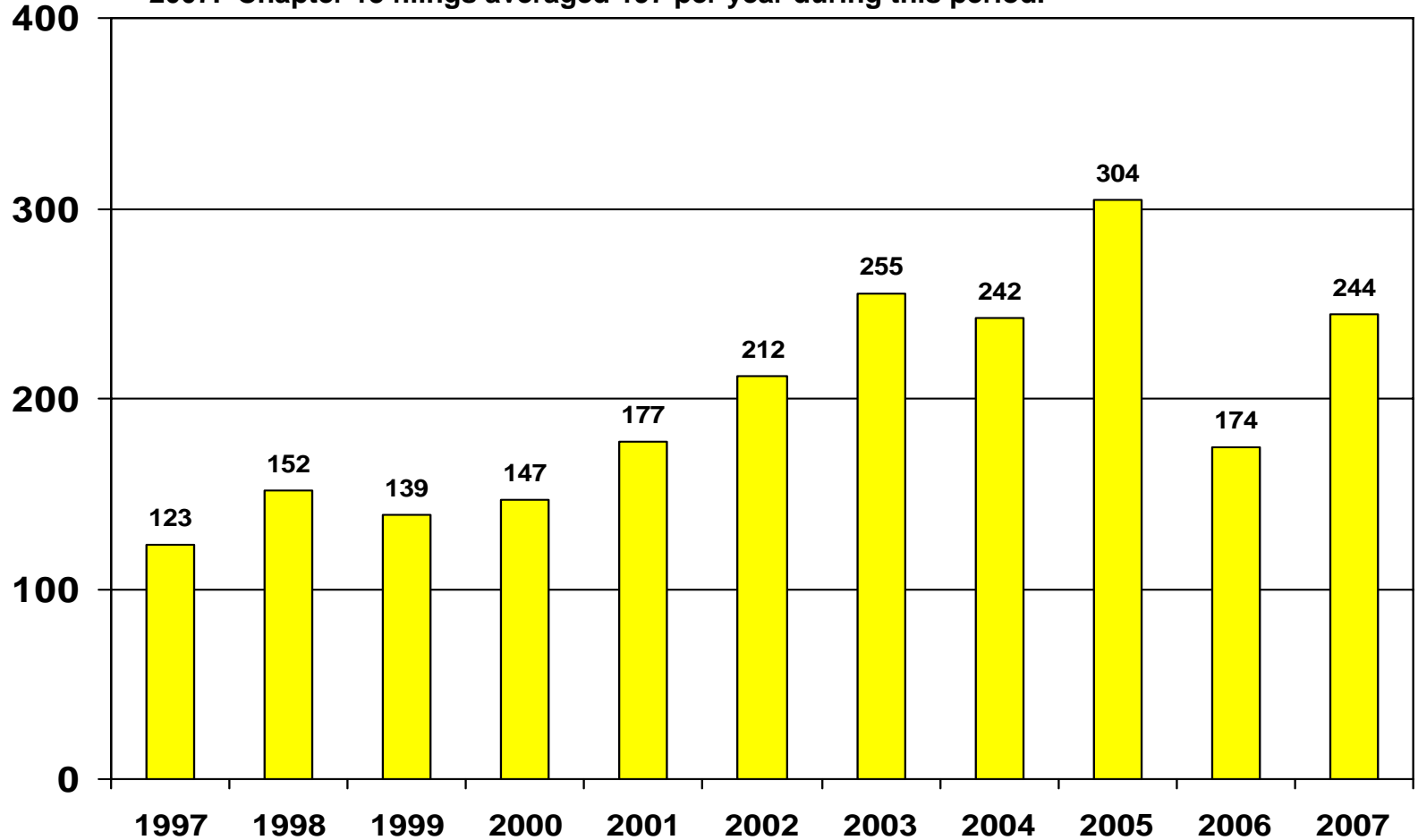

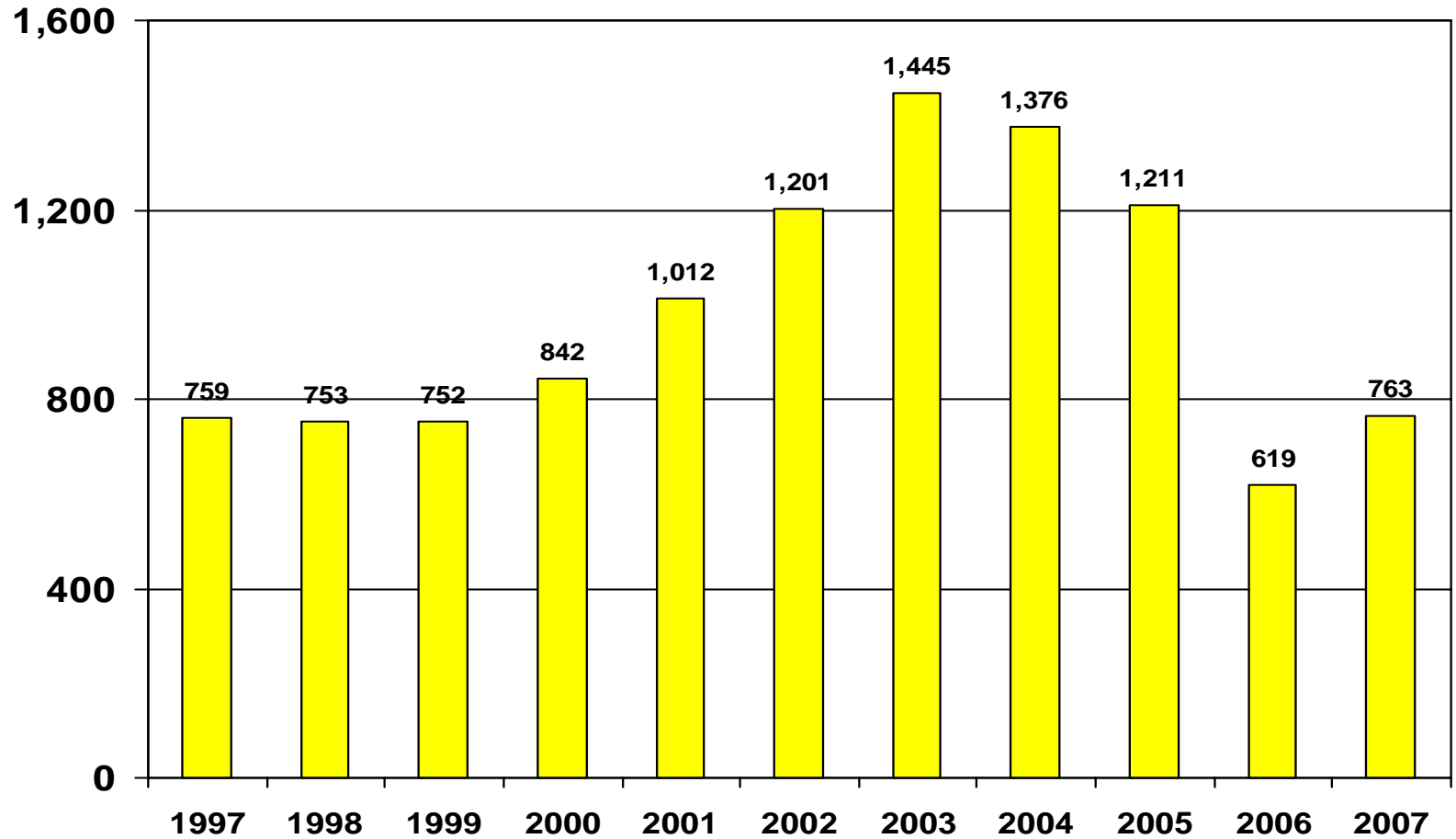

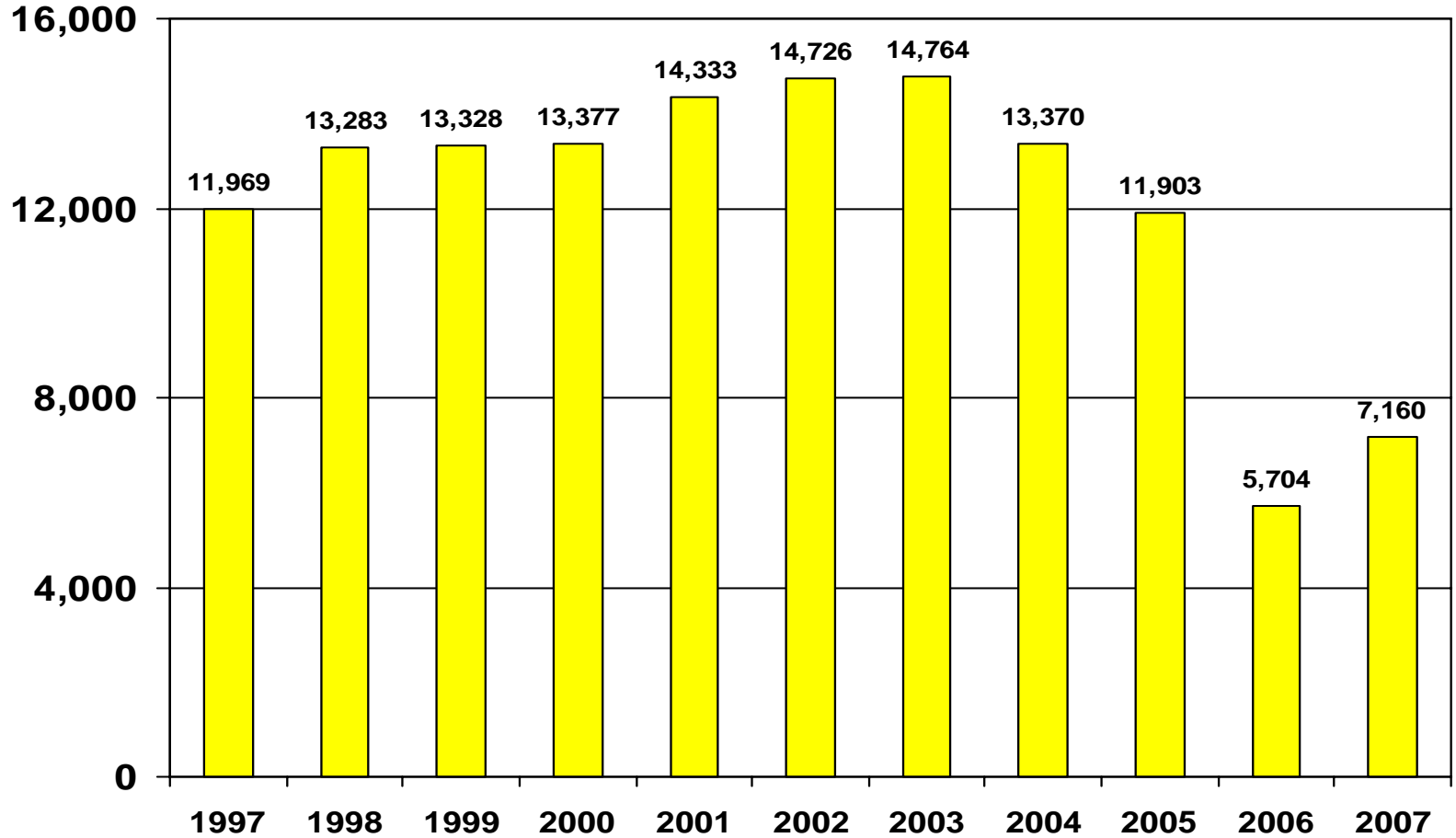

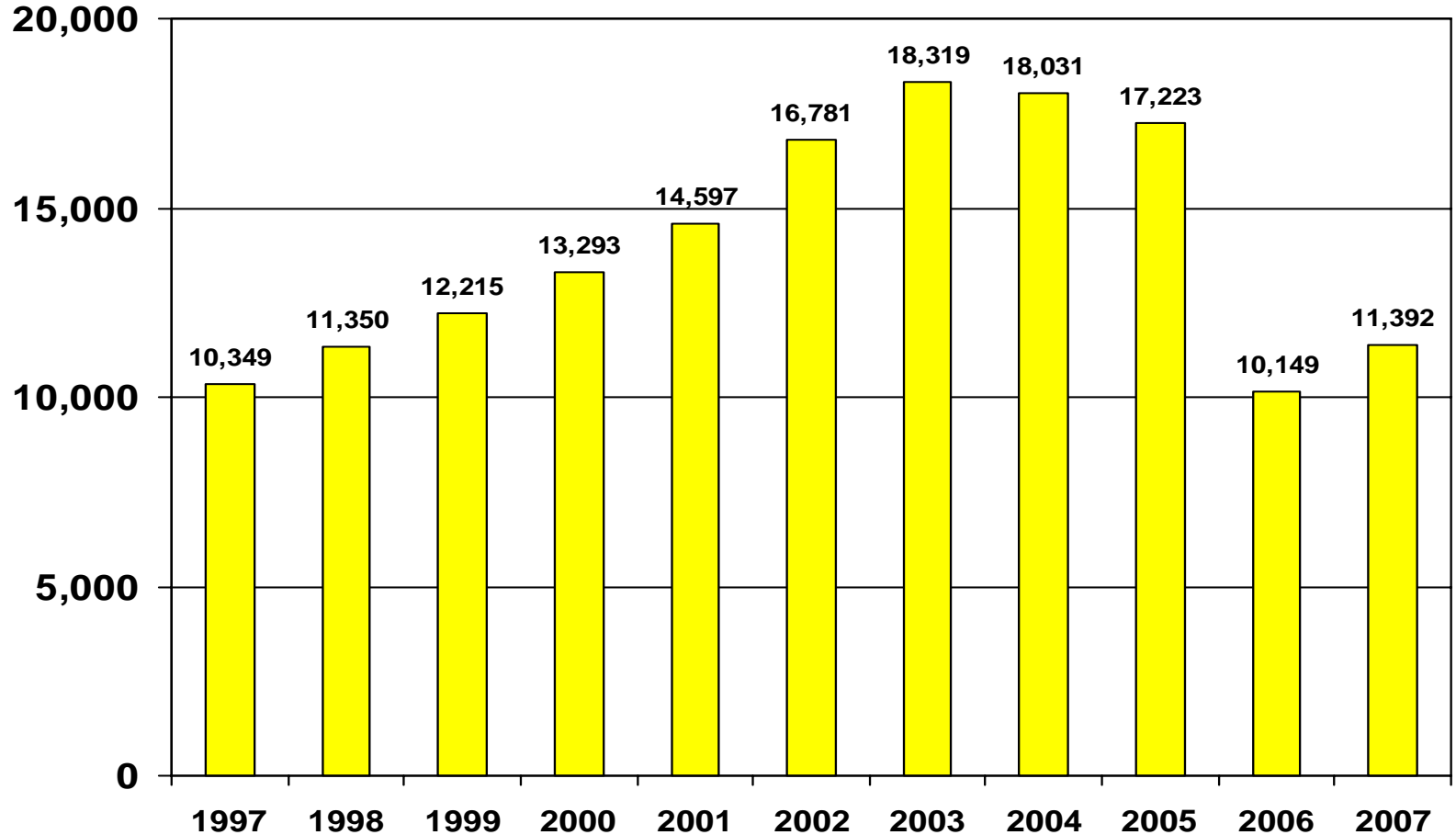

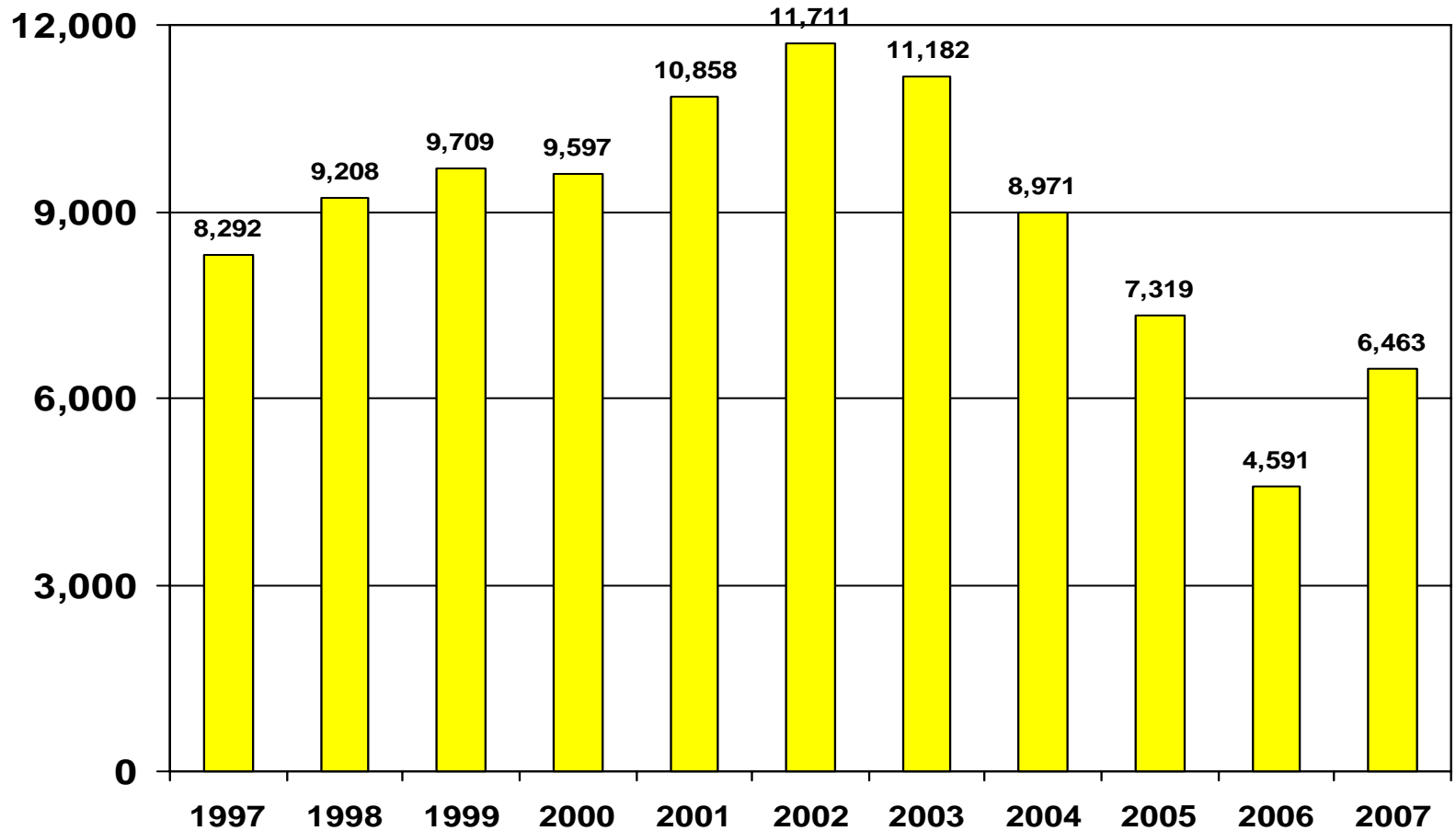

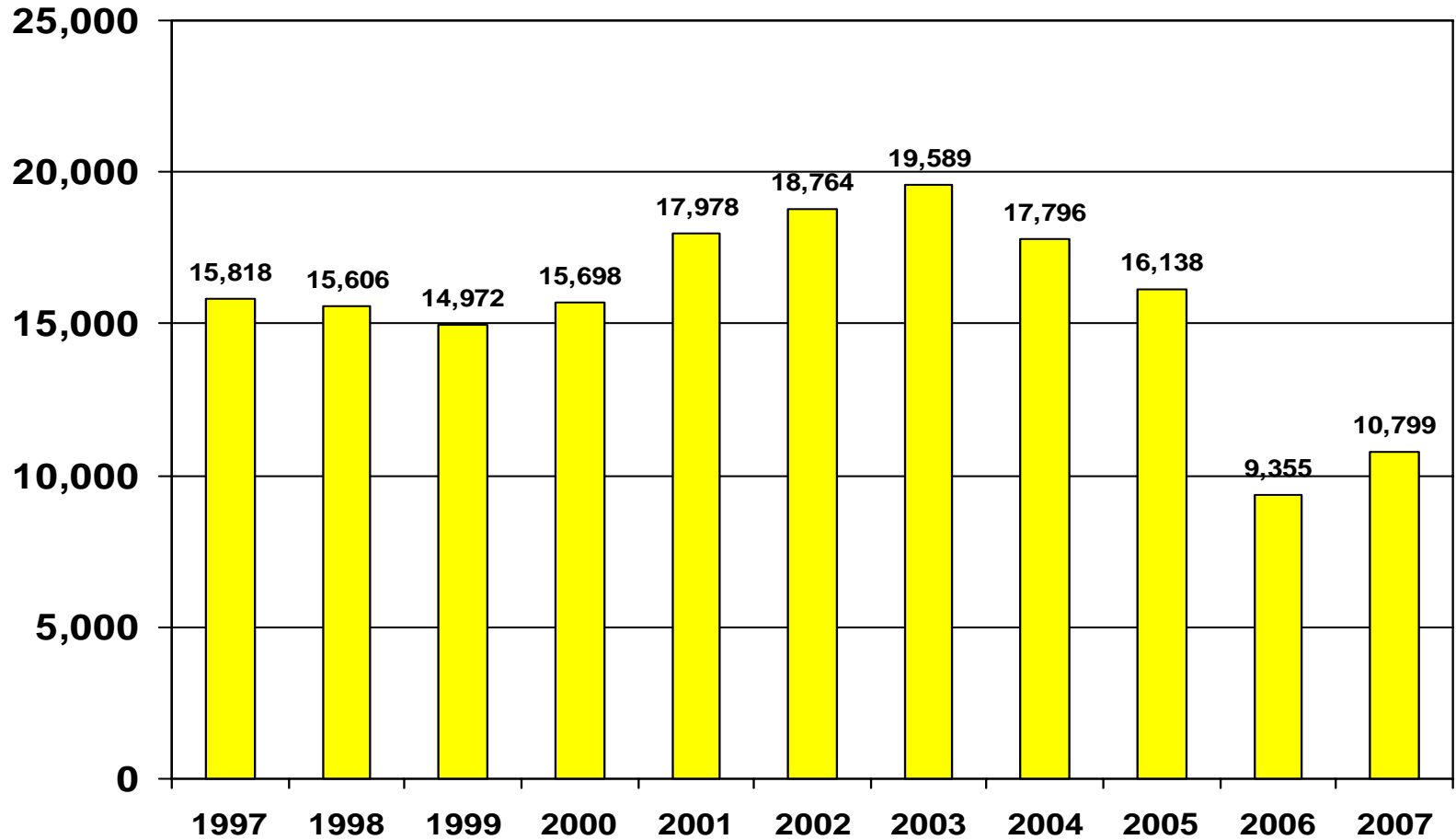

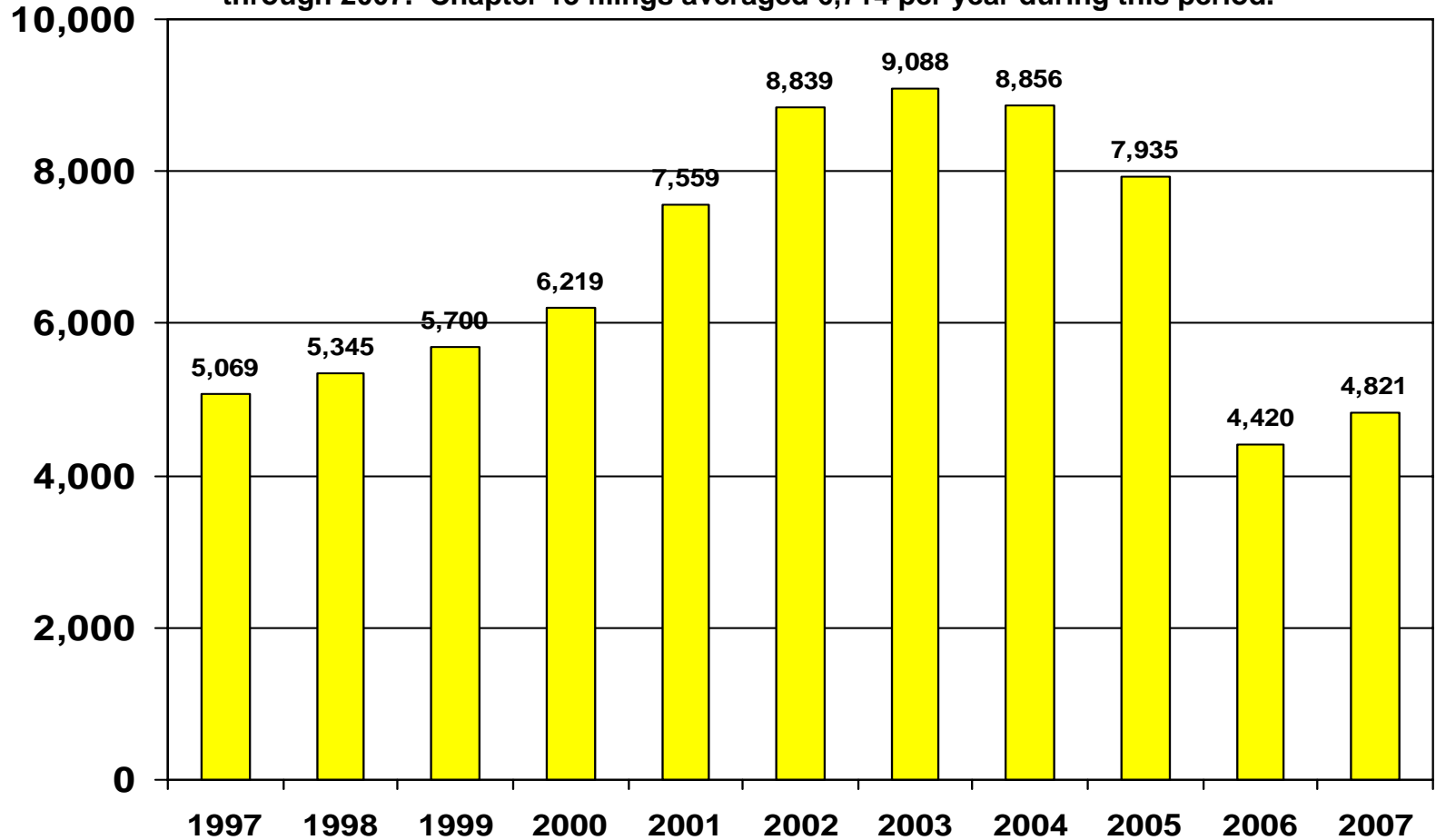

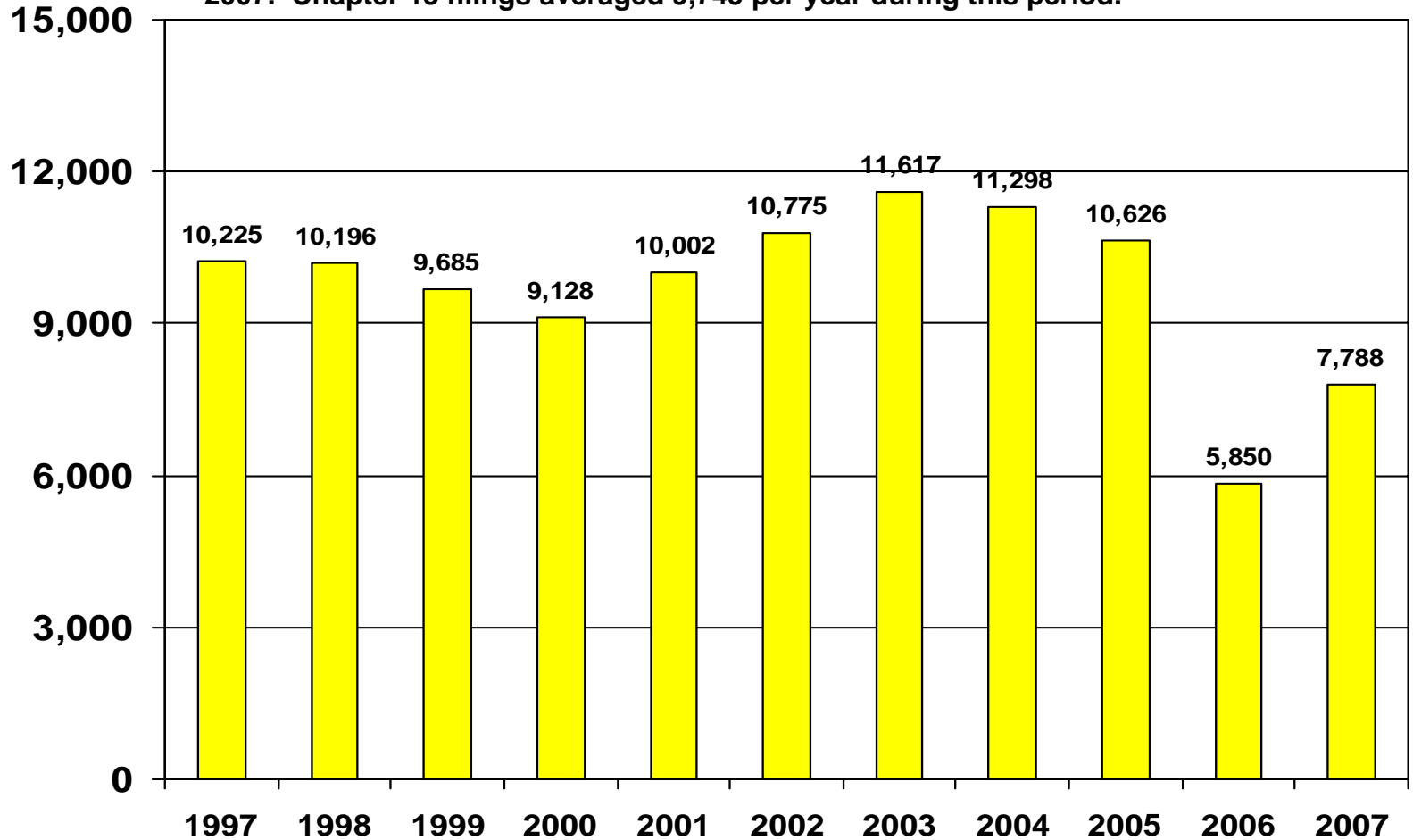

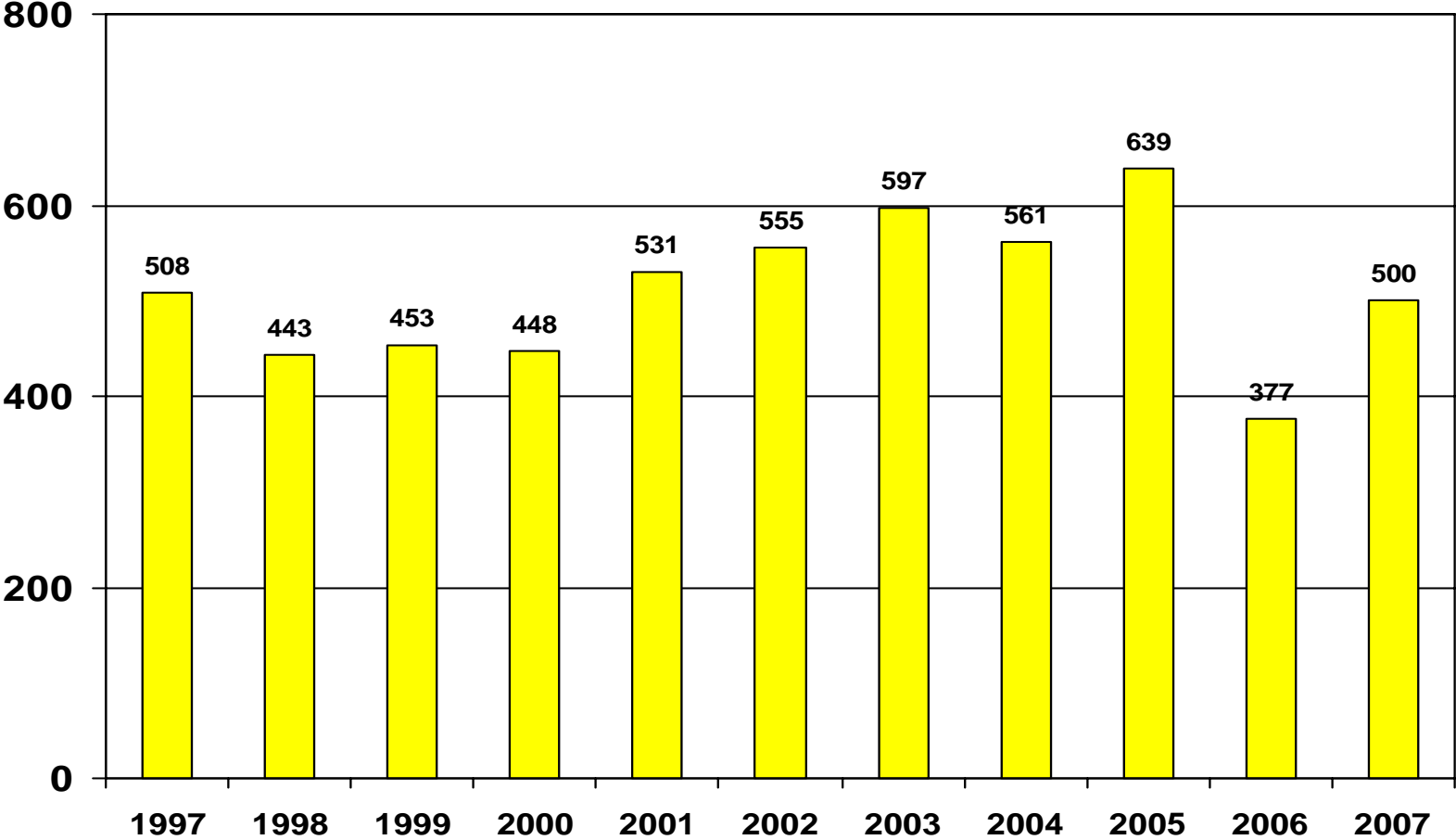

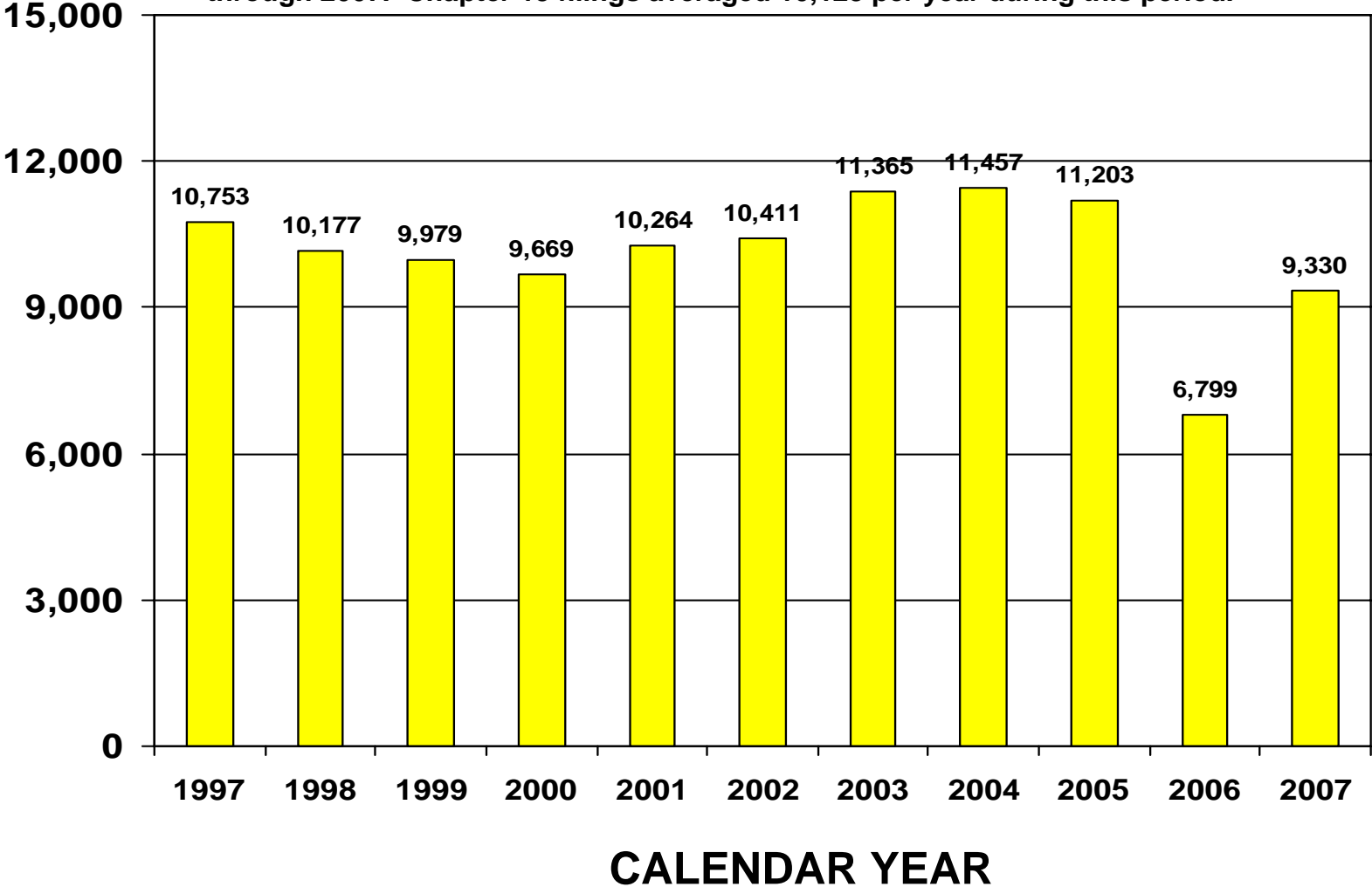

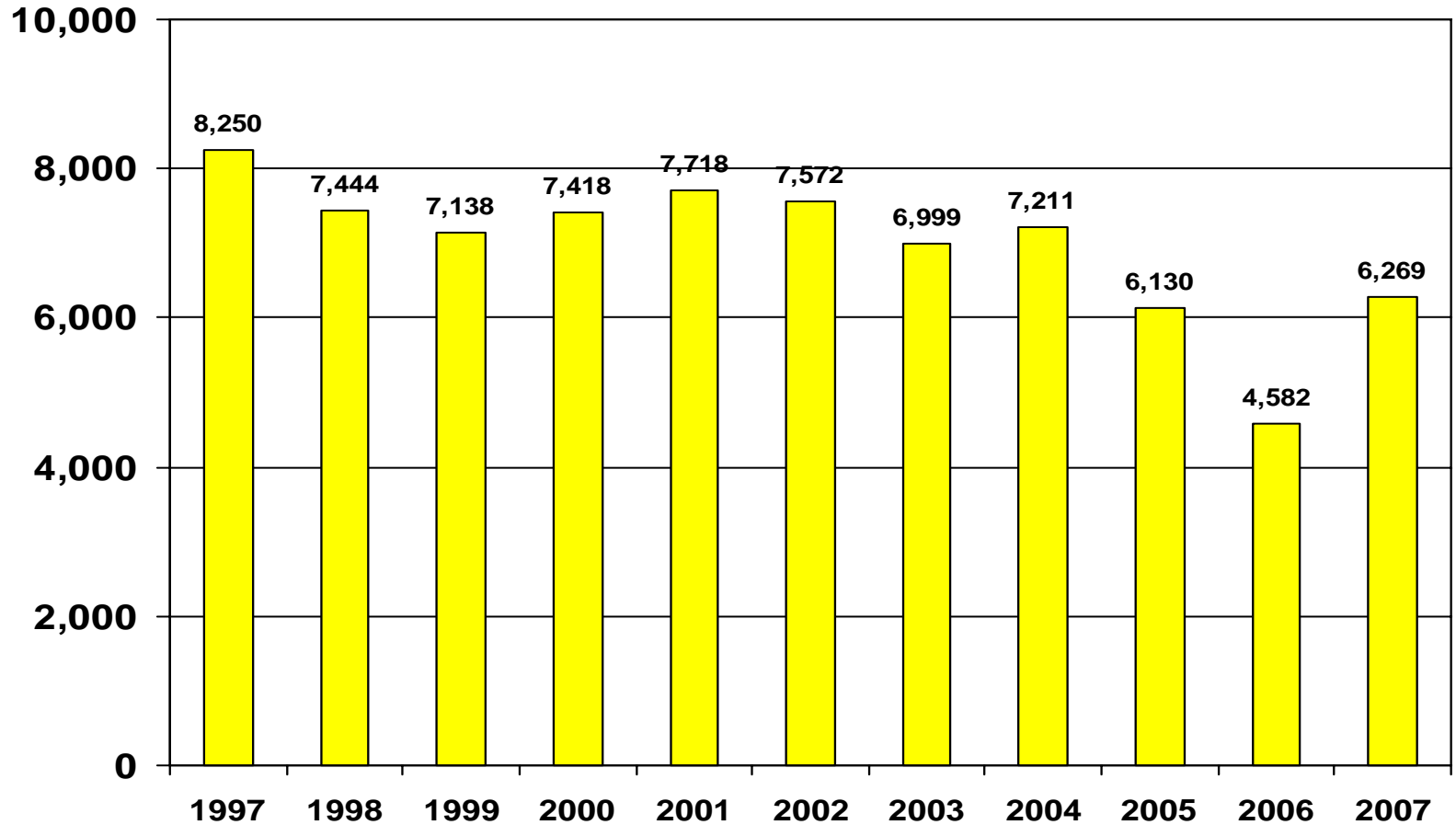

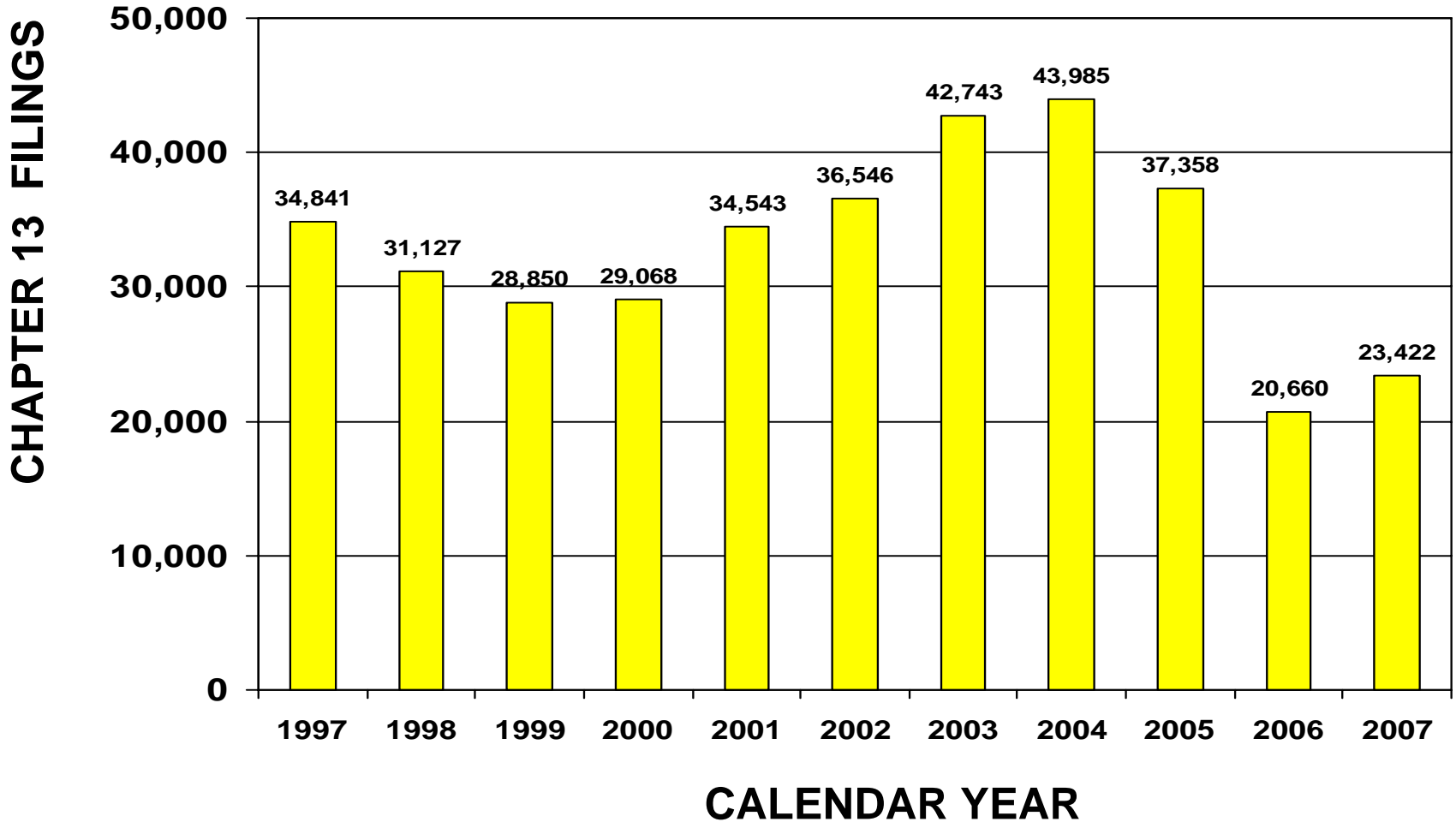

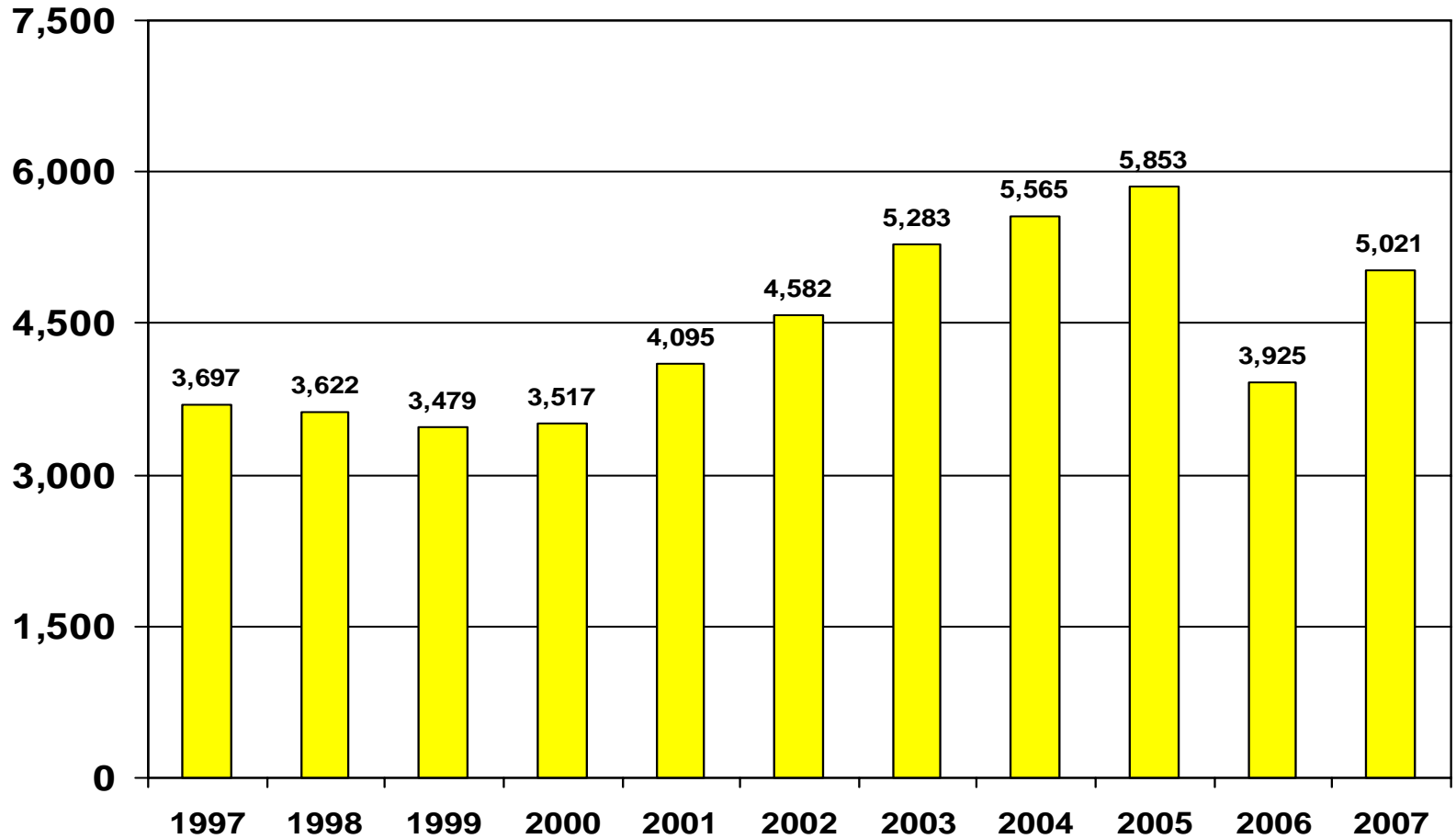

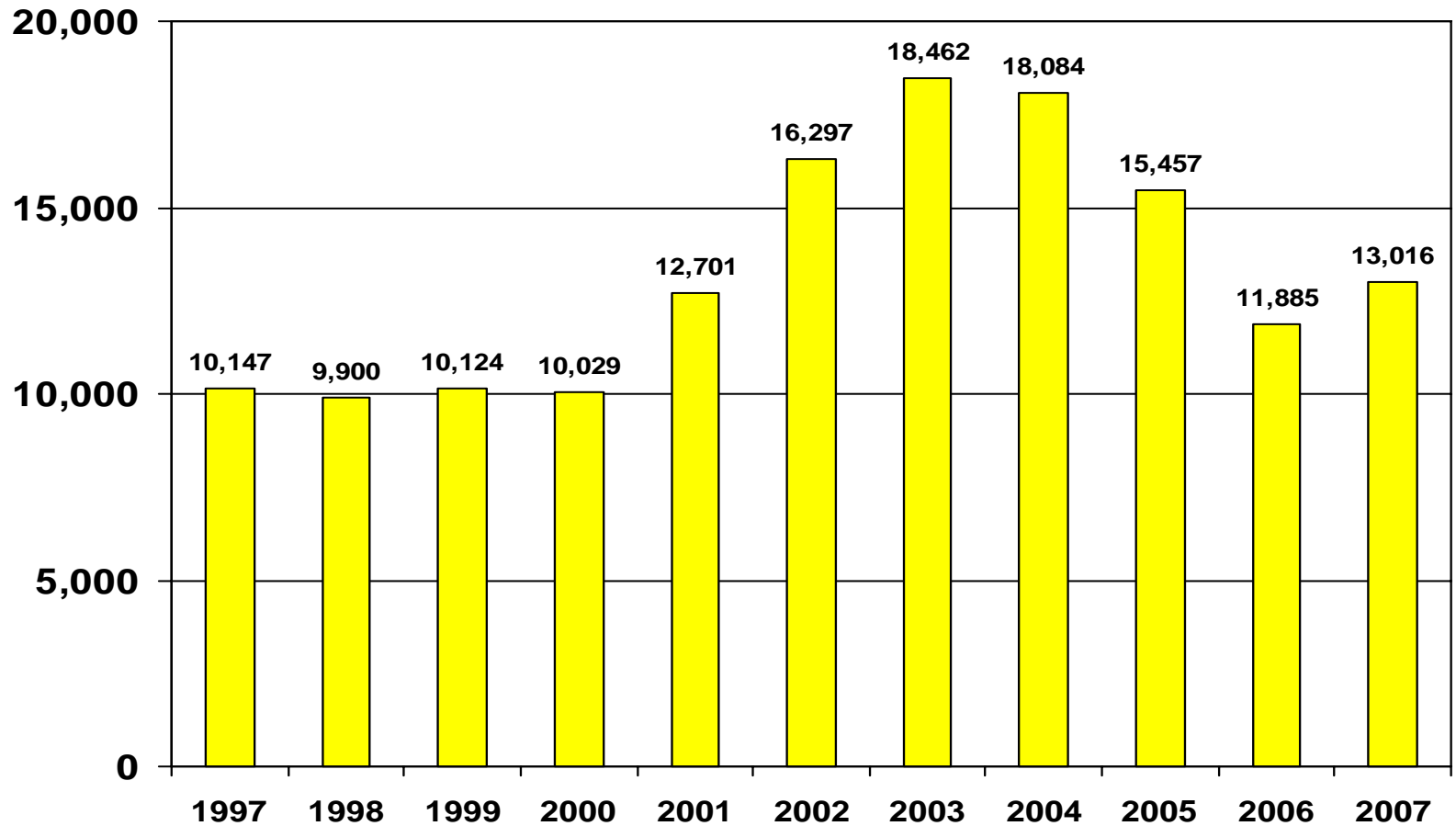

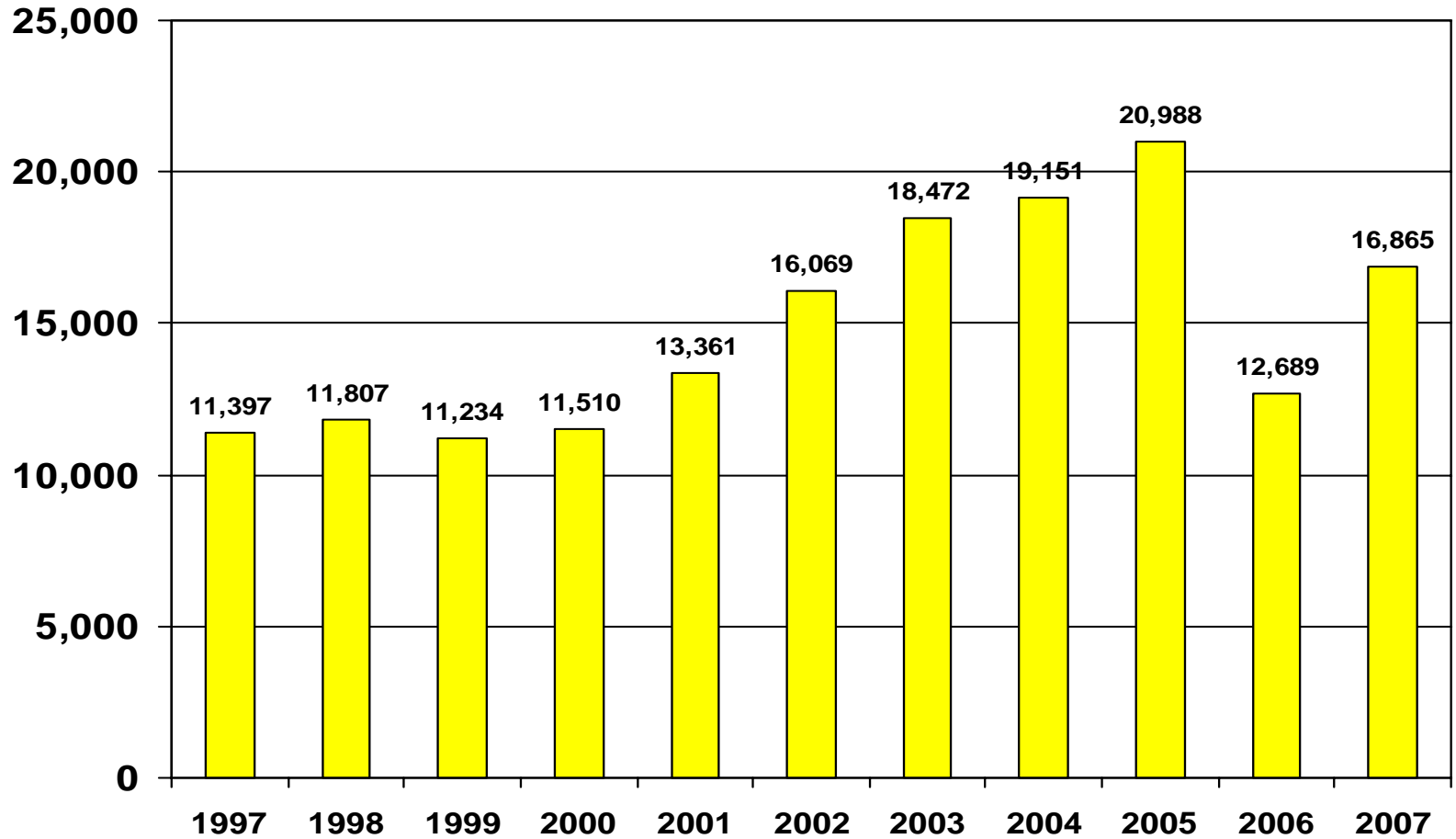

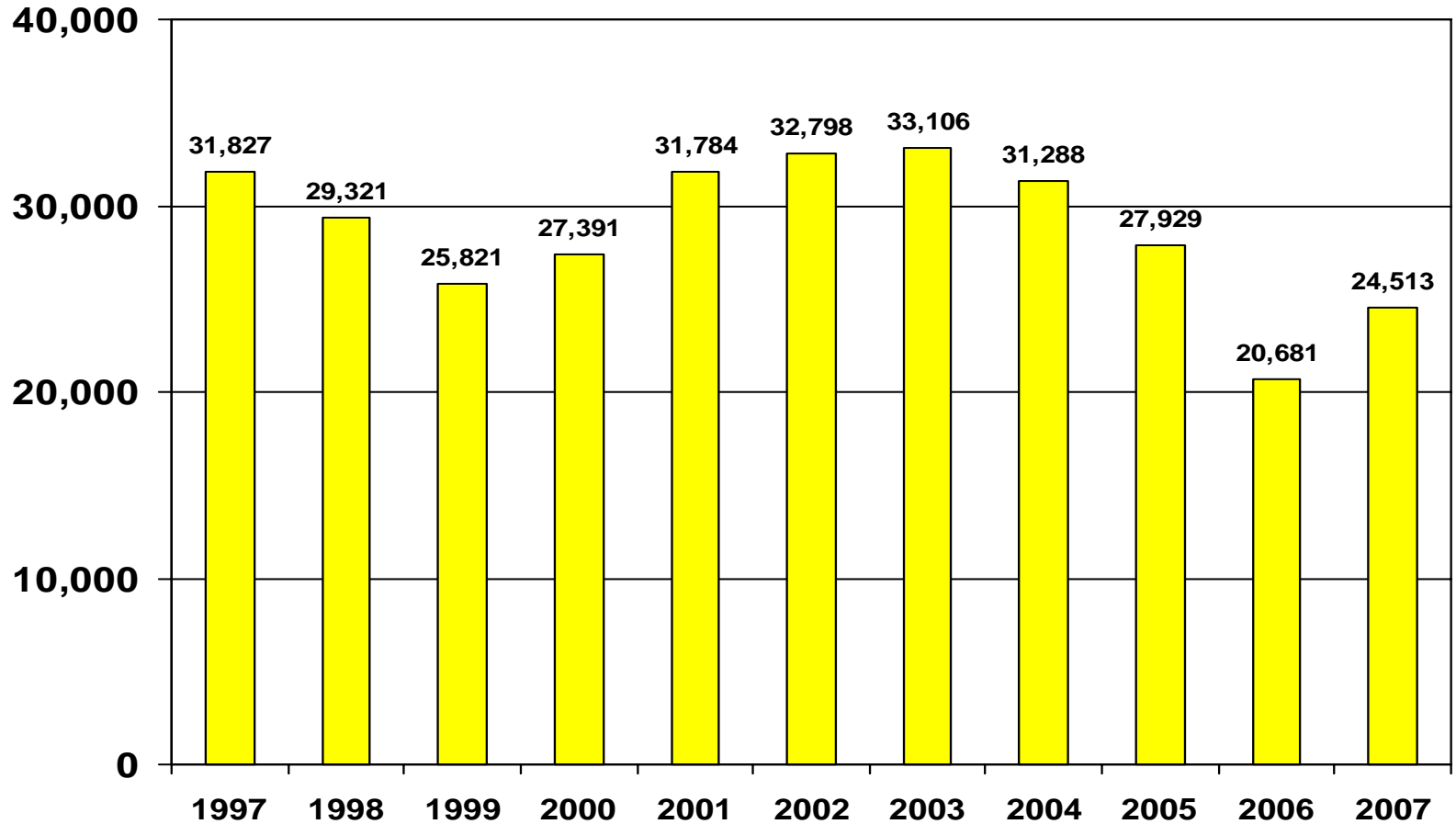

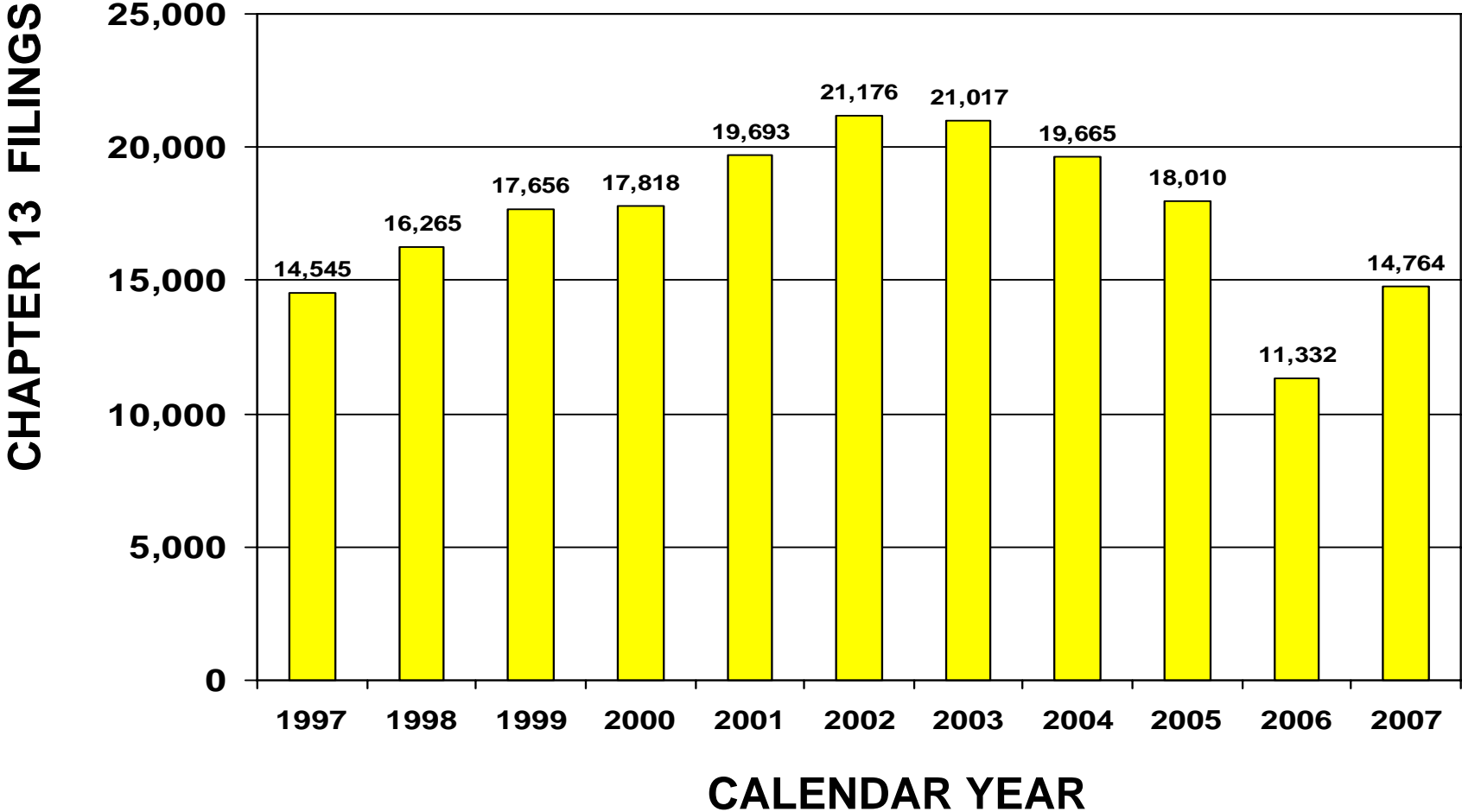

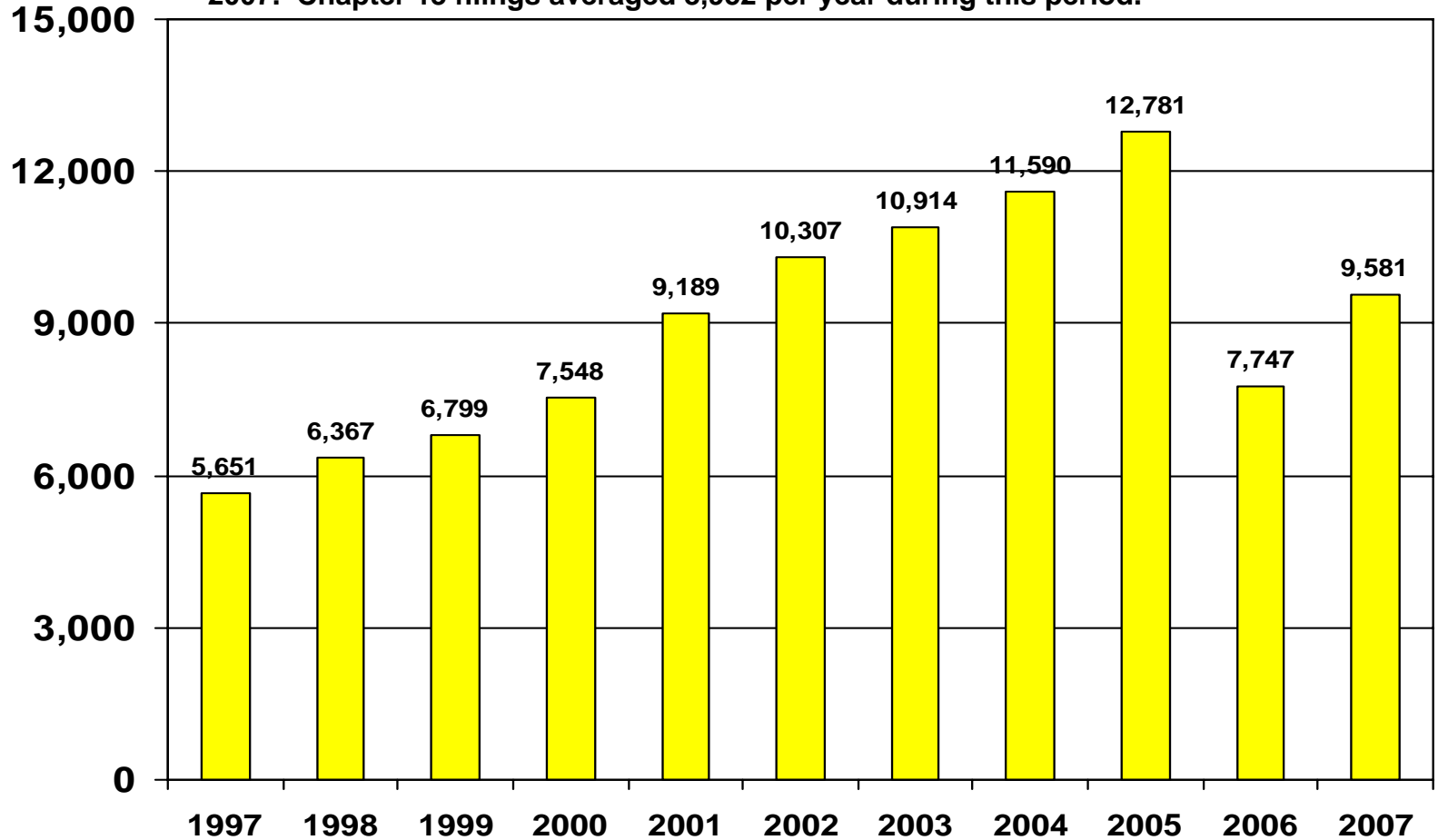

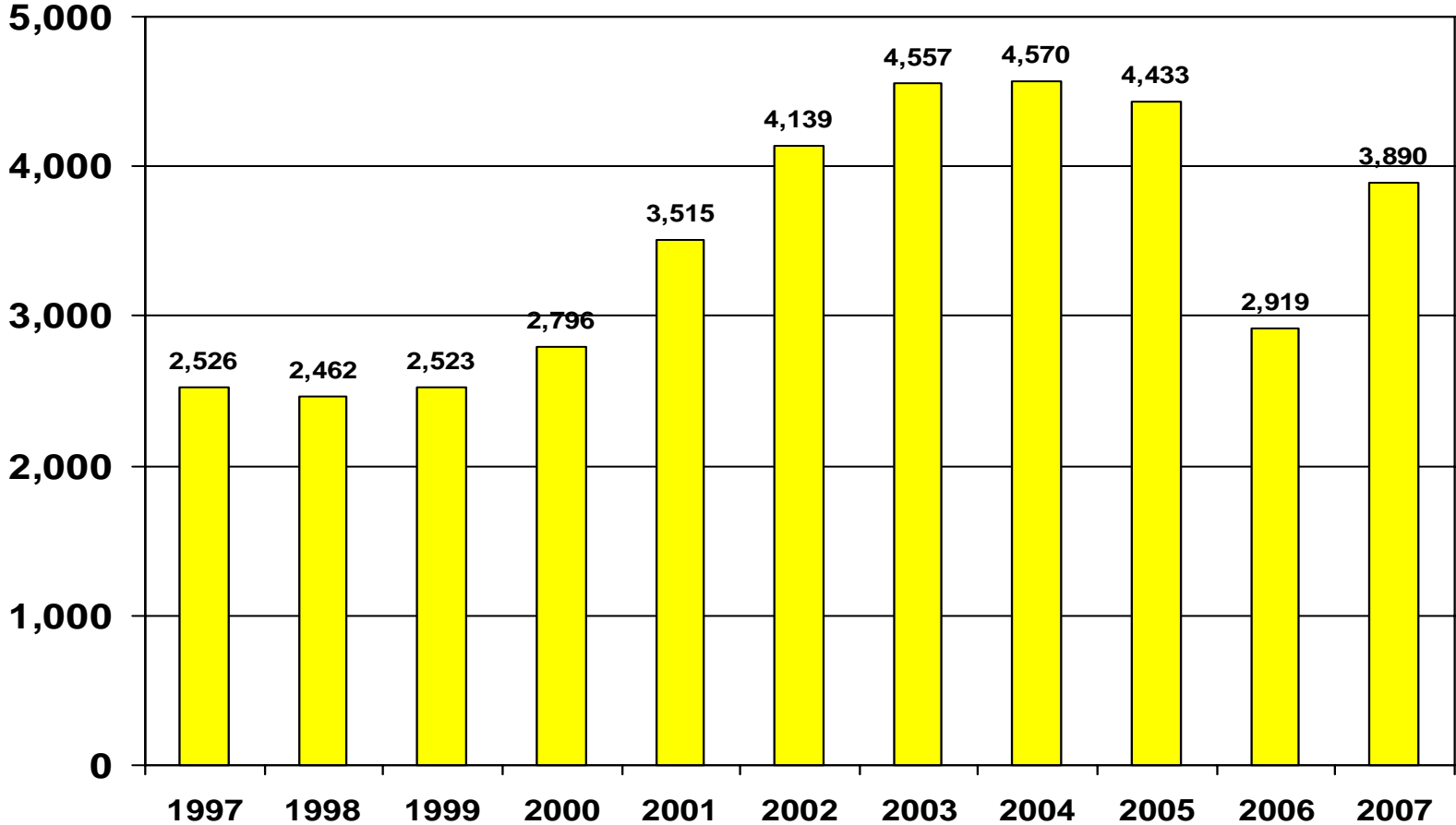

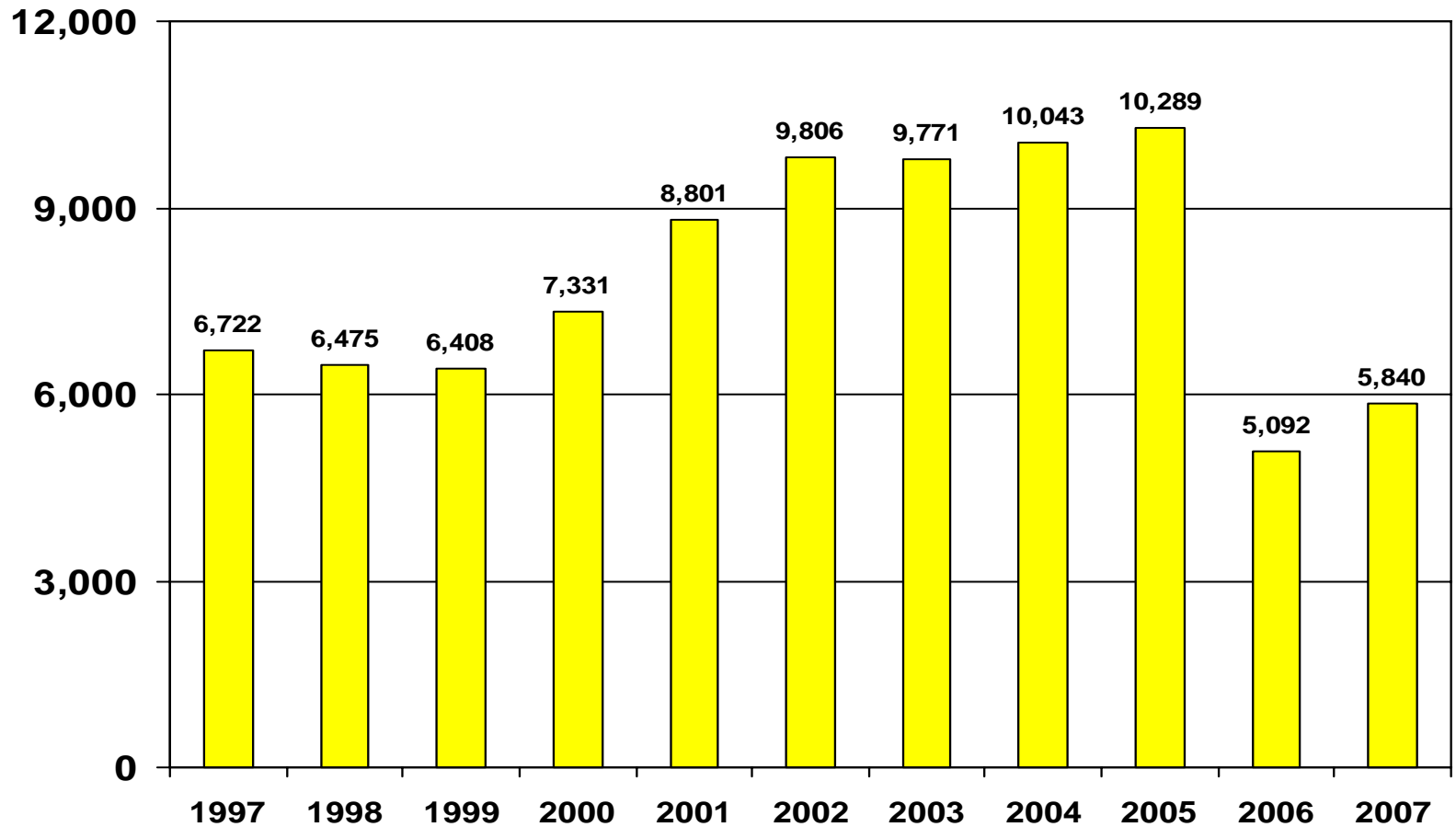

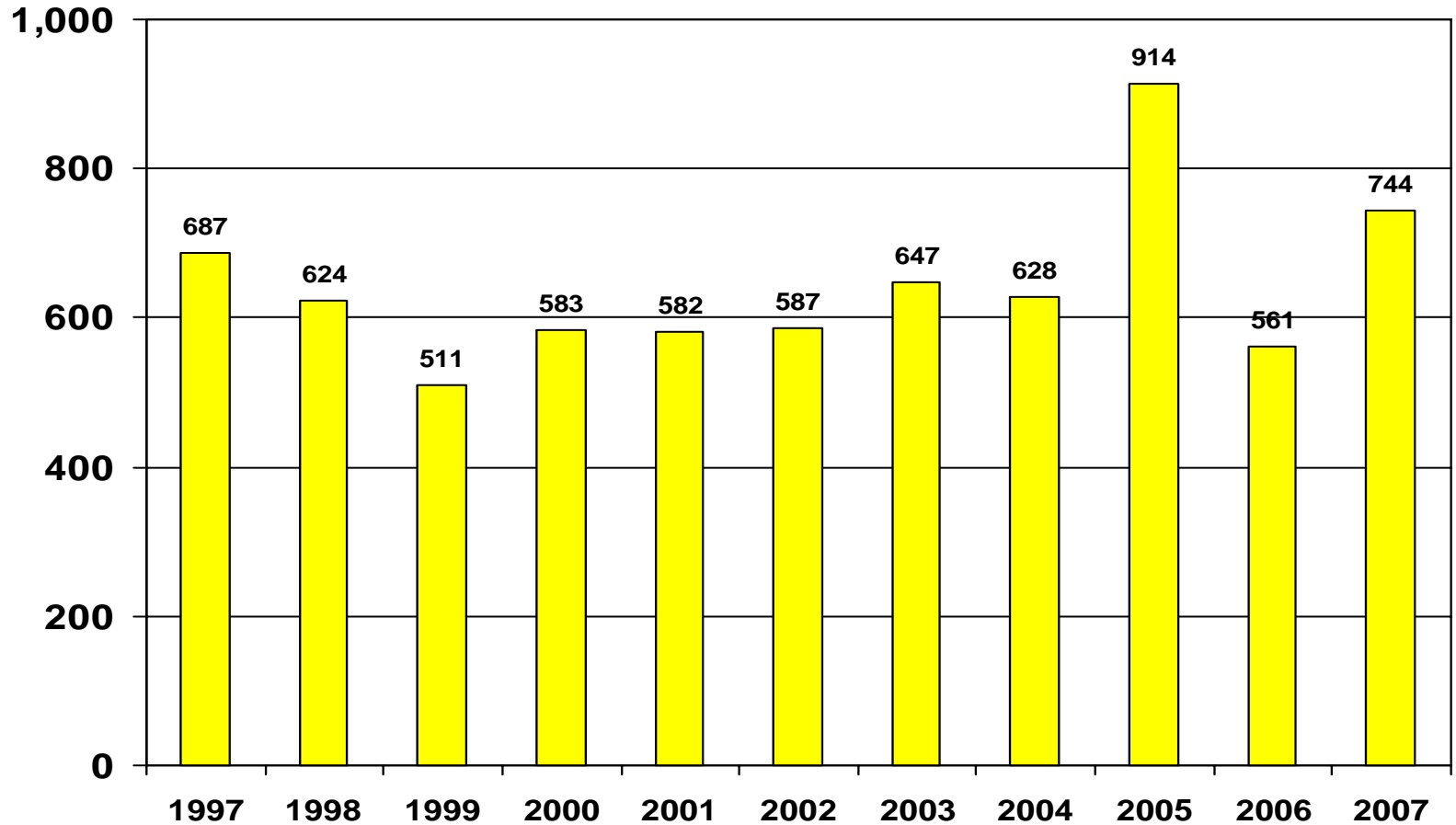

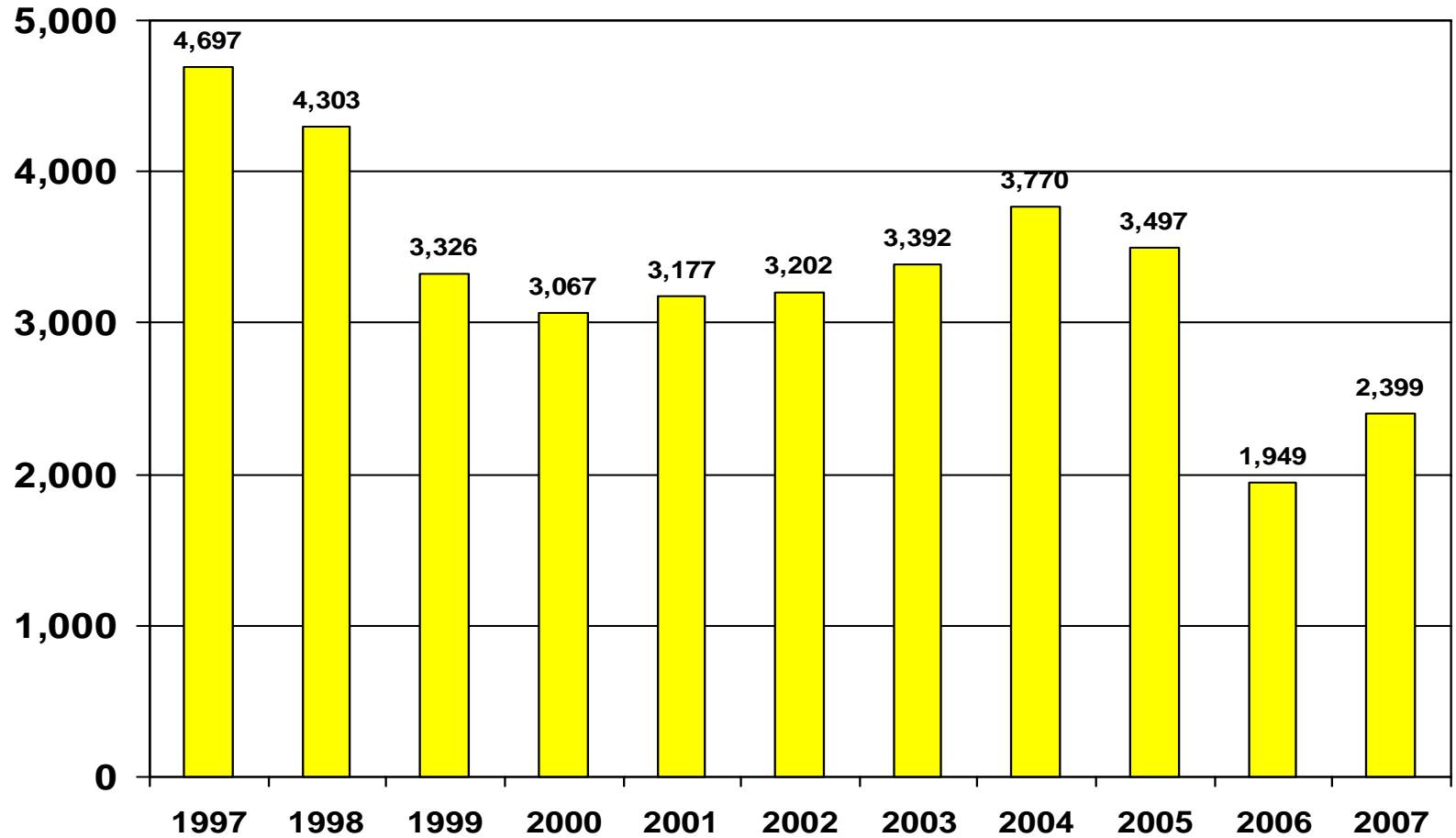

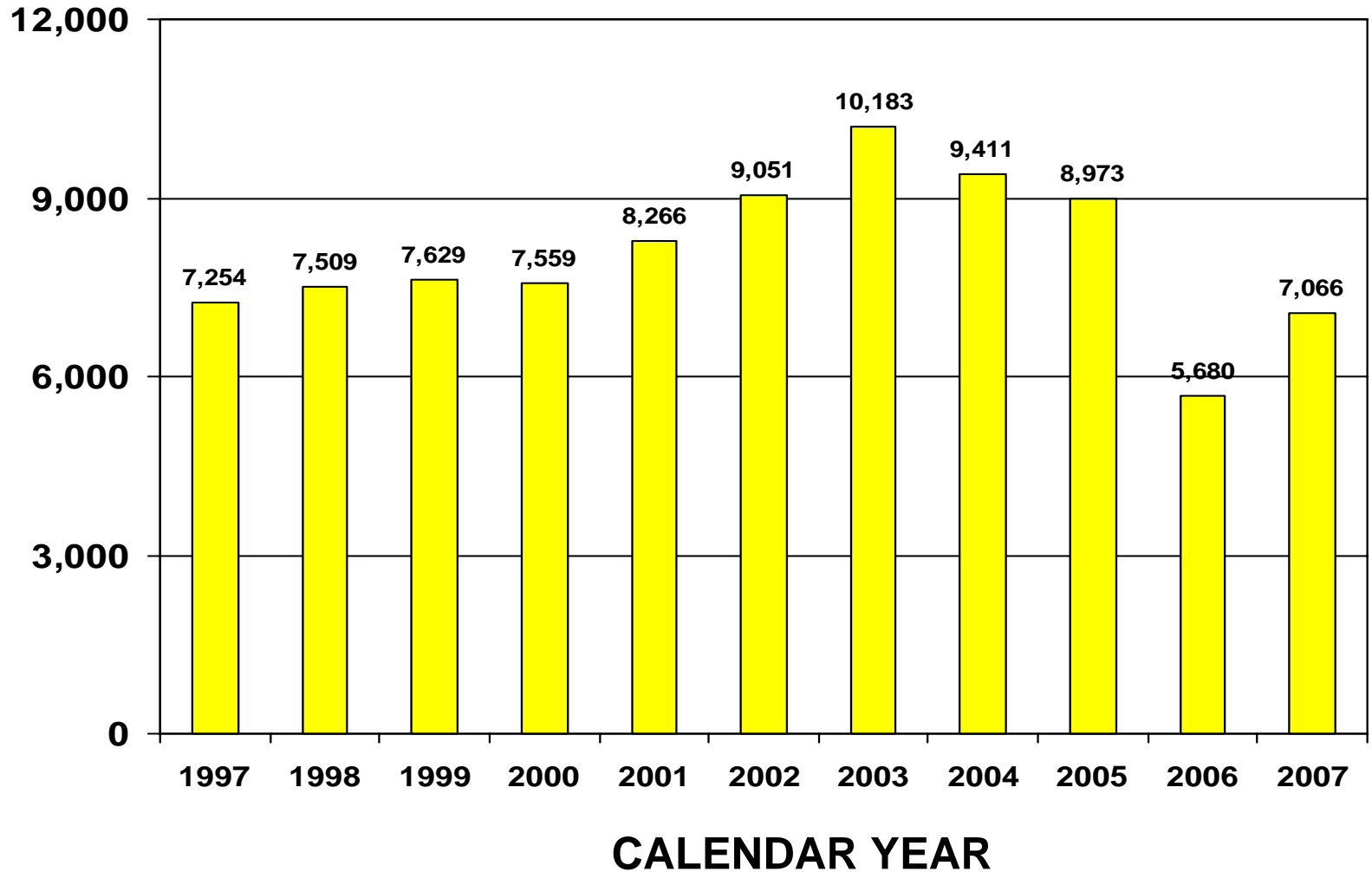

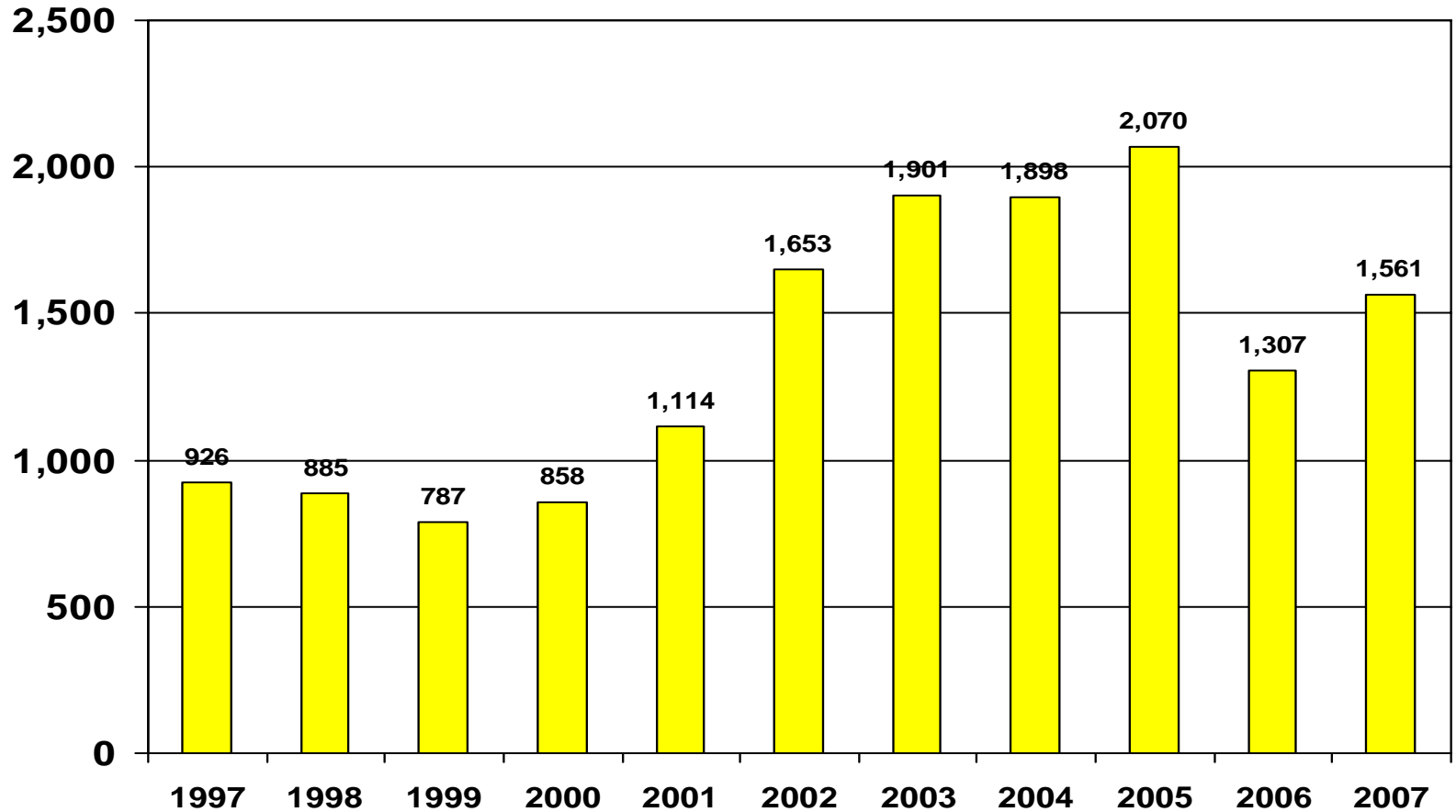

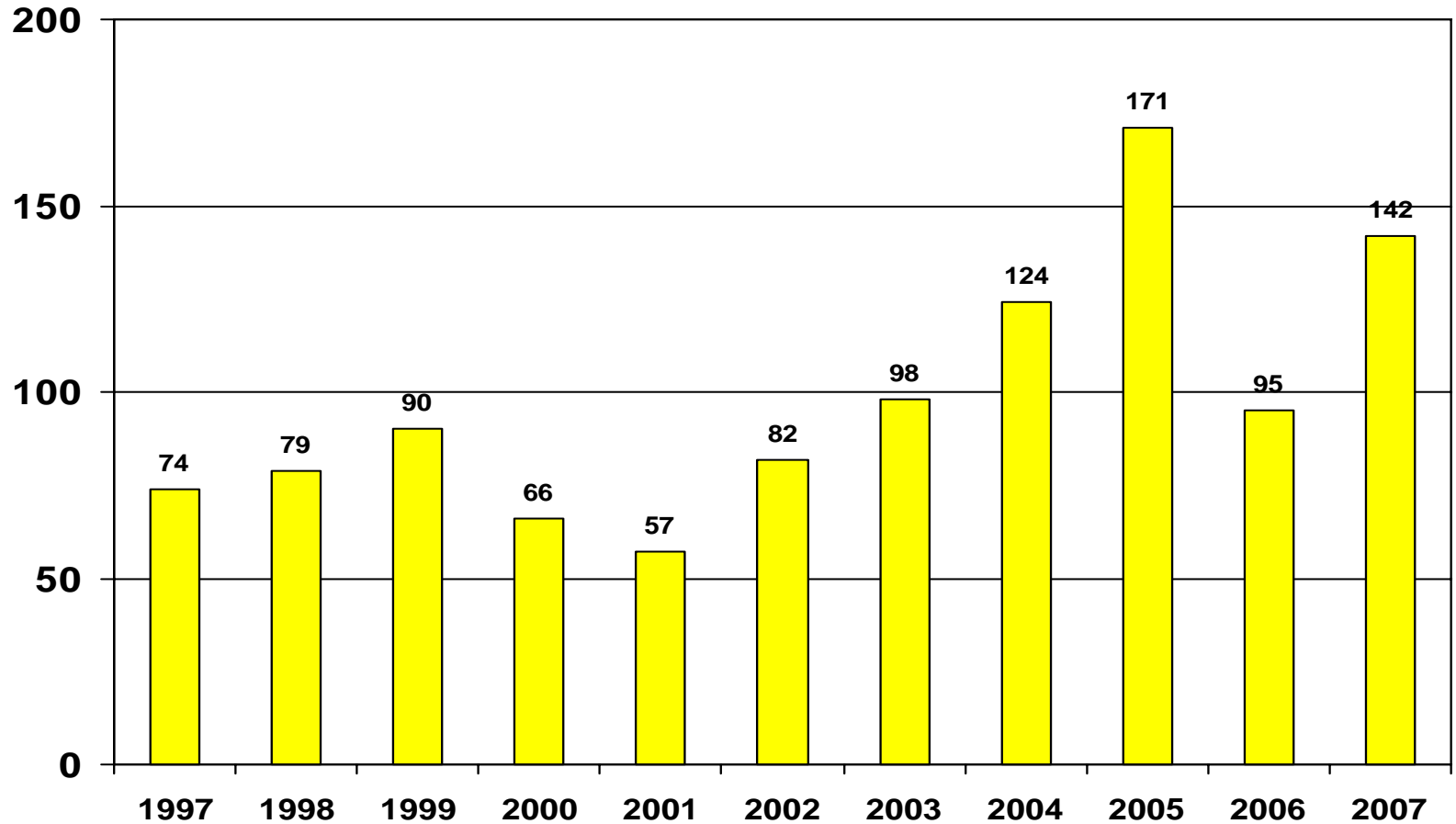

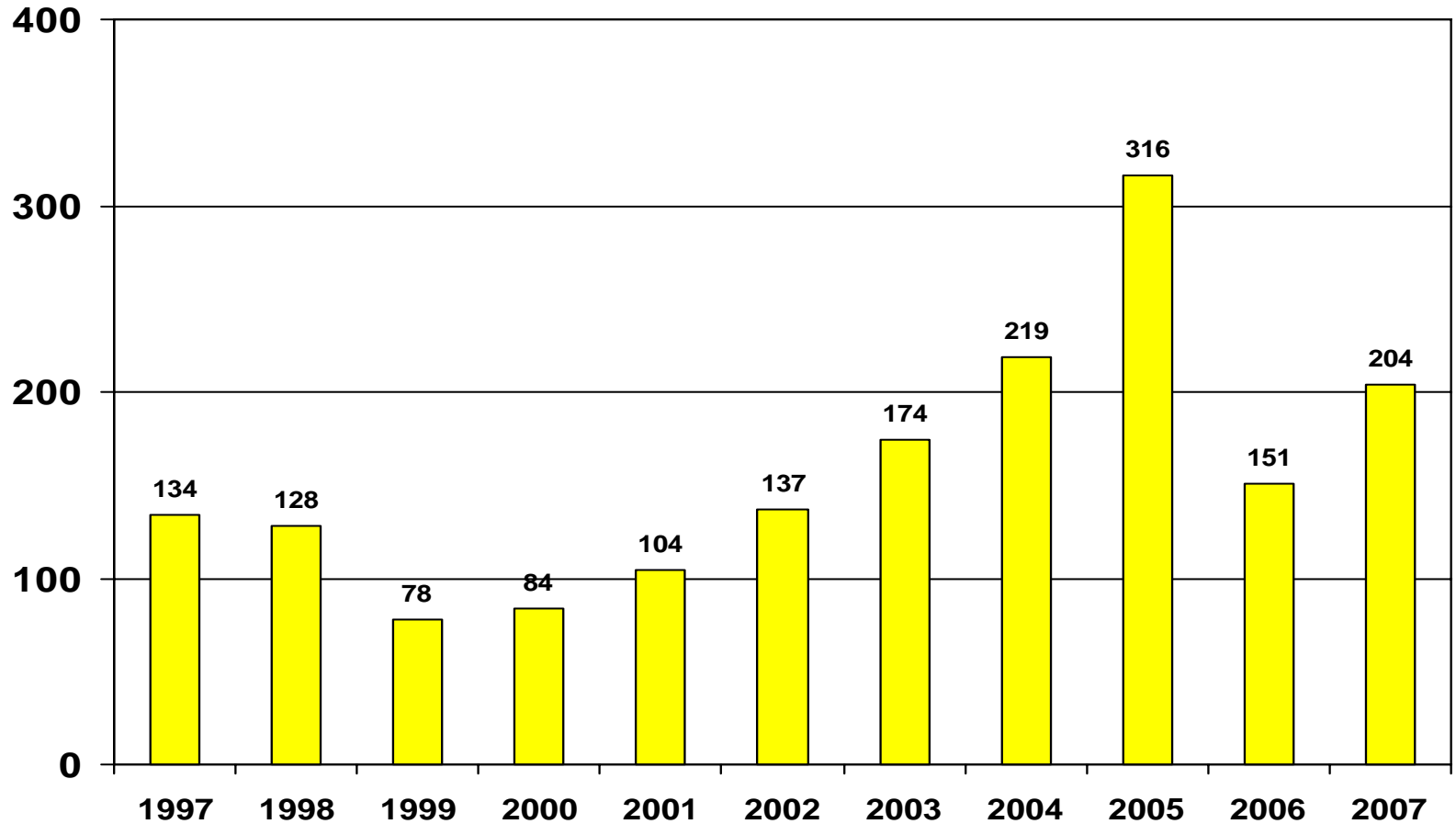

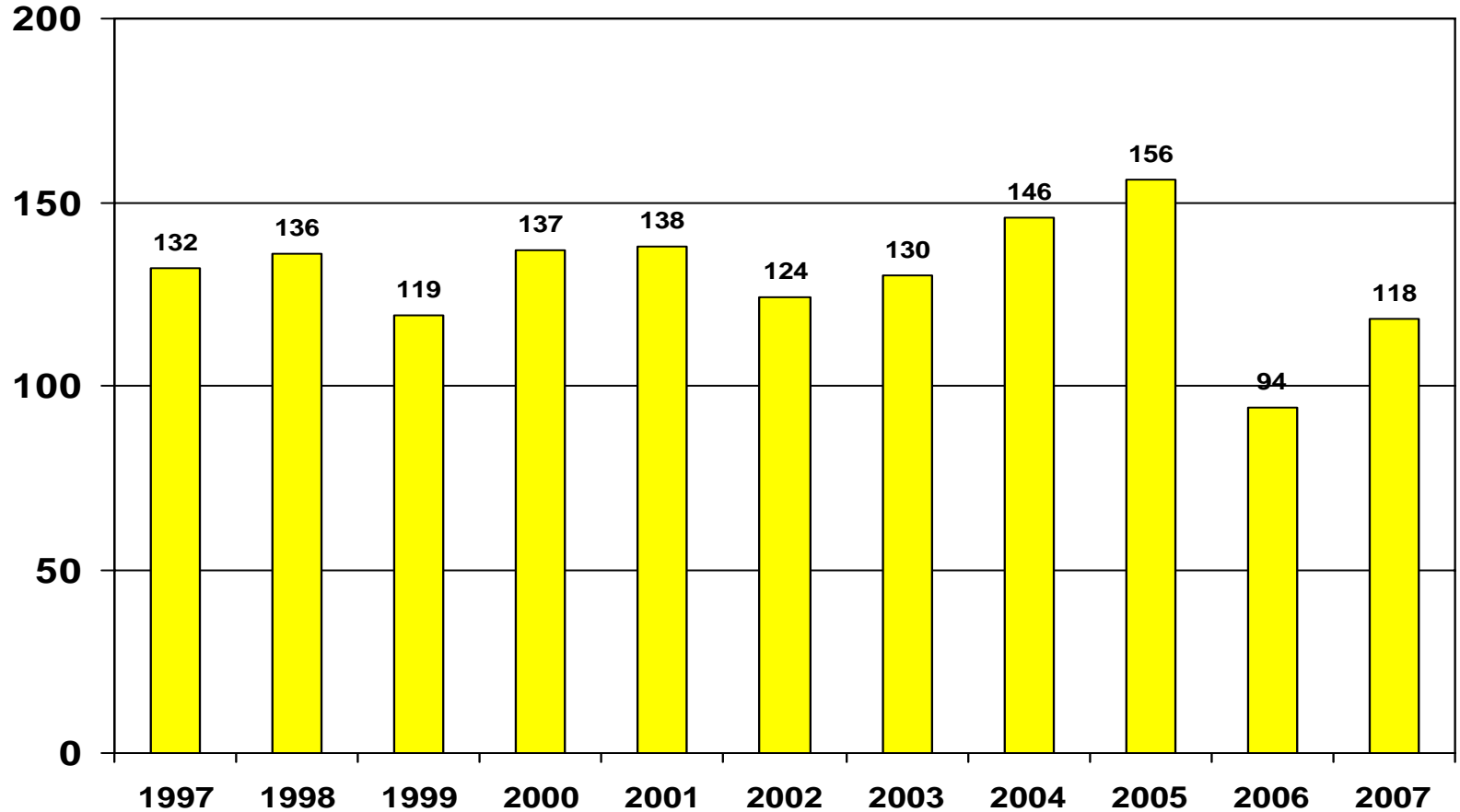

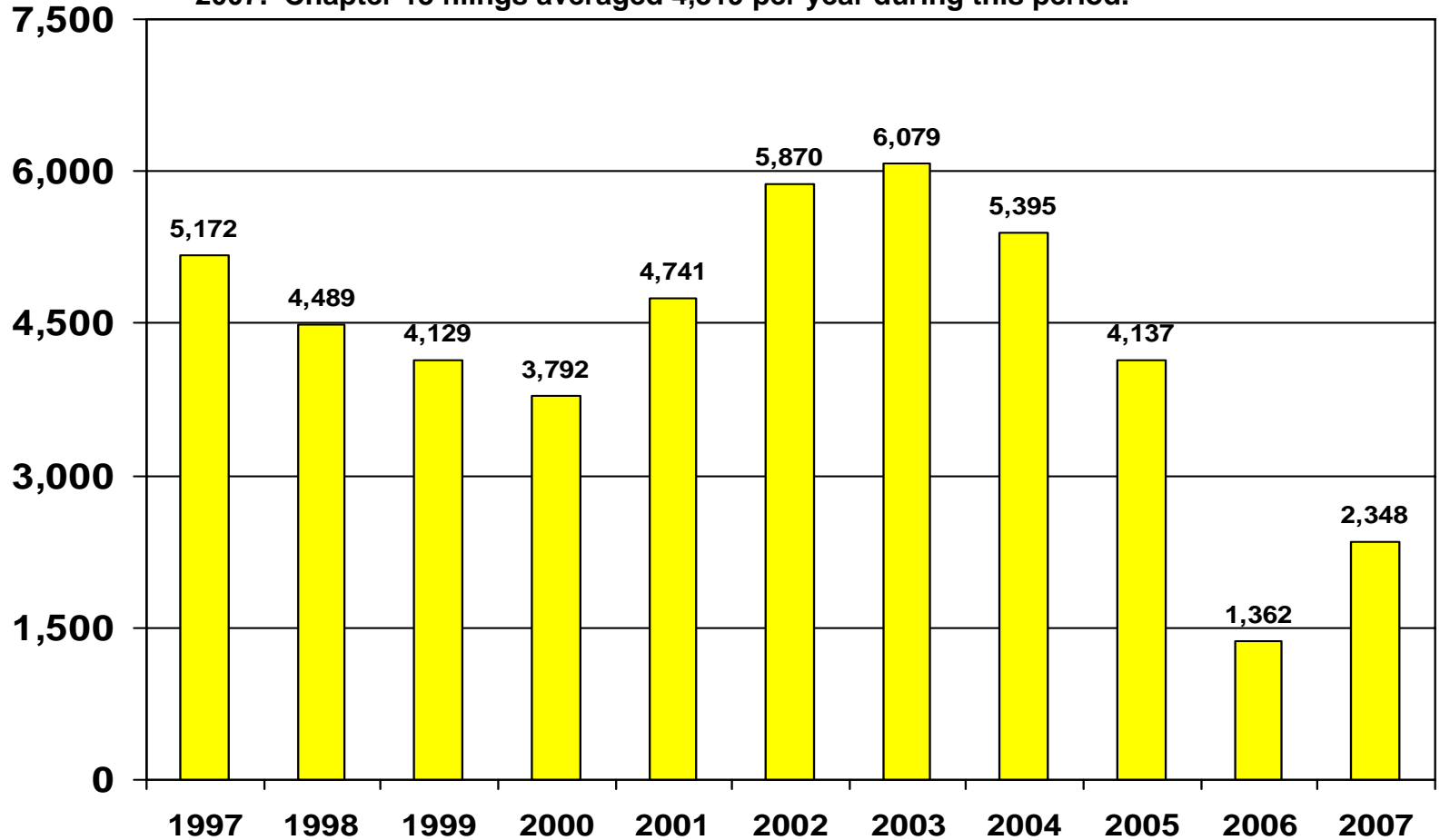

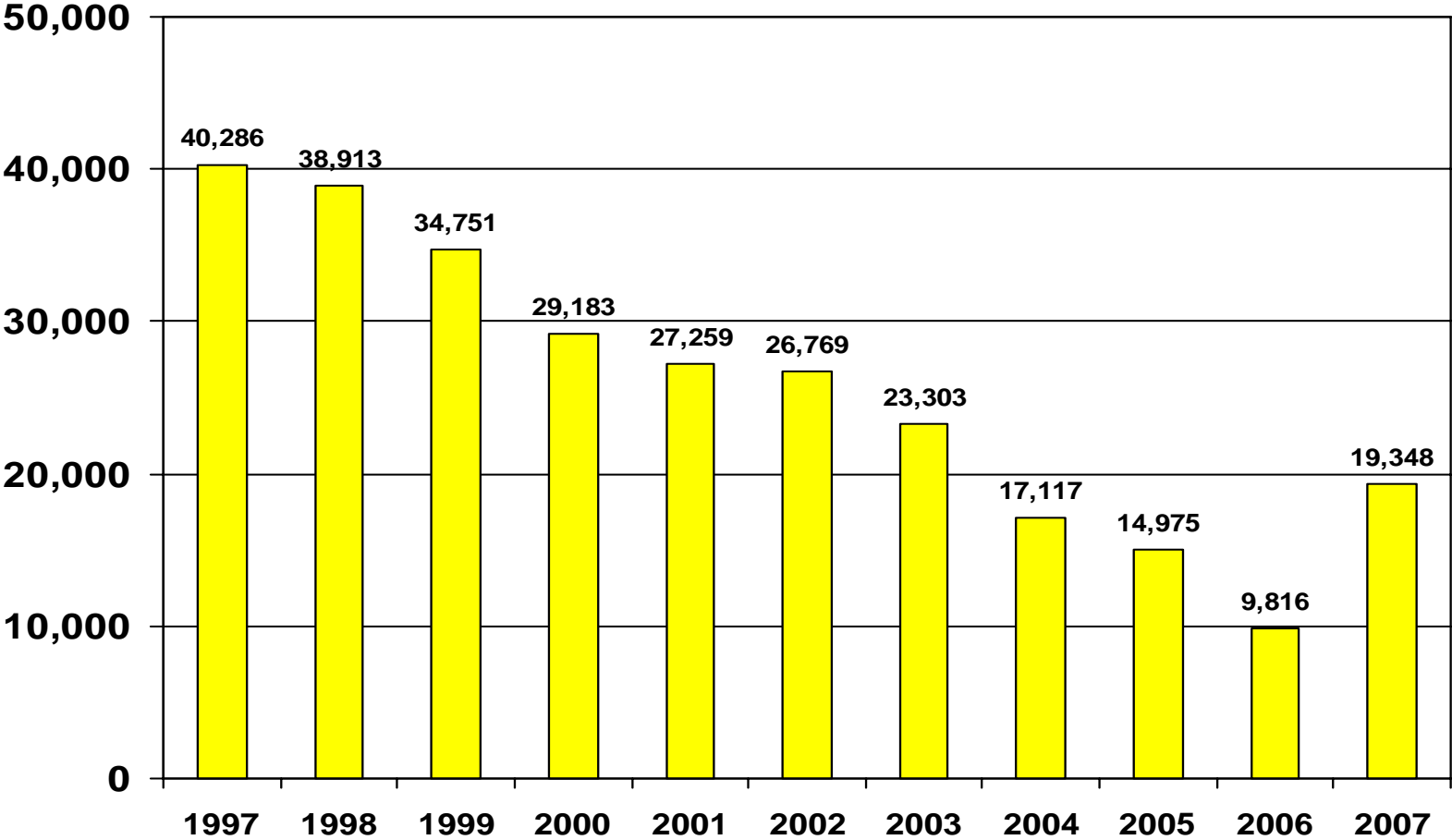

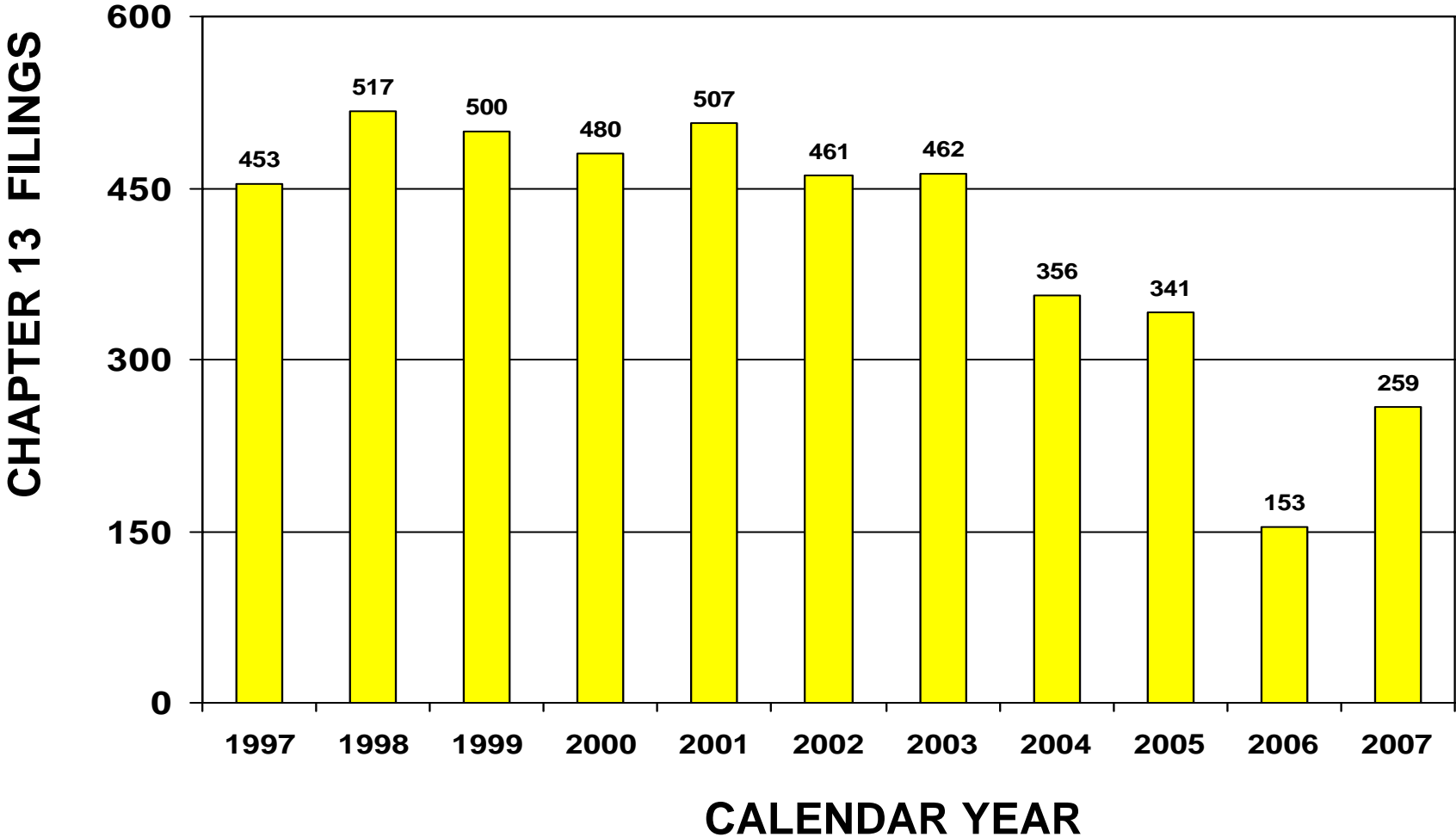

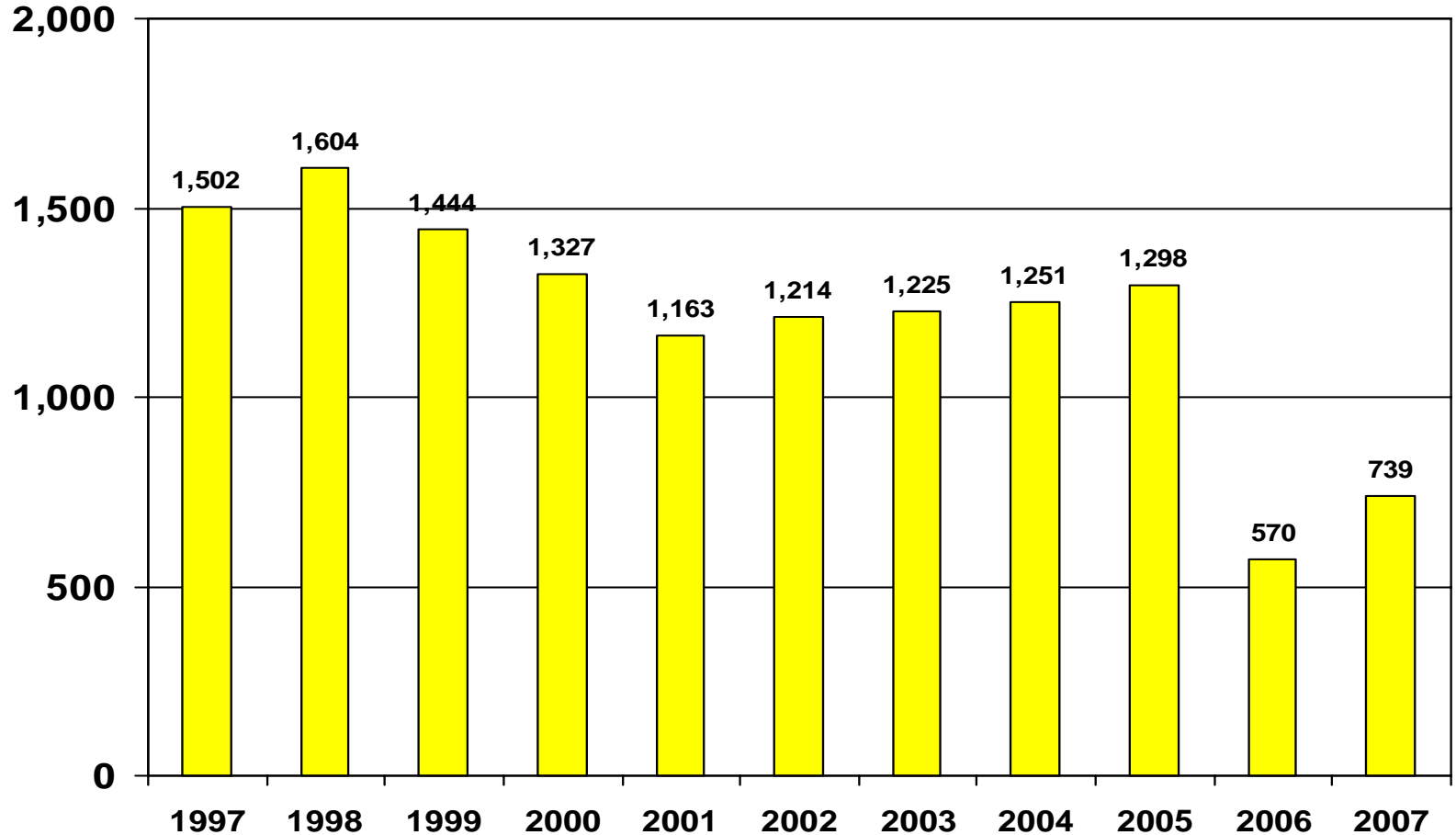

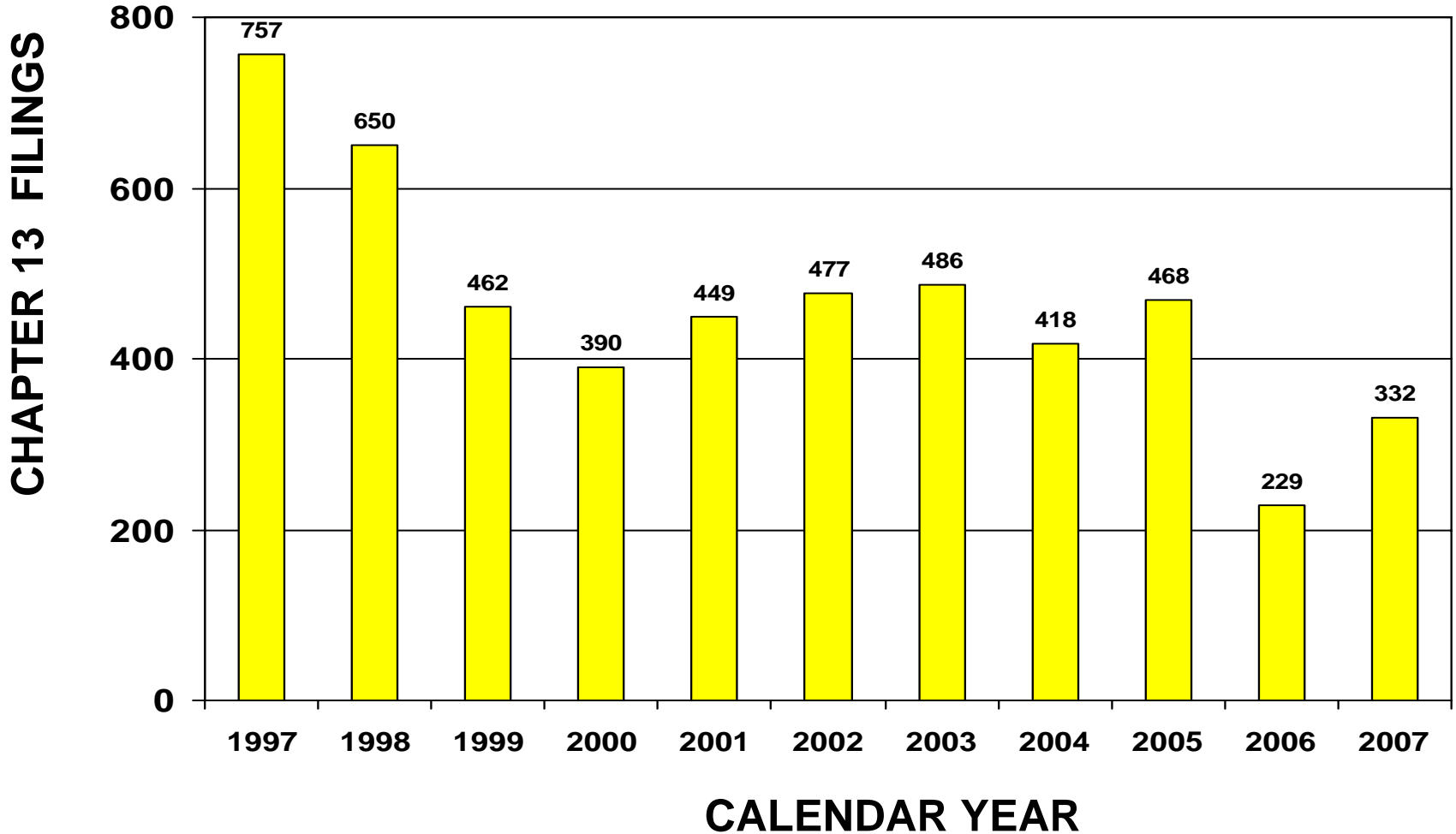

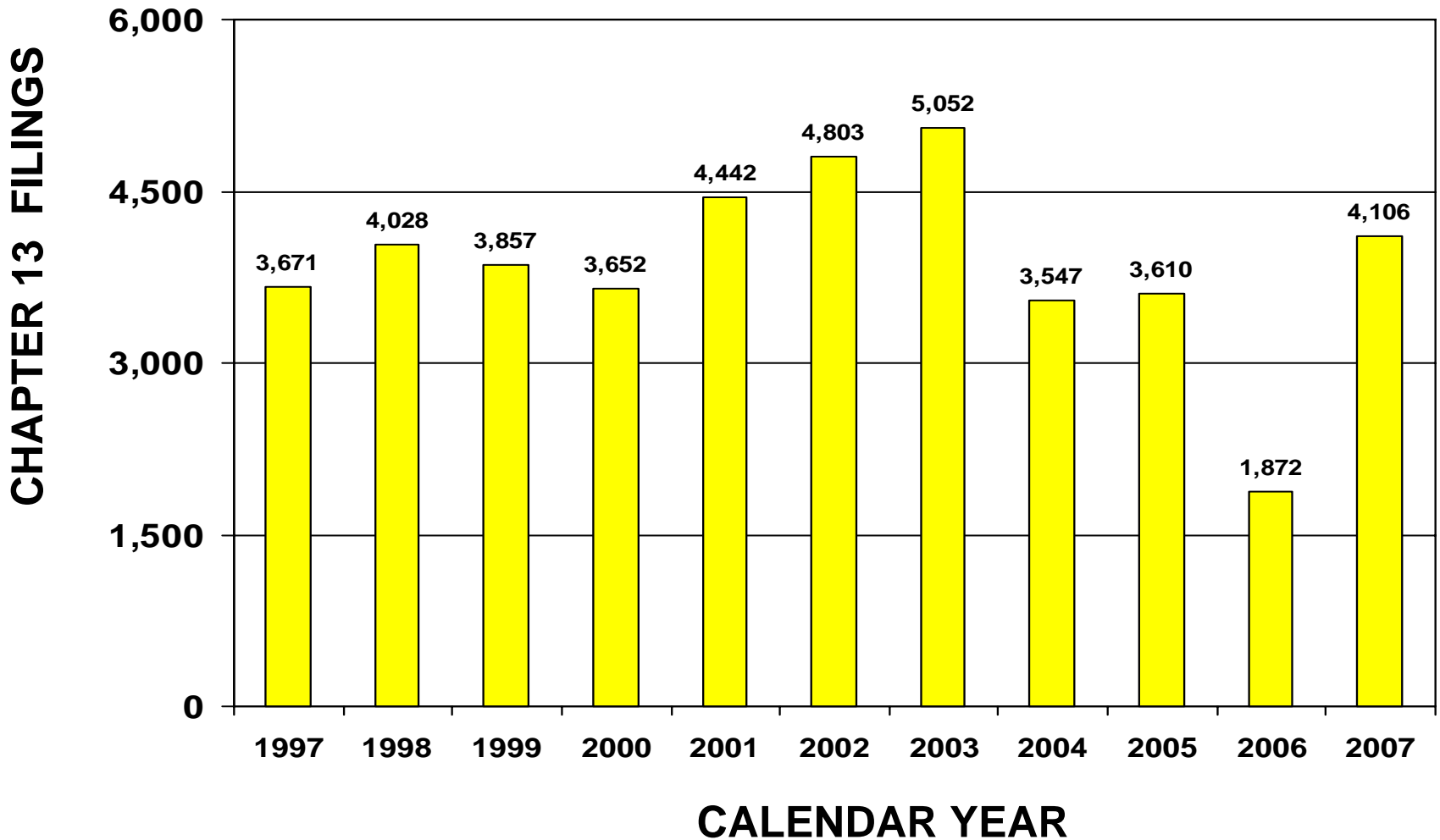

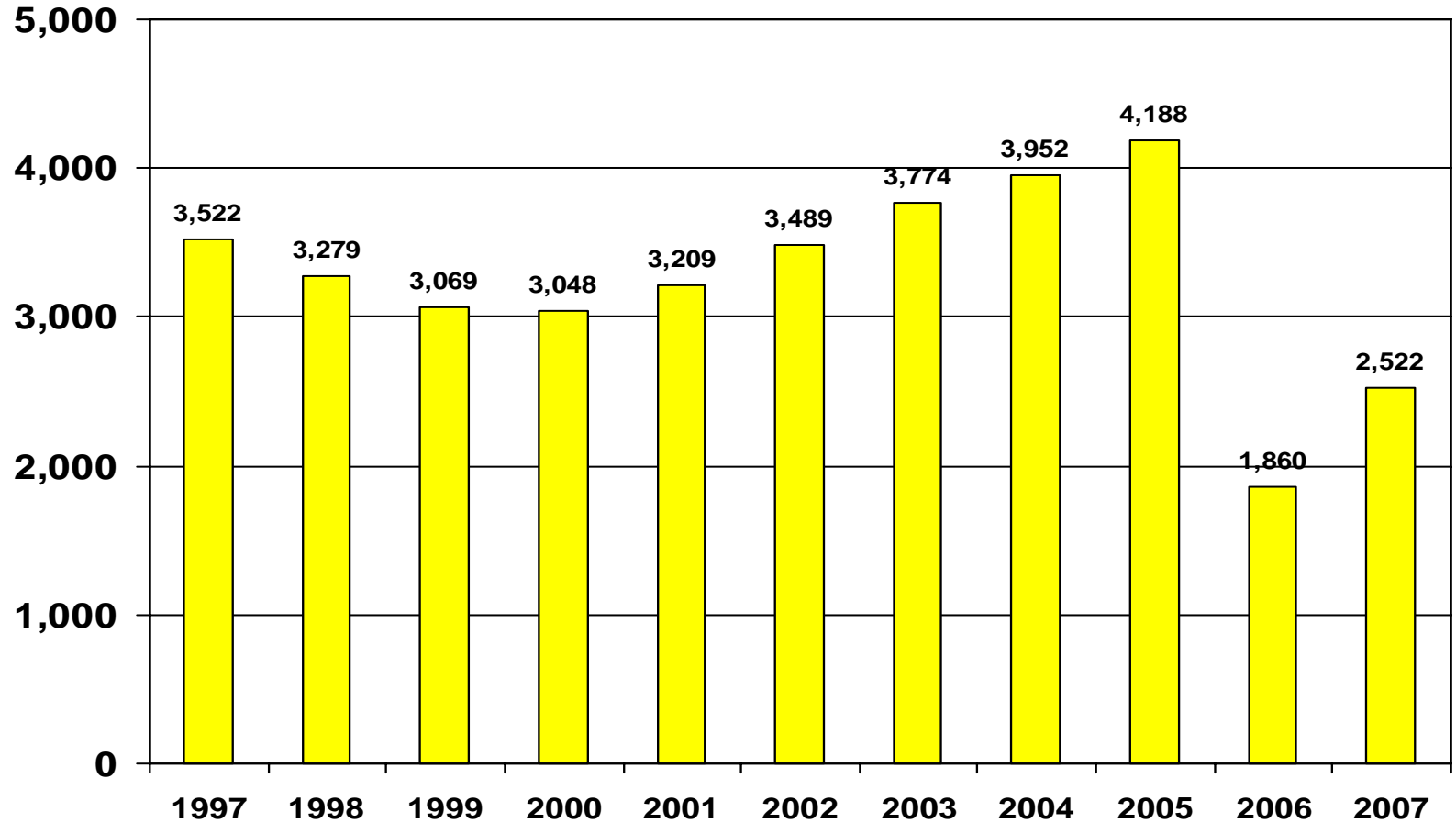
This chart shows chapter 13 case filings in Nevada for calendar years 1997 through 2007. Chapter 13 filings averaged 3,876 per year during this period.

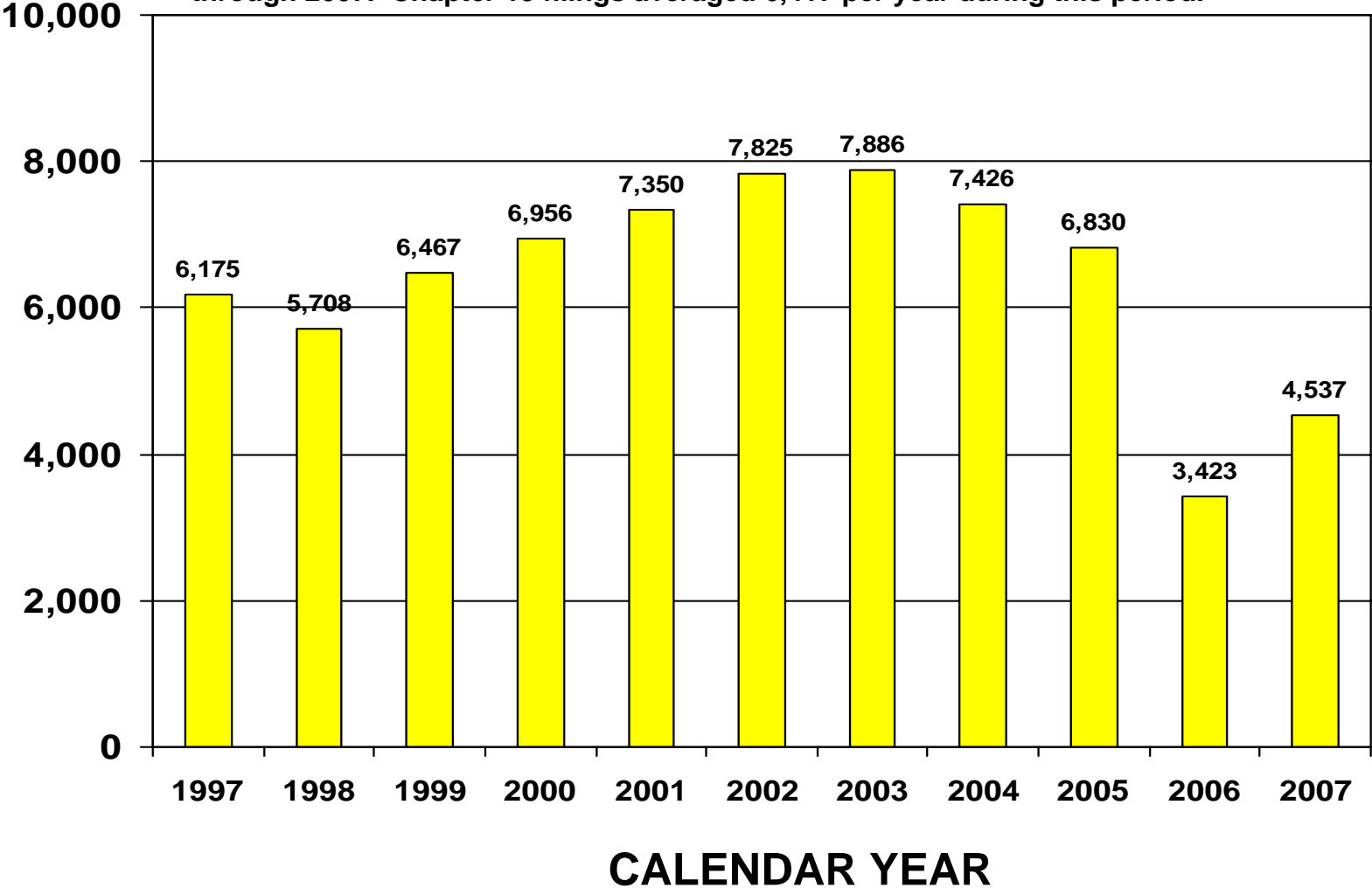

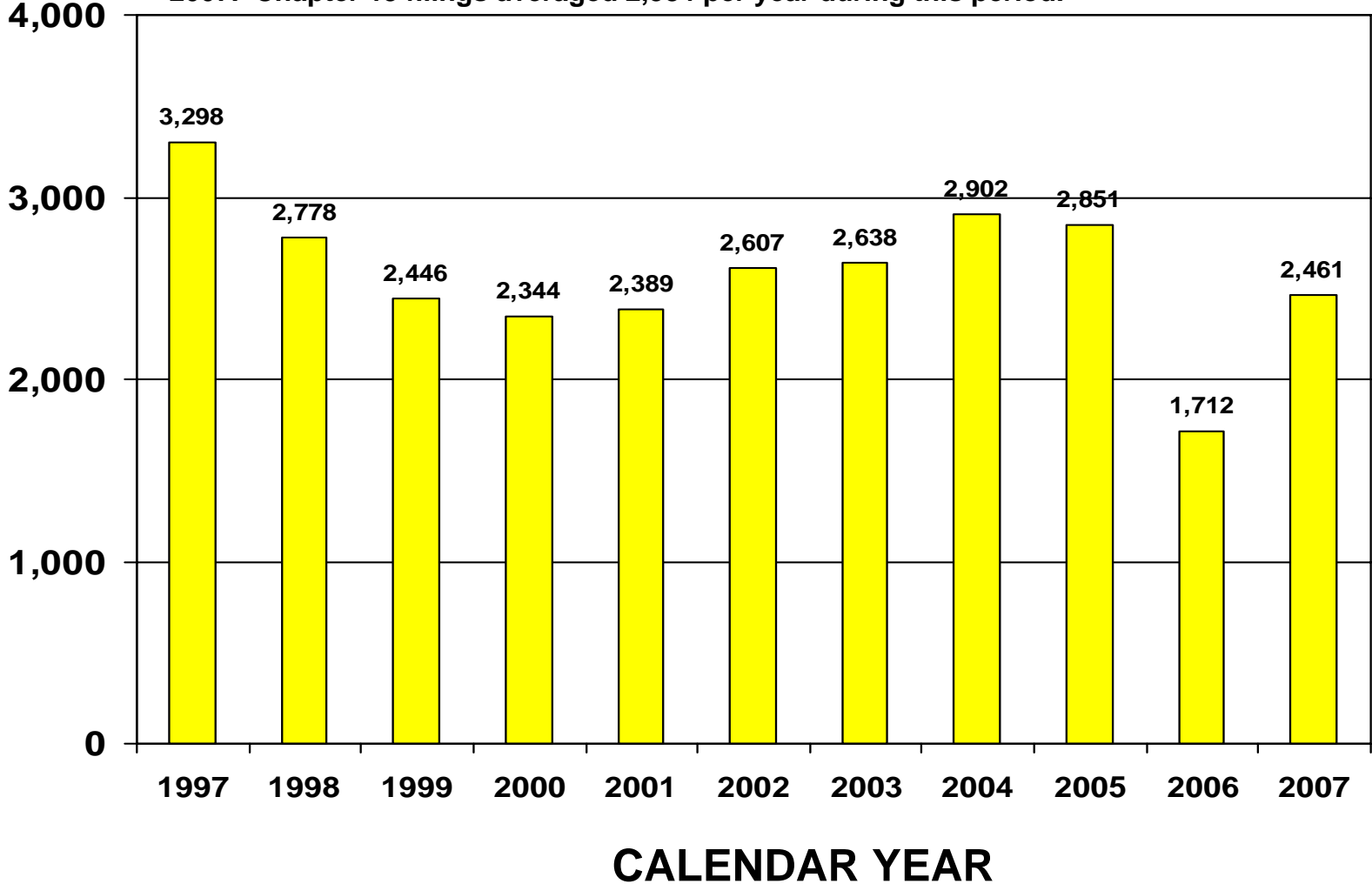

This chart shows chapter 13 case filings in Colorado for calendar years 1997 through 2007. Chapter 13 filings averaged 2,584 per year during this period.

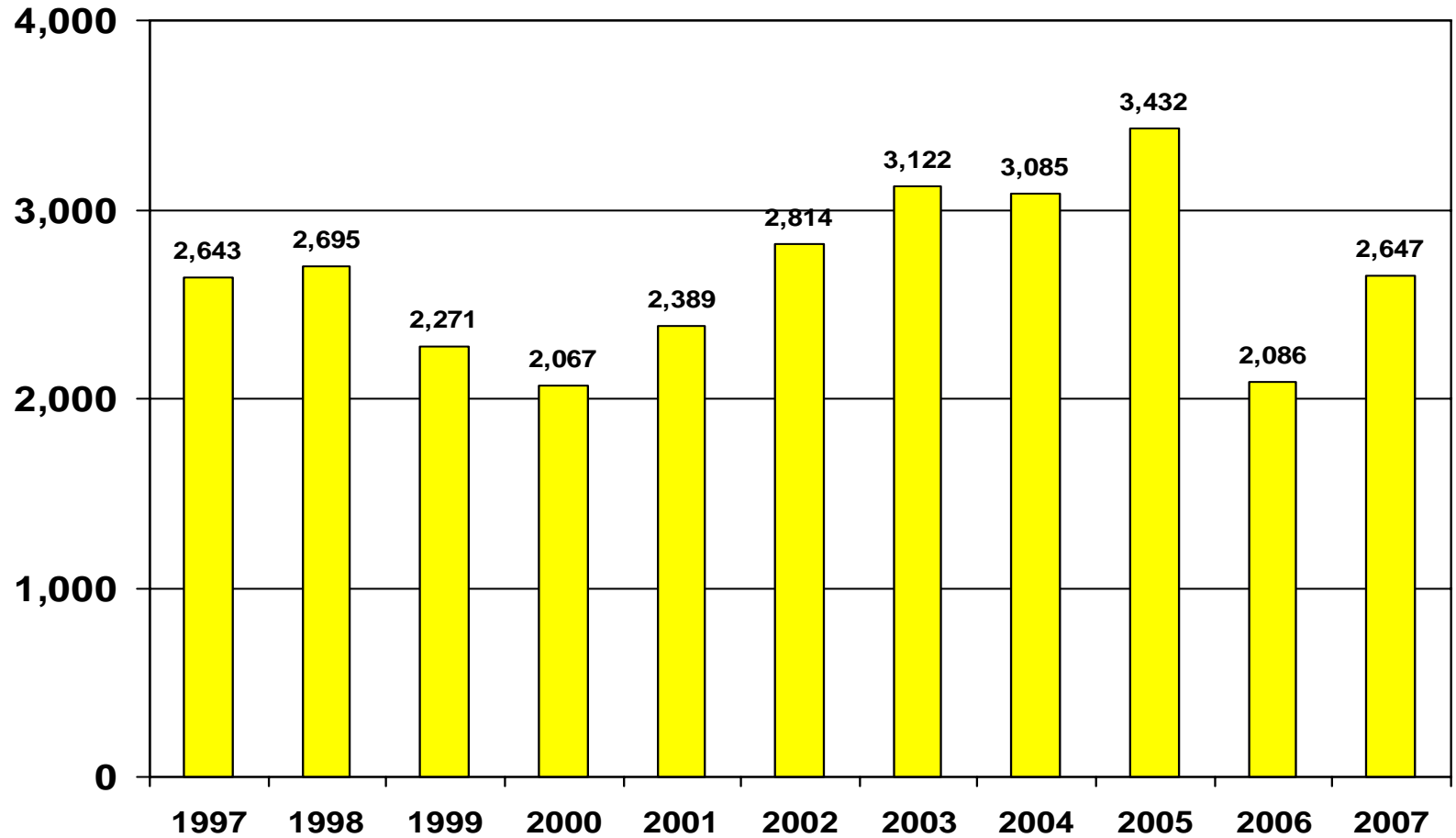

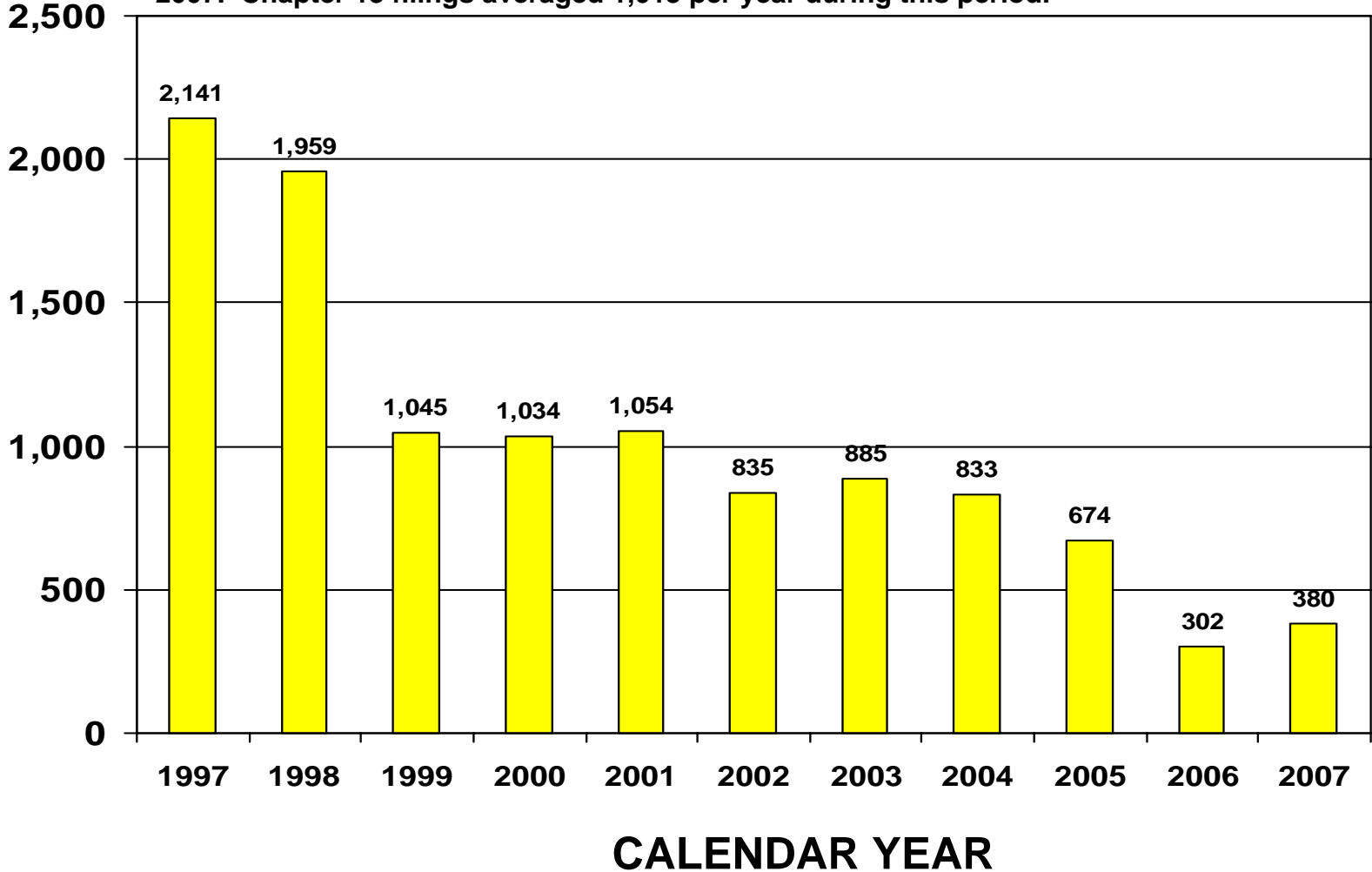

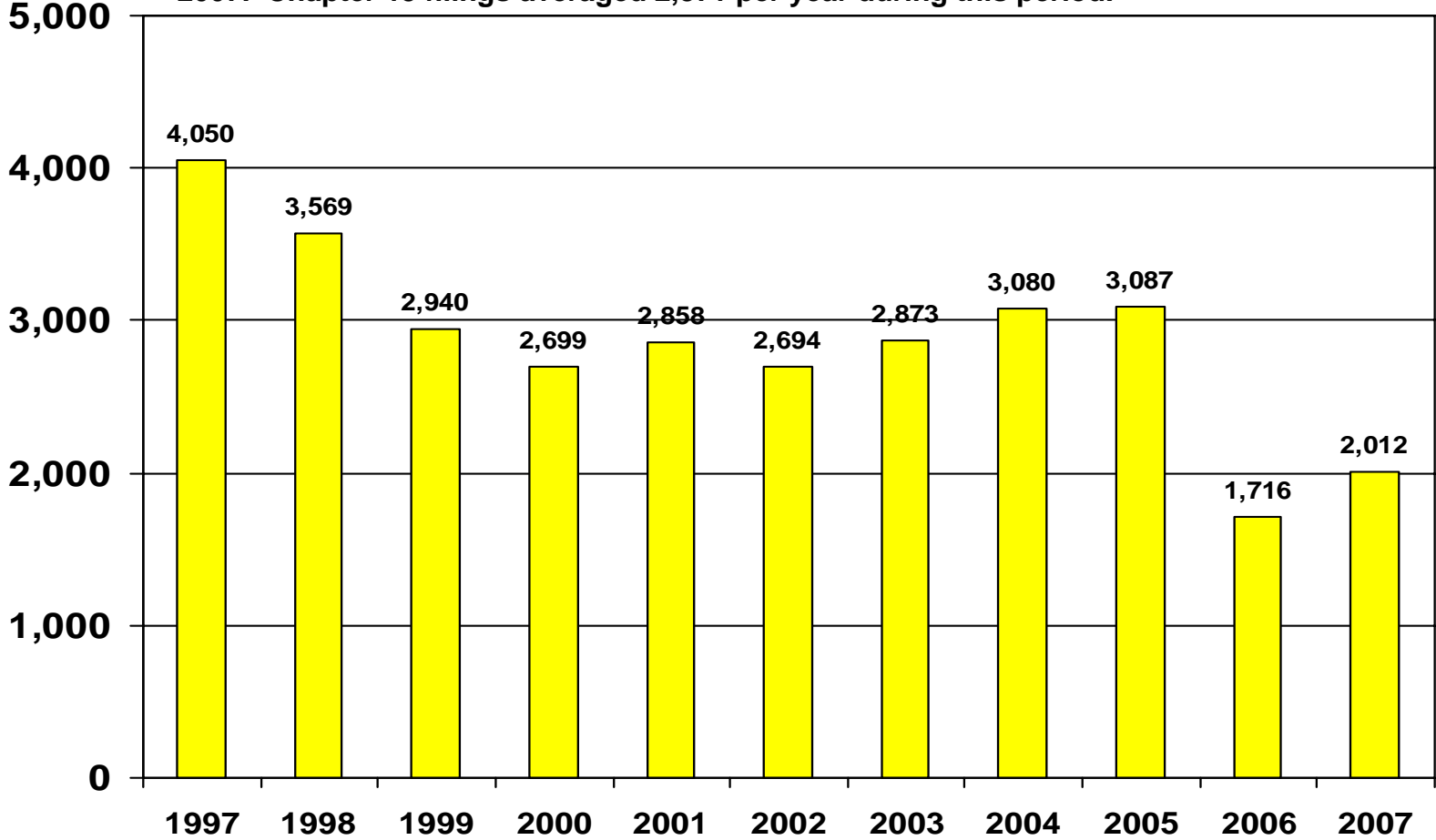

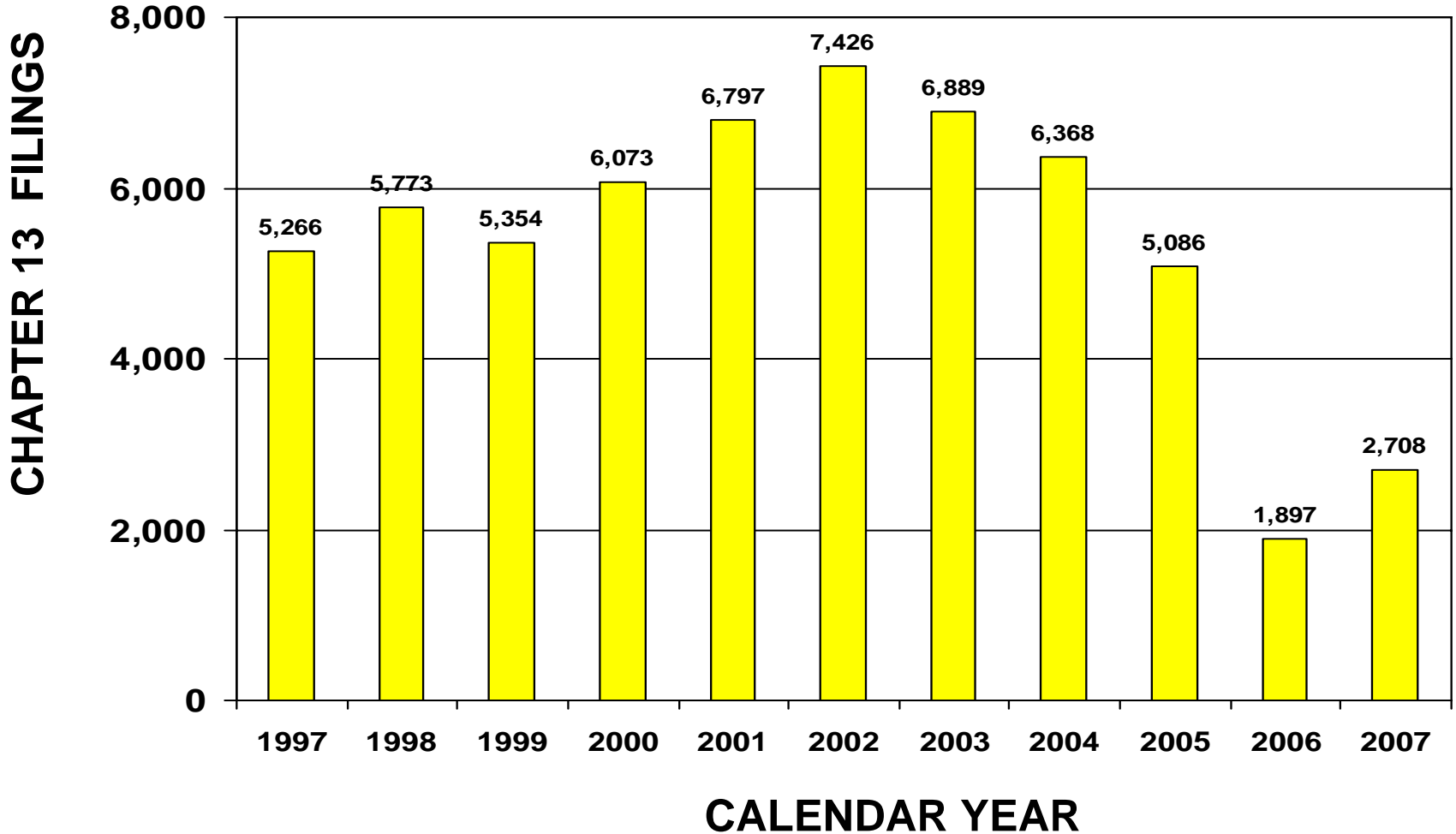

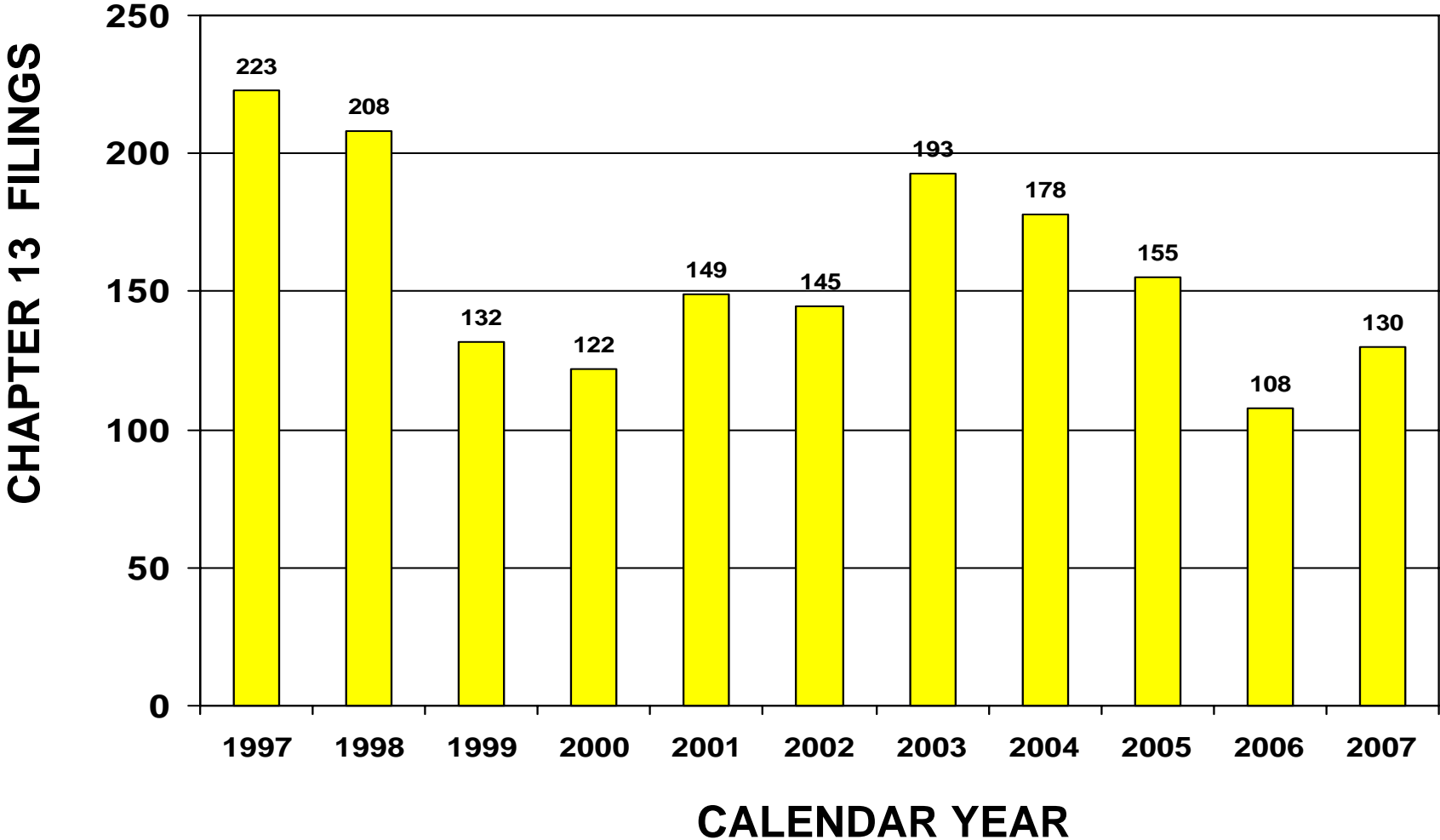

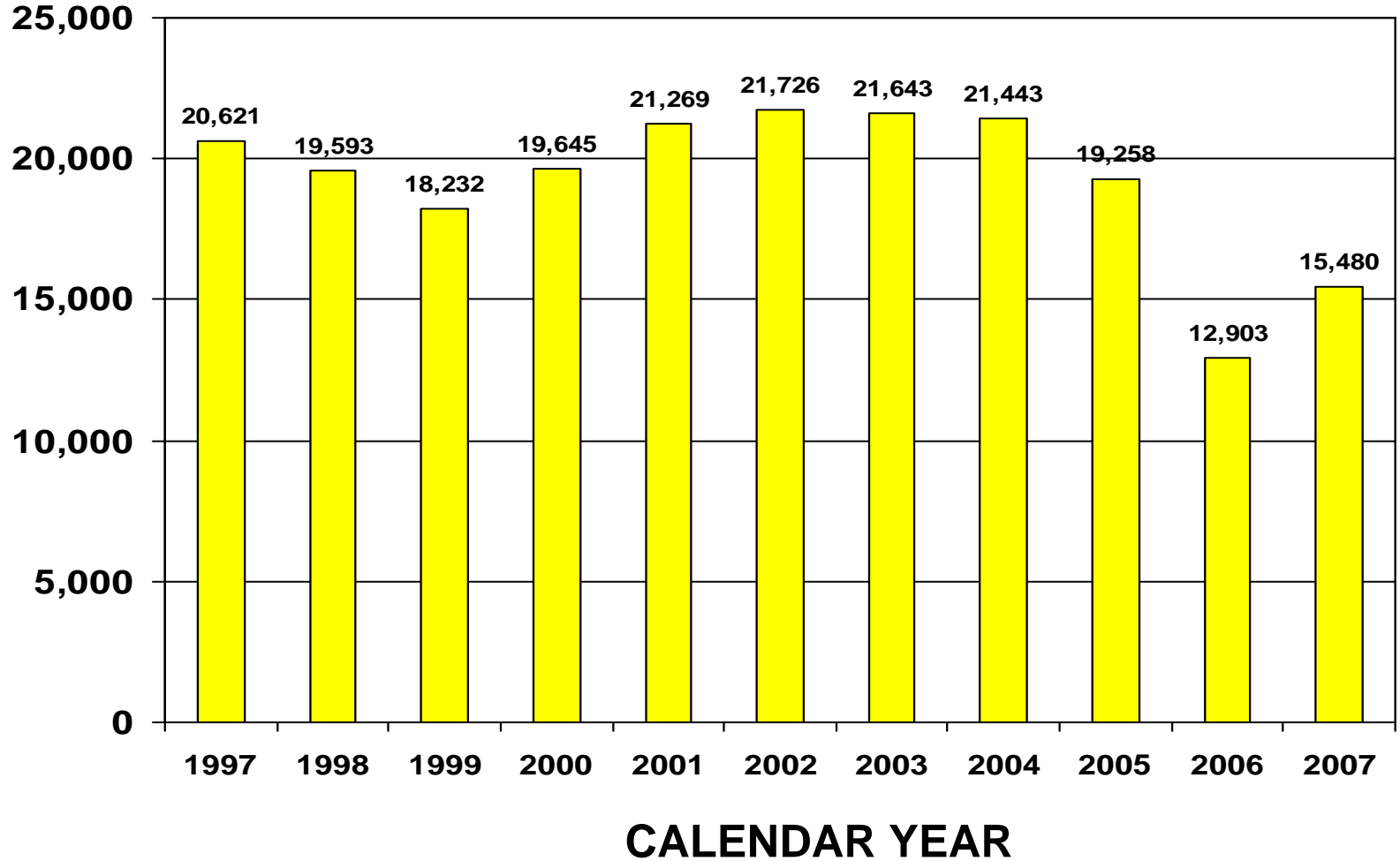
This chart shows chapter 13 case filings in Wyoming for calendar years 1997 through 2007. Chapter 13 filings averaged 158 per year during this period.

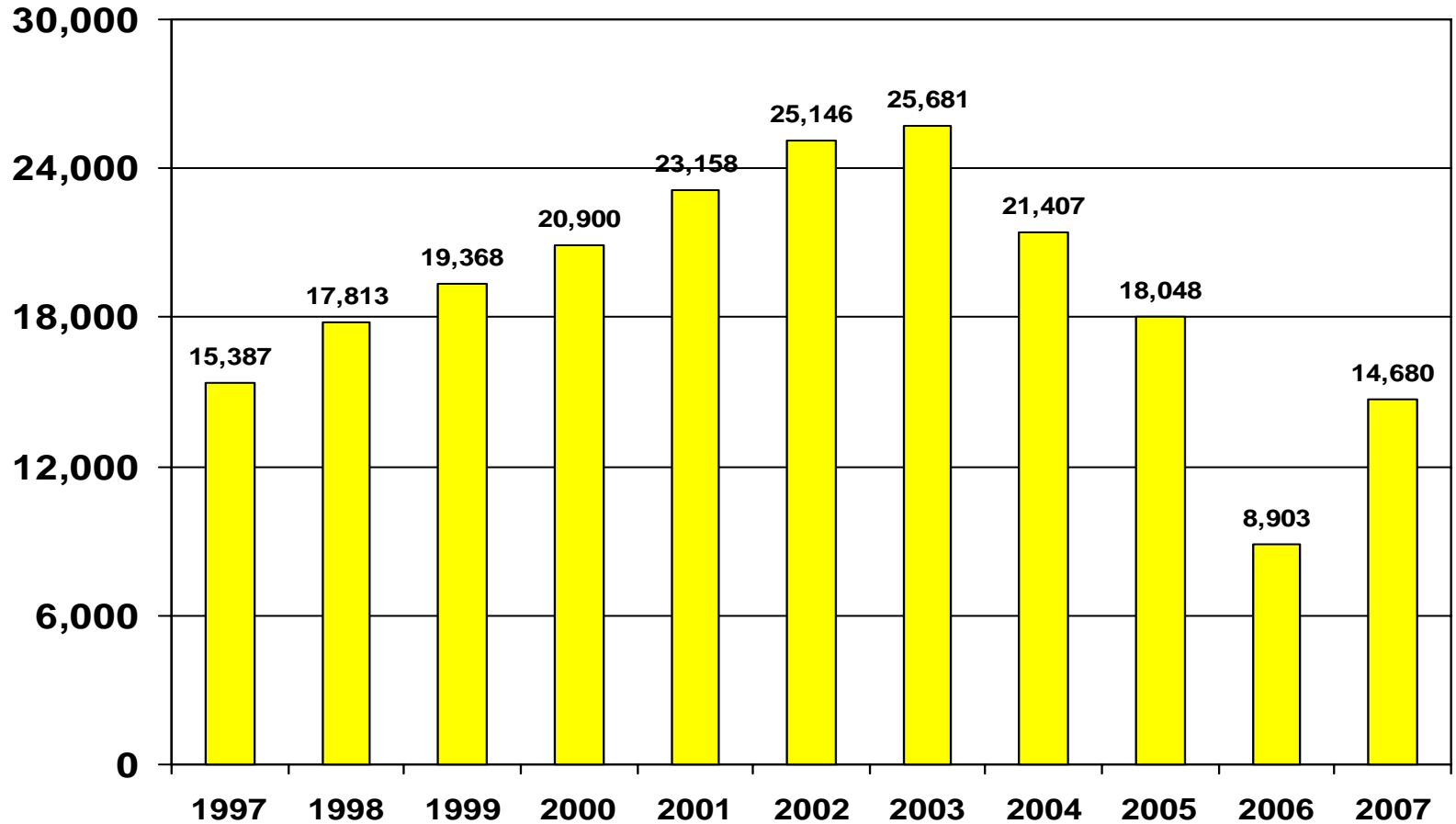

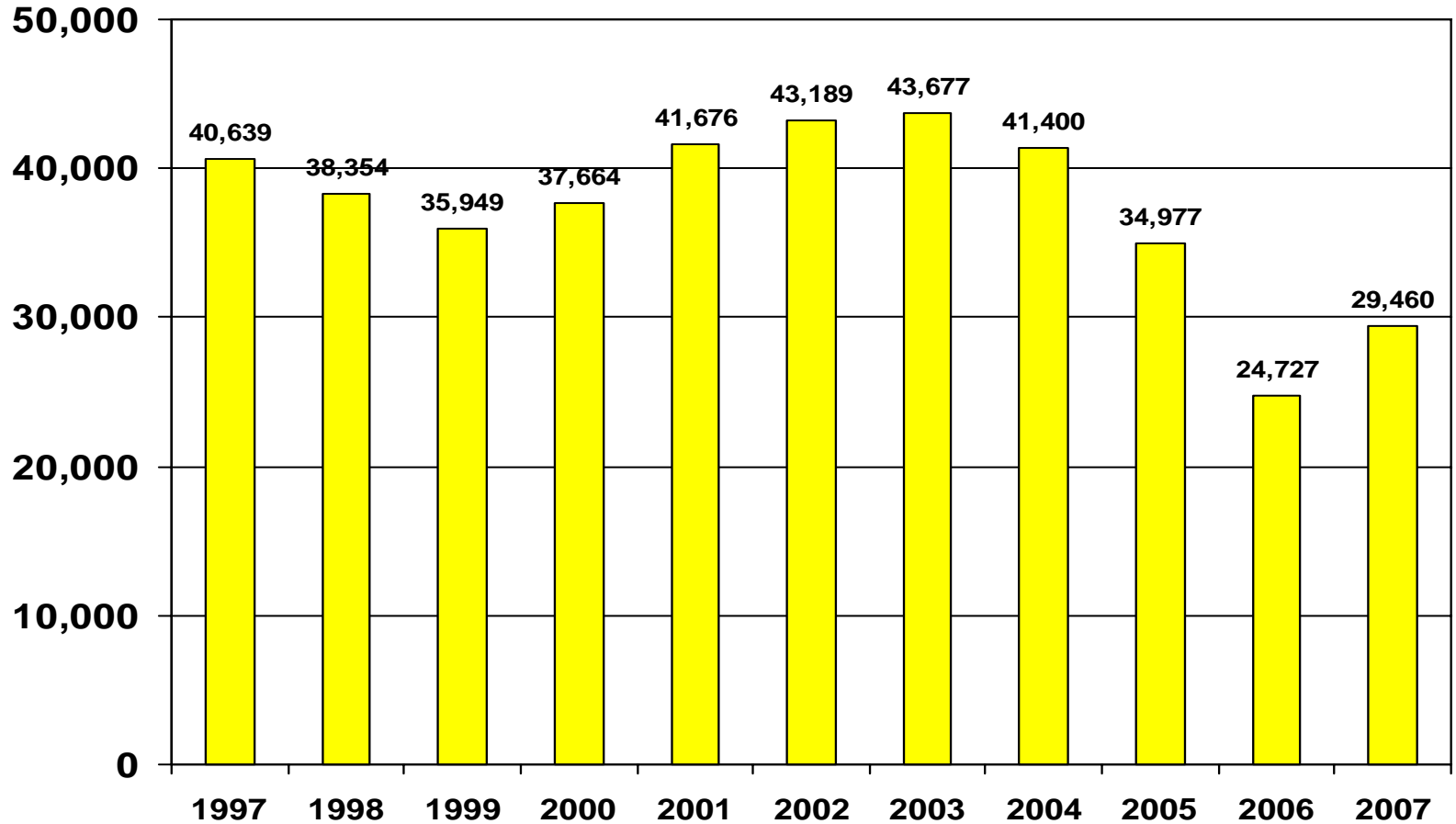
