Please complete the following application form for an Oregon Department of Agriculture inspection of mint fields in Klamath and Union counties for Verticillium wilt, as eligible for planting in Control Areas under department rules (OAR 603-52). Please use one form for each field to be inspected.

The Department will assess the program costs each year for these inspections (OAR 603-52). The most current fee is \$12.00 per acre when applications have arrived by the due date, but charges may be significantly higher if the application is late and inspectors have to be sent back to the area. Inspection reports and invoices will be mailed in the fall, or upon request by calling 503-986-4620.

This application is due by June 1. If the application is late, the department may not be able to inspect the field. The fields will be surveyed during the last two weeks of July. If pesticides will be applied to the field immediately prior to or during the inspection period, please notify the department by mail or by fax at 503-986-4737.
