

# **NIST STANDARD REFERENCE DATA (SRD) INTERNET SERVICE** **SUBSCRIPTION LICENSE**

This document is a non-exclusive, non-transferrable, non-assignable and limited License Agreement (AGREEMENT) between the National Institute of Standards and Technology, U.S. Department of Commerce, Gaithersburg, MD 20899 (hereinafter known as NIST) and \_\_\_\_\_, (“Licensee”).

## **DEFINITIONS**

**Internet Editions of NIST Standard Reference Databases** - An SRD product specifically designed to provide the most current version of a NIST Standard Reference Database and supporting functionalities in a platform-independent modality accessible to a web browser over the Internet via the NIST SRD Subscription Service Portal.

**Authorized Users** – a person designated in the License to use the Internet Edition of a NIST Standard Reference Database under the terms of this agreement. There are two possible methods of access: 1) Each Authorized User shall receive a username and password upon registration or 2) a user within a registered IP block may access via the NIST SRD Subscription Service Portal the Internet Editions of NIST SRDs covered under this Agreement

## **1. GRANT of RIGHTS, TERMS AND CONDITIONS**

Upon acceptance of this Agreement, NIST (“Licensor”) shall grant Licensee a non-exclusive, non-assignable and non-transferable for \_\_\_\_\_ Authorized User(s) from \_\_\_\_\_ (name of Institution) the right to use the NIST Standard Reference Databases Subscription Service (hereinafter, the “Licensed Service”) to access, via the Internet, Licensee’s chosen NIST Standard Reference Data subscription packaging, specifically \_\_\_\_\_ (hereinafter, the “Licensed Package”). Unless elsewhere modified, the license granted herein shall be for a period of one (1) year, beginning on the date that the Agreement is accepted by NIST, and will automatically terminate one (1) year from the date of acceptance, NIST reserves the right to modify the terms of this Agreement upon renewal. NIST will provide Licensee with the date of acceptance of this Agreement.

For subscriptions based on IP numbers the licensee will only be allowed access from the IP Number ranges listed in the Access Method section of the document.. These IP numbers must be exclusively used by the licensee. Use of these IP numbers(s) to access the service must be limited to authorized users from the licensee.

## **2. COPYRIGHT AND USE RESTRICTIONS**

Copyright protection on the Internet Editions of NIST Standard Reference Databases has been secured by the U.S. Department of Commerce in the United States and in other countries that are parties to the Universal Copyright Convention, pursuant to Section 290(e) of Title 15 of the United States Code, Licensee is responsible and accepts responsibility for ensuring that Licensee’s Authorized Users comply with all copyright and usage provisions under this agreement. Under no circumstances or conditions shall Licensee sublicense or otherwise transfer the use of the Licensed Service, nor shall Licensee or Licensee’s Authorized Users reproduce, distribute, augment, change or modify any material, including the Licensed Package obtained through the Licensed Service, unless permission to do so is expressly granted in writing by NIST. Licensee and its Authorized Users may not reproduce or distribute copies of the licensed material to anyone other than the Authorized Users, for any reason or purpose, unless approved by NIST in writing prior to such use. Licensee and its Authorized Users shall not place any of the materials obtained through the Licensed Service on an Intranet or Extranet, without NIST’s explicit written permission.

Licensee and Authorized Users are NOT permitted to do the following:

- allow any other than an Authorized User to use or access the licensed service;
- share their username or password
- create a searchable archive of any portion of the licensed service
- develop a commercial package from any portion of the licensed service and in turn, distribute package in any mode or medium to additional customers
- alter or modify any portion of the Licensed Service
- delete or remove, in any form or format, any copyright information or notice
- combine any portion of the Licensed Service with any other material, in any form or medium, without the written authorization from Licensor.

Licensee and authorized users in registered IP address are NOT permitted to do the following:

- Register one or more IP numbers which are not exclusively used by the licensee.
- Use a registered IP number to allow access by individuals who are not covered by the license in alternate institutions.

### **3. SUBSCRIPTION FEES**

License fees are based upon the number of full time employes or students at a particular licensed location. Licensee shall be given access to the Licensed Service upon full payment of the appropriate fee and acceptance of this agreement. Licensee understands that payment will be due in advance in order to access the Licensed Service. Licensee agrees that the license granted herein shall not take effect until NIST has received full payment of the appropriate subscription fee.

### **4 NO WARRANTY**

NIST strives to deliver a high quality database and to verify that the data contained therein have been selected on the basis of sound scientific judgment. However, NIST makes no warranties, express or implied, of any type including no warranty of merchantability or fitness for a particular purpose. NIST shall not be liable for any damage that may result from errors or omissions in the database.

### **5. TERMINATION**

Licensee may terminate this Agreement for any reason, at any time. This Agreement may be terminated by NIST in the event of any breach of the terms of this Agreement by the Licensee. NIST shall notify the Licensee in writing of its intention to terminate the agreement for cause and will allow customer, thirty (30) days to correct the breach after the date of receipt of written notification.

### **6. SYSTEMATIC DOWNLOADS**

Licensee hereby agrees that systematic downloading of material, e.g., use of robots or intelligent agents (e.g., spiders, web crawlers, etc.) to access and download materials through the Licensed Service, is strictly prohibited and a violation of this Agreement.
