**Source Water Protection Grants Recipients - 2007**

**Eugene Water and Electric Board – Lane County**

McKenzie River Septic System Assistance Program

Grant Amount: \$20,000

Eugene Water & Electric Board will utilize the \$20,000 to supplement the DEQ Section 319 grant, to partner with a variety of state and local agencies in order to most effectively implement and expand their outreach and education to interested homeowners and work with them to implement action that would reduce potential risks from on-site septic systems in high priority areas.

**City of Detroit – Marion County**

Security Fencing

Grant Amount: \$20,000

The proposed project, a combined protection & security effort would completely fence the water treatment plant, limiting access to the City of Detroit only. A new gate will be installed on the road to the Mackey Creek damn in an area above the water source to prevent unlawful dumping of waste and or trash.

**Langlois Water District – Curry County**

Grant Amount: \$20,000

Develop a drinking water protection plan for the water district. The project will follow DEQ/DHS guidelines, including identification and outreach to critical stakeholders.

**City of Springfield – Lane County**

Springfield Drinking Water Protection Outreach and Communication Database

(Database)

Grant Amount: \$20,000

The proposed Database will allow the City of Springfield to foster more frequent and effective outreach by allowing the City to track their communications, set up mailing lists and schedules for automated reminders and notices, develop recipient lists for educational materials, track issues of concerns, and cross-list contacts based on a range of categories such as sensitivity of the location or presence of underground storage tanks.

**City of Maupin – Wasco County**

City Springs Security Fencing

Grant Amount: \$20,000

The project involves the installation of a security fence and protection fence around the remaining three sides of the City Spring protection area. This activity completes the protection effort initiated by the city to minimize risk in the recharge areas of the spring.

**City of Coburg – Lane County**

Ground Water Monitoring Wells

Grant Amount: \$20,000

Early detection of possible contaminants at the City well. The Proposed well will help the City evaluate the susceptibility of the City's water supply to storm water run off.

**Central Howell School – Marion County**

Replace Fuel Tank

Grant Amount: \$14,190

Underground heating fuel storage tank will be removed or decommissioned, substantially reducing the risk of contamination of the school's drinking water supply.

**Victor Point School – Marion County**

Victor Point School Tank Decommissioning

Grant Amount: \$4,600

Remove or decommission in place fuel oil storage tank, substantially reducing the risk of contamination of the school's drinking water supply.

**Butte Creek School – Clackamas County**

Butte Creek School Tank Removal or Decommissioning

Grant Amount: \$8,110

Remove or decommission 5,000 gallon under ground storage tank, substantially reducing the risk of contamination of the school's drinking water supply.

**Silver Crest School – Marion County**

Silver Crest School Fuel Oil Storage Tanks

Grant Amount: \$20,000

Remove and replace underground fuel oil storage tanks, substantially reducing the risk of contamination of the school's drinking water supply.
