# **Team building Activity:**

## **Sharing:**

- Chair shared requests/info from Directors office:
  - o A group wants 90 minute interviews with DV survivors for a study. DHS may be making survivors aware of the interviews and the opportunity to participate. Sarah shared this may be a study on victims in the workplace.
    - Possibly have their grant manager (Noelia Hernandez-Valdovinos; 888-560-6877; 503-317-4575) come speak at council meeting.
  - o Are quality standards congruent with DHS DV Standards?
    - Response to letter: there are a variety of measurements. DV Standards are one of many tools and options. We did not consider other measurement tools.

- Carri: is on call with Red Cross to go help with Katrina.
- <u>SDA 2 committee work:</u> Carol distributed handout on the activities of this group and asked that committee members bring in information on similar happenings around the state. Jayne and Carol are attending these meetings.
- Bonnie did not get the grant to continue to have advocates in rural programs.
- Carol brought copies of the GAO study that showed that Health and Human Services (HHS) should provide better guidance on screening for DV in TANF programs. Contact Carol if you want the link. Only 5 other states have anything like TADVS – Alabama, Arizona, Iowa, Florida & Utah.

#### **Discussion:**

What do we do when we hear things about DHS?

- Local management team would hear first, then if problem wasn't resolved, they would go farther. Does the council have a responsibility to say things when the group hears things? (i.e. should the council correct misperceptions, etc...maybe people don't realize there is a formal complaint procedure within DHS). This should be handled on a case by case basis.
- 1. Make certain someone calls to follow up and verify that someone tells the person the complaint process.
- 2. The council will draft a list of contacts and numbers for general complaints.
- 3. Susan Hughes will draft a position paper on what the council will do in these circumstances by October's meeting. Jayne & Carol will present to Barry.
- 4. Maybe a presentation on GAO and what they do? Their internal processes.

## **Trauma Council report-out:**

LeAnn left them a card and asked them to call her if they had questions: Carol distributed the draft policy. One of their partners may be interested in being a part of the council. Send comments to Carol if you see something that doesn't fit within our standards.

## **Update on Governor's DV Council:**

• Carol handed out the public hearing testimony from July. Carol will be going to a forum in the Umatilla tribe on the reservation (they have really good training on history of tribes in Oregon).

The public testimony is of a victim who said she came to OR from ID because of the child support laws (specifically good cause) in Oregon being friendlier to DV survivors.

#### <u>Updates on standards of training:</u>

- SDA 2 is designing their own training, and Carol made certain they knew about the DV Standards and Kim gave them the Standards.
- Child welfare does not currently have point persons. SDA 2 is rethinking how point people might be used in CW
- They are designing their own flier and complaint process.
- The director's office might be able to encourage local offices to look to the standards.
- CW moral gets low because they have the perception that so many of their cases nexus in DV and they feel like the script is exactly the same.
- There is an 80% no show percentage for SDA CW point persons at quarterly partnership meetings. SDA managers had requested point people from CW and SS attend the meetings. Carol will follow-up with SDA managers. SPD decided not to appoint point persons. They have APS workers.

## **Hardy Myers: Batterer Intervention Standards:**

Purpose: to help insure the safety of women & children. To help insure the batterer intervention component will have as high a standard as we can achieve of impacting the behavior of batterers.

DV has such lethal potential; the stakes involved are great.

These standards will be administrative rules: thus they will be law. They haven't come up with a mandate for compliance. Judges choices of programs will be shaped by whether or not programs are complying with standards.

#### Key controversial issues:

1. Gender specificity—rules are specifically for male batterers. Decision generated a lot of controversy.

- 2. Length of programs
- 3. Grandfathering current instructors
- 4. Polygraphs
- 5. Separate alcohol/drug standards
- 6. Couples counseling: standards prohibit offering as batterer intervention
- 7. Prohibition of batterers becoming counselors in BIP's.
- 8. Definition of victim: was challenged by various responders b/c it is a woman. Batterer cannot be considered a victim.

Goal: Release Batterer Intervention standards in October and formalize before the end of the years, making this valid at the beginning of the year.

Currently there are Batterer intervention recommendations. Some counties have standards but nothing state wide.

If we want the committee members, we can send him a card & address.

He is open to questions or comments, etc...

There is no current enforcement mechanism. Enforcement will come primarily via judges. It appears that there is a heightened interest in DV& sexual assault. He distributed draft standards and invited comments: ok to respond directly to him.

BIPs are independent and independently funded.
