- Carol distributed address confidentiality program issue briefing. Please let Bonnie, Carol, or Morgan Brody know if you see an impact or if you have questions.
- They will start with a small group and grow up to a group of as many as 250. Bonnie commented that WA State found that there weren't large numbers requesting this.

Feedback on HR training: Jayne Downing & Carol Krager

• Mostly HR generalists in this meeting. It went fairly well. They requested the video tape on DV and wanted to pass it around.

Native American Youth and Family Center—Tawna Sanchez

- Jan 2000 began the family healing circle system. DV & Sexual Assault are not part of the history within the Indian community. Because children were sent to boarding schools, they were exposed to violence and did not have family role models.
- They believe that DV is not normal for Indian tribes. They believe that violence within the tribes is mostly an issue of modeling.
- Many people in this area have no interest in involvement with government because many Indian children were taken by government. They have great FEAR of government. This group may struggle with getting people to be involved with DHS.
- The statistics of violence with tribes are higher than the average: 60%-65% of violence against women is from non-native people.

Reservation police may not be able to prosecute non-native peoples or may have only civil authority.

Are there things CPS could be doing to better working with the tribes? Sometimes our cultural mindset needs to be filtered:

- Animals in the house are very normal
- Sleeping on the floor isn't abnormal
- Not having a lot of food in the house isn't abnormal: they may eat at functions fairly often. They have a Watetcha bowl to take food home from an event.
- Another example: questions may not be immediately answered because their culture tends to wait for the speaker to finish speaking.
- Allison asked for sources of information on cultural differences.
- What they do now may not be traditional, but it may be generational. They speak a lot around traditional treatment versus generational treatment.
- Grande Ronde Indians will be honoring all veterans WWI to present veterans in a ceremony soon.
- People outside of metro area: they will assist with transport. They can help get folks involved with safe shelter here.
- NARA: Native American Rehabilitation and Alcohol program. They are not Portland specific.
- They are in the process of moving.

Carri shared a concern:

On a recent home visit, the batterer was in the home and she ran into him. She felt like she had put the person in jeopardy by being present. Does DHS need to reconsider how they are screening home visits?
