## Combat Veterans Experience the Magic of Winter

For the last 22 years, veterans have been taking to the slopes across America. The first ever 'Soldiers in Sisters' weekend brought a taste of the action to some Oregon combat veterans and their families.

'Soldiers in Sisters' was held on the slopes of Hoodoo Ski Resort near Sisters, Oregon. Hosting 10 disabled veterans and their loved ones, the weekend package included skiing and snowboarding, lodging, food, and more. Oregon Adaptive Sports (OAS), Hoodoo Ski Resort, Disabled American Veterans (DAV), along with several other Oregon organizations and businesses, planned and funded the program.

Amber Blanchard, President of OAS was inspired by all those who stepped up and supported the weekend getaway on behalf of those who stood to preserve freedom. "These men and women have given their all to defend our country. It is only right that we put together a weekend to bring them together," said Blanchard when describing the importance of including spouses and family in the weekend activities.

First class accommodations at the Five Pine Lodge were provided at no cost to the veteran. "The rooms are absolutely gorgeous, so we wanted to ensure veterans had ample time in their schedule to enjoy relaxation with

their loved ones." Blanchard said about the rooms that featured a fireplace and soaking tub.

Director Jim Willis of the Oregon Department of Veterans' Affairs said, "An event of this scale is a shining example of how communities can provide a warm welcome home to war veterans while reflecting on community events being offered throughout Oregon. These events connect veterans and families with patriots who share in their love of country and passion for service."


Volunteers of OAS worked with adaptive ski instructors at Hoodoo Ski Bowl to teach skiing and snowboarding. Hoodoo offers five ski lifts, 806 skiable acres, 30 alpine trails, and a tube park. OAS, a Chapter of Disability Sports USA, is a non-profit corporation in Oregon.

The 22nd Annual VA Winter Sports Clinic kicks off on March 30 in Snowmass, Colorado. The event which runs through April 4th includes veterans who receive health care at a U.S. Department of Veterans Affairs (VA) medical facility. It is open to U.S. military service veterans with traumatic brain injuries, spinal cord injuries, orthopedic amputations, visual impairments, certain neurological problems and other disabilities.

The Oregon Military Hall of Fame will honor its second class of inductees on Saturday, April 12, 2008 at 12 p.m., during a special luncheon ceremony at the Red Lion Hotel at Jantzen Beach in Portland. This event will bring together veterans from some of the most famous battles of World War II in what may be one of the largest gatherings to date of military citation holders in Oregon.

Inductees are recognized in two categories: *Above & Beyond the Call of Duty* and *Service to Country & Community*.

In the *Above & Beyond the Call of Duty* category, the following groups and individuals are being inducted:

# 2008 Supplemental Session

Most people are aware that the State Legislature held a first-of-its-kind supplemental session in February. Before the session began, Senate and House Leaders met to discuss issues they hoped to focus on and pass during the short session.

Some of those common issues included:

- Providing 24-hour state police coverage
- Quality care for seniors
- Children's welfare
- Mortgage lending
- Water storage and resources

The number of bills introduced by Committees was limited and the House Committee on Veterans' Affairs introduced House Bill 3625 (HB 3625), that if passed would establish the Veterans' Small Business Repair Loan Program and provide interest-free loans to certain veterans. Another bill, Senate Bill 1060 (SB 1060), was introduced by the Senate Committee on Finance and

Revenue, and seeks to establish the number of certifications for income tax credits that the Office of Rural Health may issue for certain tax years to health care providers who participate in the TRICARE medical system.

With the latest state revenue forecast, which was released on February 8, most bills requesting General Fund dollars were put on hold while the goals of the supplemental session were re-evaluated.

At the time of this printing, HB 3625 had been passed by the House Veterans' Affairs Committee with a do pass recommendation and was referred to Ways and Means. SB 1060 had passed the Senate and had been referred to the House Revenue Committee.

The Oregon Department of Veterans' Affairs is tracking these and other bills and will provide a summary in the May/June issue of *VETS NEWS*.

## Souvenir Army Munitions Unsafe

Whether they are called unexploded ordnance (UXO), "duds," or "dummy ammunition," munitions remain dangerous by design and should never be considered safe to handle. Too often, veterans unknowingly place themselves, their families and neighbors in danger by keeping war souvenirs and assuming they are safe.

In one case in 2007, the result of keeping these dangerous munitions as a conversation piece for many years occurred when two California children were killed and others injured after a live munition detonated.

Exposure to the thousands of keepsake munitions often comes unknowingly, but the risk can be significantly reduced through proper education. The Army is urging anyone coming upon a UXO to use the R's for explosives safety: Recognize—when a munition is encountered; Retreat—do not touch move or disturb it and leave the area; Report—call 911 and advise the police of what you have seen and its location.

## Oregon Soldier's WWII Pacific Theater Picture History

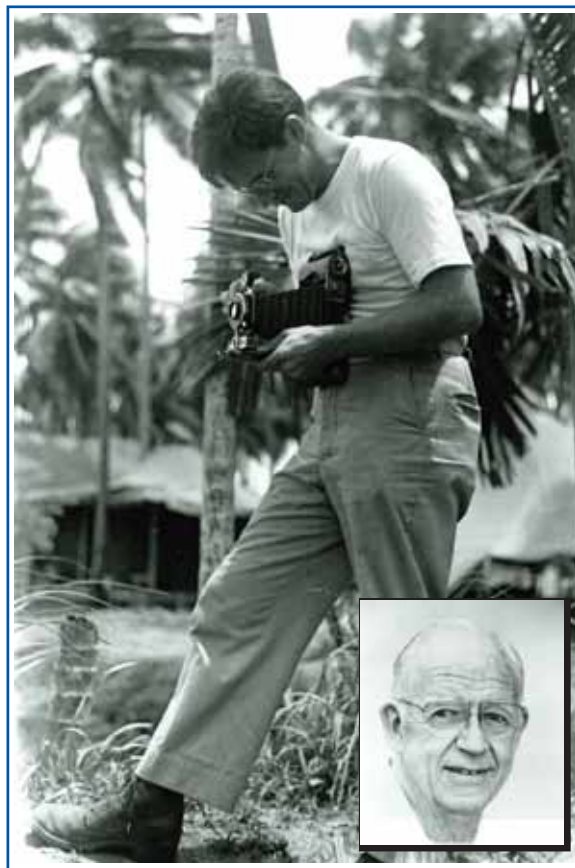

When Fred Hill is asked what he did during the war, he says he shot many things including people, but never injured one of them. From 115 personal letters and more than 200 photographs, the retired photographer from La Grande has created a unique record of war in the Pacific Theater of operations during World War II. This uncensored personal record, entitled *Darkroom Soldier*, is Hill's only published work and shows a world at war as seen through a combat camera lens between 1943-45.

Prior to December 1941, Hill was assigned to an Army National Guard infantry unit, but in November was transferred to the Oregon Air National Guard's 123rd Observation Squadron. As the war raged on, "weekend warriors" like Hill were reassigned to active duty units worldwide. Hill joined his new unit in 1942 and would train at Gray Field, located at Fort Lewis, Washington.

Before being called to active military duty, Hill had been studying in his hometown of La Grande at the Public Works Administration (PWA) Art Center and what is now Eastern Oregon University. He wanted to become a commercial photographer. While on duty, he split time as a clerk and performing other duties before an astute captain recognized his background and the need for trained photographers and photo lab technicians. Hill was soon reassigned as a photo lab chief in Salinas, California in November 1942. By October 1943, he was on his way to the South Pacific with the 5th Air Force's 17th Reconnaissance Squadron.

Portions of Hill's wartime photo album and the letters to his wife, Martha, chronicled much

of the U.S. military involvement from Australia to New Guinea and the East Indies to the East China Sea. The photos depict a record of life as lived by thousands of military members and indigenous people caught between war and their daily lives.

While in a support role, Hill says his unit's mission of processing aerial photos and developing them quickly was crucial for senior military officers. Photo crews worked tirelessly, from mid-afternoon and into the early morning, developing and providing these valuable photos showing enemy locations for U.S. combat leaders to make battle plans.

Sergeant Hill had a close call while aboard the *USS Juan Cabrillo* anchored near Tacloban, Leyte in the Philippines. Unfortunately, he wasn't able to photograph the nearby nighttime Kamikaze attack attempt on other American ships. "I was very scared for that short period of time. Those Marines reacted quickly and shot him down over the sea before he could target our ships."

Following the war, Hill would train at the California School of Fine Arts in San Francisco and study with noted photographer Ansel Adams. Between 1948 and 1986, Hill's professional photography career would thrive and earn him awards and notoriety. By 1989, he felt it was time to retire and return home to La Grande.

The feisty Hill, now 87, is still a well-known freelance photographer in Union County. His scenic outdoor photos, historical images and military history reprints are in demand and keep him busy. Much of his photo collection has appeared in 14 different books and he has produced hundreds of reprints for veterans. One battle in Hill's photonegative collection shows members of the Army's 503rd Parachute Infantry Regiment jumping into battle on the Philippine island of Corregidor.

Hill's letters to Martha were kept in a safe place and bound in white string for decades. "There's nothing too personal in there. It gives readers a different view than other accounts from that era," Hill said. "The 'blood and guts' war stories are always popular, but home-front accounts are also interesting."

# New "Wheelchair Only" Parking Rules Clarified

In the January/February edition of *VETS NEWS*, we reported on the passage of Senate Bill 716 (SB 716) in the 2007 Legislature. This bill calls for specifically marked "Wheelchair User" parking spaces and corresponding placards or decals for use of these spaces.

Now that the bill has been implemented, some clarification on the rules may be helpful.

Under SB 716, establishments that have over 100 parking spaces are required to have specific wheelchair user spaces. This does not increase the number of disabled-access spaces an establishment has. Rather, it simply changes the designation of some spaces previously labeled as "Van Accessible" to that of "Wheelchair User."

Persons who qualify for the Wheelchair User placard will be eligible to park in any disabled-access space, however the reverse is not true. Those who qualify for a regular disabled parking placard cannot park in designated wheelchair user spaces.

In order to legally use one of these spaces, a person who uses a wheelchair or similar

low-powered motorized or mechanically propelled vehicle designed specifically for use by a person with a physical disability must apply for and be granted the new light blue

placard with the words "Wheelchair User" printed on it. Persons currently eligible for family placards will also be eligible for the wheelchair user placards.

The application for Disabled Person Parking Permits has been redesigned in such a way that the medical authority signing the application must indicate whether the person qualifies for the new wheelchair placard or decal.

Those who currently have a disabled parking placard, and who feel they may be eligible for the wheelchair user permit and placard, will need to re-apply and obtain the signature of a medical authority specifying that the person qualifies. Applications for the new placard are available on the Oregon Department of Motor Vehicles (DMV) website at [www.oregondmv.com](http://www.oregondmv.com) and at DMV field offices.

## They Keep Serving - We'll Keep Sending

John Baker of Salem has developed and successfully maintained a program that is close to his heart. Known as 'Operation Love Boxes' (OLB), the effort has shipped thousands of boxes to Oregonians who currently serve in the U.S. military around the world. Forging ahead with the mission and the OLB motto, "They keep serving - We'll keep sending." Baker receives requests from all across the U.S. for his program to send boxes, but the primary focus is to reach out to fellow Oregonians.

During a January packing party, 254 domestic flat rate boxes were filled. Eighty percent of those packages were shipped directly to U.S. Army Sky Soldiers of the 173rd Airborne Brigade in Afghanistan. An additional 15 boxes included nine bread makers and numerous boxes of lasagna noodles. The unusual request came straight from retired U.S. Army CW3 Frank Eckrode, whose son is assigned with the 173rd.

Additionally, soldiers had requested extra socks and thermals. To say OLB is responsive is an understatement. Just a few weeks later Baker reported that some 800 pairs of wool socks worked perfectly for packing materials. Shortly thereafter, Baker reported to OLB supporters that all of the wool socks available in Willamette Valley Costco warehouses were bought for shipment.

## VA Expands its Reach in Southern Oregon

Uncle Sam is reaching out farther to veterans in Southern Oregon.

The U.S. Department of Veterans Affairs' Southern Oregon Rehabilitation Center and Clinics (SORCC) in White City opened a once-a-week extension clinic in Lakeview in December and is considering opening one in Grants Pass.

"We are trying to reach out to veterans who are geographically challenged to save them mileage and time," said SORCC spokeswoman Anna Diehl. "Sometimes all they need is a blood pressure check or a medication refill.

"We're really focusing on access," she added.

There are about 40,000 veterans in Southern Oregon, including about 1,000 in Lake County where Lakeview is the county seat.

SORCC, formerly called the VA Domiciliary, was established at the Army's Camp White following World War II. It is the central VA medical clinic for residents in far Southern Oregon and Northern California and currently has about 500 resident patients from more than 30 states. Its 400 employees also work with about 13,000 outpatients in the region.

SORCC already has an outpatient clinic in Klamath Falls. Its first extension clinic opened

in Lakeview on December 18 and drew 29 veterans on its first day. It's open from 10 a.m. to 2 p.m. each Tuesday at the Veterans of Foreign Wars Post in Lakeview.

Although the extension clinic is intended to provide primary and preventive care services such as blood draws and limited health screenings, it may be open longer on more days and offer more services if the demand warrants, said Max McIntosh, SORCC director.

"Veterans living in rural areas need to have more convenient access to their VA care," McIntosh said in a prepared statement. "There are a number of veterans rurally positioned that do not take advantage of VA care available to them, even though they need help, simply because of social, economic and geographic barriers."

A nurse, a nurse practitioner and a clerk now staff the Lakeview site. Veterans not enrolled in the VA health care system can pick up applications for care at the clinic.

Diehl said a proposal has been developed seeking to open a similar extension clinic in Grants Pass, with the hope that it would become a full-scale outpatient clinic "in a couple of years."

Whether that happens will depend on the availability of funding and other factors, she said.

"We want to expand to focus on access for veterans in rural areas," she said. "We're trying to bring health care to their doorstep."

## Veterans Earn Travel Reimbursements

An increase in travel mileage reimbursement went into effect February 1st for certain veterans that travel to VA medical facilities. VA Secretary Dr. James B. Peake was able to authorize this increase within the first 30 days of taking command of the U.S. Department of Veterans Affairs (VA). When announcing the increase Peake said, "This increase helps veterans — especially those living in rural areas — offset some of the gasoline costs as they travel to the VA for health care."

The reimbursement rate is the first increase in 30 years. New rates are now set at 28.5 cents per mile, up from 11 cents per mile. The maximum deductible amount is \$46.62, \$15.54 for round trip, and \$7.77 for one-way visits. VA will waive deductible amounts upon approval of financial hardship to the veteran.

## VA Extends Health Care Benefits

The period of eligibility for health care benefits has been extended for veterans who served in a theater of combat operations after November 11, 1998. Five years of health care is now available which includes cost-free health care services and nursing home care for conditions related to military service. New combat veterans are enrolled into Priority Group 6, unless eligible for enrollment in a higher rating group.

Dental care has also extended from 90 days to 180 days. Dental benefits are also available for service-connected disabled veterans who are participating in the Chapter 31 VA Vocational Rehabilitation program. VA also provides an eye examination and eyeglasses for recipients of the Purple Heart medal, former prisoners of war, and veterans receiving compensation for service-connected disabilities.

## Disabled Veterans and Spouses included in Economic Stimulus

In February, President Bush signed the 2008 Economic Stimulus package. Some individuals receiving certain veteran benefits will be receiving a cash rebate. In most cases, single veterans will receive up to \$600 and \$1,200 for married veterans. Overall, the package will put \$168 billion into the pockets of 128 million American households. Veterans with children will receive an additional amount of \$300 per child.

Reflecting on the impact to the veteran community, Director Jim Willis of the Oregon Department of Veterans' Affairs (ODVA) said, "Once again, veterans are reminded that their honorable service to our state and nation is not forgotten. Disabled veterans and families should know that economic relief is on the way." Disabled veterans and spouses who receive at least \$3,000 from any combination of Social Security and certain veterans' benefits will receive rebates. Contact the IRS at 1-800-829-1040 for information and to determine if you must file a 2007 tax return to receive a cash rebate.

## Bush Wants \$93.7 Billion for 2009 VA Budget

Honoring the nation's commitment to care for the newest generation of combat veterans and servicemembers from other conflicts and eras, Secretary of Veterans Affairs Dr. James B. Peake has announced that President Bush is seeking a \$93.7 billion budget in fiscal year 2009 for the U.S. Department of Veterans Affairs (VA).

If Congress accepts the White House's request, VA's budget would be \$3.4 billion more than the current spending level and nearly double the budget in effect when Bush took office in 2001. The proposal calls for \$47.2 billion in discretionary funding, mostly for health care. It also would provide \$46.4 billion in mandatory funding for compensation, pension, educational assistance, home loan guaranties and other benefit programs.

"This budget builds on VA's past successes in providing veterans with timely, accessible delivery of high-quality benefits and services earned through their sacrifice and service in defense of freedom," Peake said.

A high priority is being given to servicemembers returning from Iraq and Afghanistan with \$252 million being devoted to research projects focused specifically on these veterans. This includes research in traumatic brain injury, polytrauma, spinal cord injury, prosthetics, burn injury, pain, and post-deployment mental health. Other portions of the budget request include:

- \$41.2 billion for VA medical care, or \$2.3 billion more than the 2008 budget;

- \$1.3 billion to meet the health care needs of an estimated 330,000 veterans returned from service in Iraq and Afghanistan;
- \$3.9 billion for mental health services;
- \$762 million for non-institutional long term care; and
- \$1.5 billion for prosthetics and sensory aids
- The resources needed to eliminate VA's patient waiting list by the end of 2009.
- Disability compensation payments will be made to 234,000 more service-disabled veterans and their survivors in 2009;
- \$14 million increase in vocational rehabilitation and employment benefits for service-disabled veterans;
- \$46.4 billion in mandatory funding for compensation, pension, educational assistance, home loan guaranties and other benefit programs;
- More than \$2.4 billion for the Information Technology program, including \$93 million to support VA's cyber data security program;
- Expanded access, by 88 percent, to VA's burial program by increasing the number of veterans served by a national or state veterans cemetery located within 75 miles of their residence.

## Transferring Unused G.I. Bill Benefits

Beginning in November 2007, U.S. Army soldiers serving in certain Military Occupational Specialties (MOSs) as part of the Regular Army Active Component Selective Reenlistment Bonus (SRB) became eligible to transfer their GI Bill education benefits to spouses and dependents.

The U.S. Department of Veterans Affairs (VA) manages GI Bill education benefits and is responsible for all matters pertaining to payment for individuals applying for benefits under this program.

In his final State of the Union address in January, President Bush urged Congress to support U.S. servicemembers and veterans by, "expanding their access to child care, creating new hiring preferences for military spouses across the federal government, and allowing our troops to transfer their unused education benefits to their spouses or children."

Bush made the statement after praising the sacrifice of military families for America. Transfer of educational benefits to spouses and dependents is currently only available to Army servicemembers.



# Veterans Homecoming Gets a New Stage?

The Oregon Shakespeare Festival (OSF) in Ashland is hosting *Welcome Home Jenny Sutter*. The play is about an Iraq War veteran coming to grips with life outside war-torn Iraq, the loss of a leg, a sense of guilt and what her children will think of her disfigurement.

The “humor-filled and tenderhearted tribute” runs through June 20, at the Ashland theater before moving on to the New York-based Kennedy Center for a special engagement.

*Sutter*, a play written by Julia Marie Myatt, and directed by Jessica Thebus, is the story of Jenny Sutter, a U.S. Marine who loses a leg in an explosion and is sent home. The story deals with Jenny’s torment and uneasiness as she faces her new life, and children, with her injuries.

The play is a narrative of the conflicts veterans face when returning from war. Jenny takes refuge in a former military site in California called Slab City, a place where many rag-tag refugees of life have



come to live. She is befriended by two other Slab City residents, who knowingly or not, help Jenny deal with her situation and prepare her for the rest of her life in very different ways.

The tale of young women coming home from war is increasingly common.

According to U.S. Defense Department statistics, more than 180,000 women have served in combat support roles in Iraq and Afghanistan, many of them, single mothers.

What kind of statement is *Sutter* on our current

military conflict? Myatt admits it is hard to say. “It’s always important and challenging for artists to speak to the present cultural moment,” she says. “We don’t have much perspective yet.”

TRICARE Prime and Prime Remote beneficiaries can now manage their health care online. Beneficiaries can log on to the TRICARE Beneficiary Enrollment website to enroll, disenroll, update personal information and perform other procedures. The site also allows standard beneficiaries to add health care information and to enroll in Prime.

Enrollment forms are available on the website which may be printed off, completed

and mailed to a TRICARE regional office. Beneficiaries may also visit a TRICARE service center for assistance with other healthcare needs.

## Oregon to Celebrate 150 years in 2009

Not only is February 14th Valentine's Day, but it is also Oregon's birthday. Next year, the state will celebrate Oregon's Sesquicentennial—150 years of statehood.

The Oregon 150 Board of Directors continues to plan events for a nine-month birthday celebration. In January 2009, the celebration kicks off with the sale of the U.S. Postal Service's commemorative Oregon stamp.

The sesquicentennial will involve Oregonians from all walks of life. Some of the projects will include Take Care of Oregon Day, Oregon Stories, Travel Oregon 150, and Children's Future Vision. The project's vision is to appreciate the past, celebrate the present, imagine the future.

Honorary Chairman Governor Ted Kulongoski is asking all Oregonians to become involved and is encouraging communities and organizations throughout the state to plan their own sesquicentennial activities.

Everyone is invited to sign-up on the Oregon 150 guest list to stay current on sequicentennial information. History shows that the road to statehood followed a vote by the people of the Oregon Territory on November 9, 1857, which approved the State's Constitution. On February 14, 1859, the U.S. Congress voted to admit Oregon to the Union as the nation's 33rd state.

Prior to Oregon becoming a state, the Oregon Territory had seven governors—Joseph Lane was the first. Oregon's first governor John Whiteaker, served from March 3, 1859 until September 10, 1862.

## New Memorials to be Built

Two Oregon communities have begun work on constructing memorials to honor both Oregon's fallen and all military veterans.

A memorial at the Wallowa County Courthouse Square, located in Enterprise, will be a circle within a circle surrounding a fountain and an inner wall of honor that will hold 13 United States and the six service branch flags. Also, service branch seals will be engraved into granite located on the outer wall.

The county already has a site to remember local veterans that were killed in wartime, but the Fountain of Honor, in Enterprise will be different. "This fountain is to honor all of our local veterans," said Susan Roberts, a coordinator with VFW Post 4307 who is sponsoring the project.

"A World War II artillery piece is already in the square, which will be moved and incorporated into the project," Roberts said.

The project's two phases include planning and implementation, and then placing a bronze sculpture in the center. Roberts said the projected cost for phase one is \$40,000 with a completion date in the summer of 2009.



In addition to the two circular walls surrounding the statue, inscribed brick pavers will be sold and used for the walkways into the fountain area. In Central Point, officials are preparing to break ground on the Oregon Fallen Heroes Memorial this Memorial Day, May 26. This memorial will honor all Oregon servicemembers who died in battle from 1859 to the present and will be located next to the Central Point Cemetery. Memorial committee spokesperson Marty Terrell said the group must raise \$40,000 by May to receive a matching state grant.

"In order to take this project to the next phase, we will need the additional funds required to add six service branch flags and monuments, plus a U.S., POW-MIA and state flags," Terrell said.
