**Re:** 270/271 Business Requirements - 271 Desired Data from JAD Participants

**Date:** January 10, 2005

As stated in the final 270/271 Eligibility Inquiry and Response Business Requirement document, DHS agreed to the extent possible, to make every effort to accommodate the additional data elements identified by the JAD Participants. DHS also agreed to notify all parties when requests could not be supported and the reason why.

DHS recognizes the importance of the 271 Desired Data elements requested by the JAD participants, but due to limited staff resources and a definitive project end date, DHS can only supply data that is currently available from the OLGR and OLGX screens, excluding the requested Rate Group Code. The Rate Group Code will be returned on the 271 Response Transaction.

The following identifies the functionality and/or data that will not be supported at this time:

- Procedure specific eligibility requests and responses. This includes the reporting of vision services information (last vision exam and last eyeglasses dispensed) and dental services information such as date of last cleaning and date of last x-ray.
