FACTSHEET

VOTERS REQUIRING SPECIAL ASSISTANCE

ASSISTANCE AT THE POLLING PLACE

Any voter who requires assistance to vote by reason of physical, visual, hearing impairment or inability to read or write may be given assistance by a person of the voter's choice, other than the voter's employer, an agent of the voter's employer, or officer or agent of the voter's union (42 United States Code 1973aa-6).

Election Day Assistance at Polling Place for Voters with Disabilities

Polling places throughout the state are accessible to physically disabled voters. Voters who are unable to leave their vehicles to vote may use curbside voting services. Special parking for the handicapped is also available at most polling places.

For voters with visual disabilities, magnification devices are available for use by voters at the polling place.

Election Day Assistance at Polling Place for Voters with Limited English Proficiency

Voters who need language assistance should contact the chairperson or designated Voter Assistance Official assigned to the polling place.

DIRECT RECORDING ELECTRONIC (DRE) MACHINES AT POLLING PLACES

Pursuant to Section 301(a) of the Help America Vote Act of 2002, Direct Recording Electronic voting machines are available at polling places to:

- Ensure privacy and independence, and protect the right of voters with disabilities and voters with limited English proficiency.

- Provide accessibility for individuals with disabilities, including non-visual accessibility for the blind and visually impaired.
- Provide alternative language accessibility pursuant to the requirements of section 203 of the Voting Rights Act of 1965 (42 U.S.C. 1973aa-1a).

ADDITIONAL SERVICES

For Persons with Visual Disabilities

A taped message about voting in Hawaii is available at the Office of Elections and at the Library for the Blind and Physically Handicapped.

For Persons with Hearing or Speech Disabilities

For Persons with Limited English Proficiency

Oral assistance and/or written assistance are available for voters with difficulty understanding the English language.

In addition to the English language, the Wikiwiki Voter Registration Form and Application for Absentee Voter Ballot are also available in Ilocano, Japanese, and Chinese pursuant to the Voting Rights Act of 1965 as amended.

ABSENTEE VOTING

Any registered person may request an absentee ballot by mailing a completed Application for Absentee Voter Ballot to his or her city/county clerk. The application must be received by the clerk not earlier than sixty (60) days and not later than seven (7) days before an election (HRS § 15-4). The Clerk's office will mail an absentee ballot along with instructions upon receiving a request from the voter.
