## 3 Arrested in Florida for Securities Violations and Theft in Hawaii

HONOLULU-Attorney General Mark Bennett announced today that authorities in Florida have arrested Robert Byrch, Richard Morris and Robert Michutka, who were indicted by a Honolulu grand jury on May 25, 2006 for Securities Violations and Theft in the First Degree, related to the sale of promissory notes. Byrch was the president of 21<sup>st</sup> Century Satellite Communications, Inc., the Florida company which sold the notes. Morris and Michutka were involved in the sale of the notes in Hawaii. 21<sup>st</sup> Century Satellite Communications, Inc. has since filed for bankruptcy. In all, Hawaii investors lost over \$1,000,000. Nationwide investors lost over \$20,000,000. The Department of the Attorney General will seek to extradite all three men for prosecution in Hawaii. The Securities Violations carry a term of imprisonment of 20 years. Theft in the First Degree carries a maximum term of imprisonment of 10 years.

An indictment is merely an accusation and the defendants are presumed innocent until and unless they are proven guilty.



COUNT I: On or about the 1<sup>st</sup> day of October, 1998 to and including the 30<sup>th</sup> day of May, 2000 in the City and County of Honolulu, State of Hawaii, ROBERT BYRCH did intentionally, knowingly or recklessly sell or offer to sell in the State of Hawaii any security that had not been registered by notification or qualification as provided by Chapter 485 of the Hawaii Revised Statutes, to wit, 21<sup>st</sup> Century Satellite Communications, Inc. promissory notes, and the total value of all money and anything else of value paid by or lost by Marjorie Kubota, Emily Tahara, Michael Tahara, Shoichi Oya, Joan Oya, Masami Abe, Fae Carlson, Ira Chun, Yong Ye Fujimoto, Allan Iwamoto, Saiko Iwamoto, Herbert Kawamoto, Lillian Kawamoto, Carol Kondo, Ernie Kondo, Dennis Kunishige, Keikichi Kurashima, Elsie Kurashima, Clifford Kusunoki, Janette Kusunoki, Stacie Kusunoki, Lunalilo Dairy, Inc., Joseph Simpliciano, Dennis Sugimoto, Helen Tanaka, Kenneth Watanabe, Leslie Wong and Michiko Yahata pursuant to the same scheme, plan or representations, or to the same entity amounts to One Hundred Thousand Dollars (\$100,000) or more thereby committing the offense of Sale of Unregistered Securities in violation of Sections 485-8 and 485-21 of the Hawaii Revised Statutes.
