MASS MEDIA BUREAU PREPARED TO ISSUE MULTIPOINT DISTRIBUTION SERVICE BTA AUTHORIZATION

By the Mass Media Bureau:

On June 28, 1996, July 19, 1996, August 2, 1996, August 23, 1996, September 6, 1996, September 20, 1996, October 4, 1996, October 18, 1996, November 15, 1996, December 16, 1996, January 21, 1997, April 4, 1997, May 16, 1997, July 11, 1997, February 3, 1998, July 23, 1998, and December 9, 1998, the Mass Media Bureau issued public notices identifying the Basic Trading Area (BTA) authorizations for Multipoint Distribution Service (MDS) which the Bureau was prepared to issue. This public notice identifies an additional BTA authorization which is ready to be issued and provides details regarding final payment.

The applicant identified in the attached list must submit the balance due on the specified BTA authorization by **May 21, 1999**. The Mass Media Bureau will issue a BTA authorization and a conditional license to the applicant approximately ten business days following notification of receipt of full payment. *See* 47 C.F.R. §§ 21.955, 21.958, 21.960(b).

The payment must be made in U.S. dollars, must be in the form of a wire transfer or cashier's check, and must be made payable to the "Federal Communications Commission" or "FCC." No personal checks or other forms of payment will be accepted. The payment must be accompanied by a completed FCC Remittance Advice Form (FCC Form 159), and proper completion of this form is critical to ensuring correct credit of the applicant's payment.
