B. Brief description of the agency's response-time ranges.

During FY2003, the median processing time for all combined initial requests was 42 **calendar days**. Not all requests took 42 **calendar days** to process. Requests for readily available documents that involved little or no review were processed faster. Other requests took longer to process for a variety of reasons. Some requesters asked for a large volume of documents that had to be located, photocopied, and reviewed. USAID is an international organization that has many overseas offices. Delays in our response time occurred when documents had to be transported from the overseas offices to Washington. USAID received many requests for procurement-related documentation, especially for proposals. Such requests were often time-consuming and labor-intensive because they involved repeated discussions with contractors and grantees concerning the competitive ramifications of releasing the requested information.

C. Brief description of why some requests are not granted

USAID sometimes was required to withhold requested information under one or more of the FOIA's exemptions. The numbers of instances in which USAID used an exemption in FY2003 are listed in Section V.B.3. Exemptions 3 and/or 4 normally were used to protect commercial or financial information provided by contractors and grantees. Exemption 5 was used to protect vital deliberative-process information or attorney-client information. Exemption 6 was used to protect the privacy of individuals named in documents. At times, a request was not fulfilled for an administrative reason. The various types of administrative reasons are listed in Section V.B.4.

- B. Basic terms, expressed in common terminology.
- 1. **FOI/PA request** -- Freedom of Information Act/Privacy Act request. A FOIA request is generally a request for access to records concerning a third party, an organization, or a particular topic of interest. A Privacy Act request is a request for records concerning oneself; such requests are also treated as FOIA requests. (All requests for access to records, regardless of which law is cited by the requester, are included in this report.)
- 2. **Initial Request** -- a request to a federal agency for access to records under the Freedom of Information Act.
- 3. **Appeal** -- a request to a federal agency asking that it review at a higher administrative level a full denial or partial denial of access to records under the Freedom of Information Act, or any other FOIA determination such as a matter pertaining to fees.
- 4. **Processed Request or Appeal** -- a request or appeal for which an agency has taken a final action on the request or the appeal in all respects.
- 5. **Multi-track processing** -- a system in which simple requests requiring relatively minimal review are placed in one processing track and more voluminous and complex requests are placed in one or more other tracks. Requests in each track are processed on a first-in/first-out basis. A requester who has an urgent need for records may request expedited processing (see below).
- 6. **Expedited processing** -- an agency will process a FOIA request on an expedited basis when a requester has shown an exceptional need or urgency for the records which warrants prioritization of his or her request over other requests that were made earlier.

- 7. **Simple request** -- a FOIA request that an agency using multi-track processing places in its fastest (nonexpedited) track based on the volume and/or simplicity of records requested.
- 8. **Complex request** -- a FOIA request that an agency using multi-track processing places in a slower track based on the volume and/or complexity of records requested.
- 9. **Grant** -- an agency decision to disclose all records in full in response to a FOIA request.
- 10. **Partial grant** -- an agency decision to disclose a record in part in response to a FOIA request, deleting information determined to be exempt under one or more of the FOIA's exemptions; or a decision to disclose some records in their entireties, but to withhold others in whole or in part.
- 11. **Denial** -- an agency decision not to release any part of a record or records in response to a FOIA request because all the information in the requested records is determined by the agency to be exempt under one or more of the FOIA's exemptions, or for some procedural reason (such as because no record is located in response to a FOIA request).
- 12. **Time limits** -- the time period in the Freedom of Information Act for an agency to respond to a FOIA request (ordinarily 20 working days from proper receipt of a "perfected" FOIA request).
- 13. "Perfected" request -- a FOIA request for records which adequately described the records sought, which has been received by the FOIA office of the agency or agency component in possession of the records, and for which there is no remaining question about the payment of applicable fees.
- 14. **Exemption 3 statute** -- a separate federal statute prohibiting the disclosure of a certain type of information and authorizing its withholding under FOIA subsection (b)(3).
- 15. **Median number** -- the middle, not average, number. For example, of 3, 7, and 14, the median number is 7.

16. **Average number** -- the number obtained by dividing the sum of a group of numbers by the quantity of numbers in the group. For example of 3, 7, and 14, the average number is 8.

VIII. Comparison with Previous Year(s) (Optional):

During FY2002, the median number of **calendar days** needed to process all requests was 52 **calendar days**. In FY2003, the median number of calendar days needed to process all requests was 42 **calendar days**. This is a decrease of 19.2%.

In FY 2002, 212 requests were received. In FY 2003, 324 requests were received. This is an increase of 35%.

In FY 2002, 222 requests were processed. In FY 2003, 240 requests were processed. This is an increase of 7.5%.

In FY 2003, 2 requests for expedited processing were received. Two requests for expedited processing were granted.

Improvements in FOIA Program:

USAID established a FOIA e-mail mailbox so that requesters can send in their requests electronically. This approach makes the submittal of requests easier and less-costly, speeds up the initial administrative processing of requests, and fosters more spontaneity and freer communications.
