1/ Beginning with the 1998 CPI revision, indexes for San Francisco-Oakland-San Jose are no longer published on a monthly basis but on a bi-monthly basis. The Seattle-Tacoma indexes will no longer be published exclusively semi-annually after December 1997. Beginning with January 1998 data, both of these urban areas will be published bi-monthly on even months only (Feb, April, June, Aug, Oct, and Dec). The next CPI All Items indexes for San Francisco and Seattle will be for August 1999 and released on Sept. 15, 1999.
