

This report covers USCIS Customer Service Web Portal (CSWP) Web metrics and related analysis for September 2008. Highlights in this report:


Overall Traffic Volume Continued at Usual Levels

Page View and User Session metrics continued at levels consistent with those of the past several months. (See page 2).




► Distribution of Traffic Continued at Expected Levels

Numbers for the past two months have leveled off and may indicate a trend, although it is too early to tell. (See page 8).





USCIS.gov Traffic Compared to Federal Sites


The charts below report traffic to the USCIS.gov site over the past three months, compared to that of other federal sites* according to Alexa.com. The "Reach" scale refers to the percentage of unique users of the Alexa toolbar who visited a site on a given day.

► Notable changes this month: None, except to note FEMA's spike due to September's hurricanes. Traffic to USCIS.gov continues to put it in the top 10 most visited federal web sites.

USCIS.gov Compared to Leading Federal Web Sites




* The first chart compares USCIS traffic to that of DHS and a few key DHS agencies. The second chart compares USCIS traffic to a rotating sample of the 7-8 federal Web sites that get more traffic than USCIS – including USPS, NIH, Education, CDC, NASA, and IRS – as well as other well-known federal sites.

Distribution of Traffic by Major Content Area

User sessions that involve visits to the major landing pages of the site indicate where users concentrate their attention during those sessions. About half of visitors to the major landing pages continue to view the Immigration Forms page during their visits to USCIS.gov. ► Notable changes this month: None. The distribution and volume of traffic to the seven landing pages is consistent with levels over the past several months.



GovDelivery Subscription E-mail System

E-mail volumes often fluctuate from month to month as the need to change content on the site dictates. As of October 1, 2008, there were over 209,000 active subscribers to at least one CSWP page.

▶ Notable changes this month: More than 940,000 E-mail notifications were sent this month to those who subscribe to CSWP pages, a 40 percent decrease from last month. The average number of subscriptions per user jumped from 2.6 to 3.4. The reported click-through rate, down to 7.3 percent from 12 percent last month, is inaccurate due to a partial loss of click-through data by the GovDelivery organization.

Top 50 Search Terms Entered into the CSWP Search Engine

The top search terms entered into the CSWP's internal search engine present a useful picture of what is most important to CSWP visitors. This data can help drive site design decisions for making the most requested information easy to find. (Usability testing across a wide range of Web sites shows that about half of Internet visitors prefer to use a site's search engine to find what they want, while the other half prefers to use a site's navigation links to find the same information.)

► Notable changes this month: None. Searches for I-9, I-130, and other immigration forms continue to be very popular, accounting for about half of the top 50 search terms entered.



Page Surveys as Partial Measure of User Satisfaction

Many pages on USCIS.gov contain a short survey that provides users the option to rate the usefulness of the page's information. Results from these surveys, though not statistically reliable, provide insight into user satisfaction and suggest that further data gathering may be useful to understand the reasons why certain ratings were given.

► Notable changes this month: Ratings for Contact Us continue to be lowest among the six pages that triggered the most survey responses, with 60 percent of responses for "Not Useful." The average ratings across all six most-surveyed pages were:

- Useful 43.7 percent
- Slightly Useful 8.1 percent
- Don't Know 9.5 percent
- Not Useful 38.7 percent
