



In response to your telephone call of last week, we are faxing herewith all pertinent information pertaining to the Crazy Ribbon/Crazy String Product. To summarize what we know at this point:

1. On May 15, 1999, our client, LISA GARCIA, client purchased cans of Crazy Ribbon and Crazy String from the Retailer, One Stop Party and Rental, (Owner, Glen Elder) 16761 Valley Blvd, #A, Fontana, California, 92335. Telephone: 909-356-5611; Telefax (909) 356-2787.

- 2. On May 15, 1999, JAMES ANDREW GARCIA, a minor, suffered severe burns on his face when the Crazy Ribbon/Crazy String Product ignited, when it was sprayed after he blew out the candles on his birthday cake.
- 3. After the little boy was injured, our office forwarded a letter to the Retailer, placing them on Notice of the injury, and requesting information. In response, owner Glen Elder, specifically advised that he purchased the products from Ken Chang at Stelex Corporation, in downtown Los Angeles. Stelex' address is: 1282 Factory Place, Los Angeles, California. Telephone: 213-527-1992. Telefax: 213-627-8618.
- 4. Glen Elder advised the undersigned that he filled out credit applications with Stelex when he purchased three or four cases of the product from Stelex. He also stated that Ken Chang at Stelex told him that he was the exclusive importer of the products, and that he had an exclusive contract with the manufacturer in Taiwan, Top Grease Industrial Company, Ltd., to sell the products in Southern California. Elder further stated that he purchased the products under the name of a subsidiary company, named "Party Wholesalers". He further advised that he would provide the undersigned with a copy of his invoice, showing his purchase of the products from Stelex. However, despite our repeated requests, Elder has failed to provide the supporting documentation.
- 5. According to Glen Elder, Ken Chang at Stelex also told him that although there were some problems with the products before, the product had been reformulated, and that it was now safe to use.
- 6. In response to our correspondence to Stelex Corporation, on or about May 26, 1999, Stelex' Attorney, Albert J.C. Chang, sent our firm a letter, denying Stelex' involvement with Crazy Ribbon, and denying sale of any product from Stelex to One Stop Party and Rental. We faxed this letter to Glen Elder, who stated that Stelex and their lawyers were not being truthful, and that he did, in fact, purchase the products from Stelex and Kenneth Chang.
- 7. On or about June 4, 1999, Albert J.C. Chang provided the undersigned with contact information for firms believed by Stelex to be selling the Crazy Ribbon/Crazy String products, as well as contact information for the product manufacturer, Top Grease Industrial Company. In response to our letters to all listed companies, several of the companies contacted us, and denied importing or selling the products. They also advised that Stelex Corporation was the exclusive distributor of the product, and advised that Stelex' lawyer had sent letters to YB Toys Inc. and other importers, alleging that Stelex had exclusive rights to these products, and threatening to sue anyone who imported or distributed them.


- 8. We also did a Trademark Search, which shows that Stelex owns the Crazy String Trademark, and that Albert, J.C. Chang is the Attorney of Record.
- 9. Both Stelex and One Stop Party and Rental have refused to provide any additional information concerning the products, and have failed to provide information regarding liability insurance carriers. Stelex, through Mr. Chang, has failed to comply with our request to identify the chemical ingredients of the products.
- 10. The manufacturer, Top Grease Industrial Company, has failed to respond to our correspondence.

I hope that the foregoing will assist the CPSC in its investigation of the Crazy Ribbon/Crazy String Products. Could you please keep me advised of the status of the investigation, or have the appropriate persons who are handling this investigation keep me informed. I would also request, under the Freedom of Information Act, that your office provide me with all documents pertaining to this investigation, including reports, test results, correspondence, recall information, etc.

We are running up against a wall in our efforts to locate all responsible parties, and the governments' assistance will be greatly appreciated by our client, who has been disfigured for life, as a result of these hazardous products. If I can provide any additional information to assist with your investigation, please let me know.



This firm represents JAMES ANDREW GARCIA, a minor, who suffered serious burns on his face and arms on May 15, 1999, when cans of foam spray string manufactured in Taiwan, labeled "Crazy Ribbon" and "Happy String" were sprayed near his birthday cake at his parents' home in Fontana, California After the boy blew the candles out, other children sprayed the string, and his head caught on fire. The incident was reported through the Consumer Product Safety Commission hotline, pursuant to instructions from Mr. Ken Giles. I was informed that a rush has been placed on the investigation, since this product appears to be similar to Happy String and other flammable foam spray products recalled by the Commission, which are banned hazardous substances.

In reviewing the compliance file for the product known as "Happy String", I noticed that you worked extensively on the product testing and recall effort. Could you please advise as to the procedure for having the Crazy Ribbon/Crazy String products which caused my client's injuries tested. I have the products in my possession, and would like to submit them to the Commission for testing, but am unaware of the procedure. I have an independent laboratory prepared to do the testing, but I do not want to compromise the samples, and I would prefer to have the products tested by the government lab.

Could you please advise me as to how best to proceed? Thank you for your prompt attention to this matter. Your immediately reply by telephone or facsimile would be appreciated.
