This guidance document assists eligible entities in applying for Brownfields Job Training Grants. The application deadline for proposals is September 16, 2005. These Grant funds are available to eligible entities with environmental job training projects to facilitate assessment, remediation, or preparation of brownfield sites. Eligible entities must propose to serve a community that currently receives, or has received, financial assistance from EPA for brownfields assessment, revolving loan fund or cleanup competitive grants.
