For Qualified Zone Academy Bonds, \$2.4 billion is distributed to States based on Title I Basic Grant shares. School Construction Bonds provide \$22.4 billion using a multi-stage formula. First, \$400 million is set-aside for Bureau of Indian Affairs schools. Second, from the remaining funds, 40 percent is distributed to the 125 LEAs with the largest number of children in poverty based on their Title I Basic Grant shares (\$8.2 billion to the largest 100 and \$600 million to the next 25). Third, the remaining 60 percent of funds are distributed to States, including Puerto Rico, based on population ages 5-17 (outlying areas, however, receive funds in proportion to their share of the population in poverty).
