# **House Approves Mandatory NIH Public Access Policy**

With House passage in late July of the Labor, Health & Human Services Appropriations, journal publishers lost the first round in a battle over whether Congress should require final peer-reviewed manuscripts of articles written by NIH-funded researchers for publication in scientific journals to be submitted to the National Library of Medicine and made freely available online through the PubMedCentral website. The legislative battle is not over, however, and publishers were successful in identifying and articulating the serious copyright and economic implications for journal publishing business models.

The current NIH Public Access Policy with respect to articles written by its grant-funded researchers has been based on voluntary submission for subsequent online availability within 12 months of publication in a peer-reviewed journal. The bill passed by the House would make such submission mandatory. Opposition to mandatory submission, which had focused on the potential adverse impact on the peer-review process, investments and business models of journal publishers, has now re-focused on its potential impact on U.S. copyright policy in both the domestic and the global marketplace, an issue that has gained the attention of the bipartisan leadership of the House and Senate Judiciary Committees. Although House Appropriations Committee Chairman David Obev (D-WI) refused to delete the mandatory language that

had been added at the subcommittee level, he did acknowledge the concerns raised by the bipartisan leadership of the House Judiciary Committee and its Intellectual Property Subcommittee by adding language requiring NIH to implement its public access policy "in a manner consistent with copyright law."

That language, which is in line with the version of the appropriations bill approved by the Senate Appropriations Committee, does not resolve the issue. Journal publishers maintain that mandatory submission of the final peer-reviewed manuscript cannot be implemented "consistent with copyright law" because of its adverse impact on journal publishers' copyright interests in the version of the manuscript published as a journal article.

The legislation as approved by the Senate Appropriations Committee is not expected to reach the Senate floor until after the summer recess. The fight over mandatory submission is not over in the Senate and will undoubtedly resume after Labor Day.

# AAP President Meets with Senators on Pre-K Issues

AAP President & CEO Pat Schroeder participated in a discussion on pre-K issues with Senators Robert Casey (D-PA) and Hillary Clinton (D-NY) on July 25. The senators discussed bills they have introduced that focus on pre-K. This issue is moving to the forefront of the agenda in many states, as evidenced by the 29 governors who mentioned pre-K in their State of the State addresses this year (as opposed to only 11 governors who mentioned it three years ago). New York has just approved \$146 million in funding for pre-K

for 44,000 youngsters; other states are also moving funding bills. The senators are pushing pre-K funding at the federal level as well. Research was presented showing the importance of early learning to individual success later in life as well as its benefits to the public-- for every dollar spent on early learning, seven dollars is saved by the public later. Both senators are open to meeting with publishers on these issues. Senator Casey was a 5th grade teacher and Senator Clinton welcomes contact with publishers. AAP will continue to monitor these bills.

### Senate Passes FOIA Reform Bill

Prior to leaving for the August recess, on August 3 the Senate passed sweeping bipartisan legislation to streamline the operation of the Freedom of Information Act (FOIA) and increase government transparency. The Open Government Act of 2007 (S.849), co-sponsored by Senate Judiciary Committee Chairman Patrick Leahy (D-VT) and Committee member John Cornyn (R-TX) represents the first FOIA reforms in more than a decade. The bill restores meaningful deadlines for agency action on FOIA requests and imposes real consequences for federal agencies that miss the FOIA's 20-day statutory deadline. The bill also clarifies that FOIA applies to government records held by outside private contractors, establishes an FOIA hotline service for all federal agencies, and creates an FOIA Ombudsman to mediate agency level disputes and provide an alternative to costly litigation. Through the Open the Government.org coalition, AAP has been lobbying for FOIA reforms and joined a host of organizations, including the Society of Professional Journalists and the American Library Association, in sending a letter on

August 3 to Senators Leahy and Cornyn thanking them for their leadership and urging them to stand firm against attempts to water down the reform provisions.

# **Legislation Introduced to Curb NSL Abuses**

Bi-partisan legislation was introduced in the House on July 26 that would provide safeguards against abuse of the National Security Letter authority granted under the USA Patriot Act. Co-sponsored by Representatives Jerry Nadler (D-NY), Jeff Flake (R-AZ), Ron Paul (R-TX) and William Delahunt (D-MA), the "National Security Letters Reform Act" would address many of the abuses detailed in a report issued last spring by the Inspector General of the Justice Department. Specifically, the legislation would:

- give NSL recipients the right to challenge the letter and the accompanying gag order;
- Place a time limit on the gag order (which can be extended on court order);
- Notify the target of the NSL if the government seeks to use the records obtained in subsequent legal proceedings;
- Allow the subject of the NSL to receive legal counsel and challenge use of the records

# Copyright Alliance, Unions Urge Congress to Protect U.S. Jobs

The Copyright Alliance—which includes AAP among its members—joined with seven guilds and unions, including the International Brotherhood of Teamsters and the Screen Actors Guild, in sending a letter to the House and Senate Leadership on July 2 emphasizing the importance of copyright in creating and sustaining high-paying U.S. jobs, and underscoring the threat to those jobs posed by rampant copyright piracy.

Pointing out that "11.3 million U.S. workers are employed in [the U.S. copyright industries] from film and television artists, to software engineers, to graphic designers, and set carpenters," the letter states that "...rampant copyright theft directly threatens both the continued strength of the U.S. creative industries and the employment they provide," and calls upon Congress to consider and pursue policies "that will better protect the creative works produced by the men and women of the U.S. copyright industries."

### AAP Brief Urges Dismissal of Red Hat Club Defamation Suit

On July 30 AAP filed a brief asking the Georgia State Court of Appeals to dismiss a defamation suit against St. Martin's Press and one of its authors, Haywood Smith, by a woman claiming to be the model for a character in Ms. Smith's novel. The Red Hat Club. The plaintiff claims that the novel's depiction of the character's drinking and sexual escapades defames her. A Georgia trial court, in an extremely troubling and misguided ruling, failed to dismiss the case, finding there to be factual issues to be determined at trial. Pointing out that many fictional characters are "based on" real people the author has known, the AAP brief argues that it is not enough for the plaintiff to claim to have been defamed by the depiction of a fictional character who is

"based upon" and bears some similarities to herself. She must show that
a reasonable reader would believe
the character and the plaintiff to be
one in the same, and would confuse
the actions of the fictional character
with those of the plaintiff. The brief
points out that when a judge fails
to dismiss a case in the absence of
such a showing, there is a profound
chilling effect on the free speech
rights of authors and publishers.

# AAP Voices Opposition to New York "Dead Celebrities" Bill

In a letter to leaders of the New York State Senate and Assembly, AAP voiced concern and opposition to legislation making its way through the state legislature that would give to the heirs of anyone who has died since 1938 the power to control all uses of their image, signature, and voice and would criminalize the unauthorized use of such images. The legislation, which is being pushed by celebrities including Al Pacino and Yoko Ono, fails to exempt expressive works, and would "invite litigation that would interfere with lawful, non-commercial expression." In addition, the letter pointed out, the legislation's failure to preclude retroactive application would "wreak havoc on publishers," who would find themselves liable for works that have already been published. "The repercussions of such an open-ended right would be disastrous," the letter states. AAP urged that the legislature not take action during this session and move slowly and carefully to allow for "a full vetting of the public policy implications of such legislation." The legislature adjourned in July without taking action on the bill, but it is expected to be reintroduced in the next session

# Supreme Court Denies *Cert*. in Harvest House Case

As the current term drew to a close at the end of June, the U.S. Supreme Court refused to review a ruling by the Texas Court of Appeals dismissing a libel suit against Harvest House Publishers brought by a group called The Local Church. The Supreme Court's denial of the petition effectively ends a six year legal assault in which The Local Church claimed their inclusion in The Encyclopedia of Cults and New Religions, published by Harvest House, was defamatory because of general comments regarding cults in the book's introduction and appendix. AAP took the lead last fall in a friendof-the-court brief supporting Harvest House, citing the Local Church's long history of using libel litigation to silence criticism (see Monthly Report September/October 2006).

# The Campaign Rolls On

The Get Caught Reading campaign continues to grow, with new celebrity endorsements including LL Cool J, John Lithgow, Yoda of *Star Wars* and Emma Roberts as *Nancy Drew*. The campaign has gone international, with people across the globe embracing the Get Caught Reading brand of literacy activism.

In cooperation with IMG Tennis, AAP has enlisted the support of U.S. tennis star Nicole Vaidisova in the Get Caught Reading campaign, featured reading Mitch Albom's bestselling *Tuesdays with Morrie*. With her regular "book report" contribution to *Smash Tennis Magazine* and her reputation for traveling the circuit with a tennis bag full of books, Vaidisova is already known as a book lover. She will serve as the inaugural spokesperson representing tennis on the Get Caught Reading literacy trail, joining athletes from Major League Baseball and the National Basketball Association in the campaign. PSAs and an editorial have been featured in the *Orlando Sun Sentinel* and the WTA Tour Newsletter.

# New PRISM Coalition Will Inform Public About Risks of Government Interference in Scholarly Communication

A new initiative announced August 23 will bring together like minded scholarly societies, publishers, researchers and other professionals in an effort to safeguard the scientific and medical peer-review process and educate the public about the risks of proposed government interference with the scholarly communication process.

The Partnership for Research Integrity in Science and Medicine (PRISM) is a coalition launched with developmental support from AAP/PSP to alert Congress to the unintended consequences of government interference in scientific and scholarly publishing.

The group has launched a website at http://www.prismcoalition.org, where it articulates the PRISM Principles, an affirmation of publishers' contribution to science, research, and peer review, and an expression

of support for continued private sector efforts to expand access to scientific information.

The PRISM website includes factual information and reasoned commentary designed to educate citizens and policy makers, to dispel inaccuracies and counter the rhetorical excesses indulged in by some advocates of open access, who believe that no one should have to pay for information that is peer reviewed at the expense of non-profit and commercial publishers.

# AAP Welcomes Passage of Copyright Legislation in Hong Kong

AAP welcomed passage in Hong Kong in late June of the Copyright Amendment Bill of 2006. Since 2001, a Hong Kong-based coalition of foreign and local publishers has worked with Hong Kong authorities, opposition groups, and Legislative Council members to press book publishers' concerns on issues including the absence of criminal penalties for possession of infringing books and other publications, exceptions to copyright protection, fair dealing, online infringement, and other potential threats to the interests of publishers and other rightsholders.

AAP assisted this group by providing extensive legal analysis and drafting assistance for industry submissions, and through lobbying efforts during AAP visits to Hong Kong. STM, IPA, IFRRO and other international groups weighed in during the process as well. Patricia Judd, AAP's director of international copyright enforcement pointed out that as a result of these collaborative efforts, the publishing community was able to make significant gains, but she stressed that work remains to be done.

### AAP Raids Hit Malaysia Copyshops

AAP, in collaboration with local authorities, raided four photocopy shops in Malaysia near the Melaka Campus of Multimedia University in late June, resulting in the seizure of 452 infringing copies and five photocopy machines and the arrest of all of the shop owners. The publishers whose works were infringed, all of whom are AAP members, are cooperating in the ongoing investigation.

# **AAP Supports U.S. Government in Seeking WTO Dispute Settlement Panel**

AAP voiced its support for action taken in mid-August by the Office of the U.S. Trade Representative in requesting that the World Trade Organization establish a dispute settlement panel to help resolve issues arising from China's failure to adequately protect intellectual property rights. The request for a dispute settlement panel is the next step in the U.S. Government's WTO case against China initiated in April (see Monthly Report March/April 2007), and was taken after formal consultations failed to produce a resolution. The WTO Dispute Settlement Body will consider the U.S. request for a panel at its next meeting, scheduled for August 31.

Responding to the August 15 announcement that safety concerns had prompted the recall of more than 9 million toys from the U.S. market--the third such recall in recent months— AAP pointed to the continuing importance of books in the lives of children. "Perhaps the publicity concerning lead-based paint and design flaws in a host of popular toys presents us with a 'teachable moment'," said AAP President & CEO Pat Schroeder. "As parents and grandparents, we need to be reminded from time to time that the best stimulus for a child's imagination, the most memorable moments of childhood pleasure, lie between the covers of a book. We hope that some of those recalled toys are replaced with books—a board book, a picture book, a chapter book, a poetry book—that parents can read with their young children and encourage older kids to read on their own."
