The following change is made to the above numbered contract for Lake Pontchartrain, LA and Vicinity, Floodproofing Veterans Blvd. Bridges over 17th Street Canal, Orleans and Jefferson Parishes, LA, to change the pile type for the temporary widened eastbound bridge from 14" diameter steel pipe pile to steel HP14x73 pile at 60 feet long, and to add the requirement for halting driving operations when ground velocities reach or exceed 0.5 inches per second.

CHANGES TO THE BIDDING SCHEDULE: There is no change to the bidding schedule.

CHANGES TO THE CONTRACT SPECIFICATIONS:

a. Add three sentences to Section 01100 Paragraph 19 Vibration Monitoring. as follows:

"The contractor will be directed to halt pile driving operations (including temporary, service, and sheetpiles) when ground velocities, monitored by a independent testing laboratory, reach or exceed 0.5 inches per second. During extraction of temporary and existing piles, the contractor will be directed to extract the piles by jetting when the velocities reach or exceed 0.5 inches per second. Payment for all standby costs associated with cessation of pile driving operations and jetting of piles below the dredgeline while extracting, if required, will be made by an equitable adjustment under CC I-87, Changes.

b. Add a new paragraph to Section 02315 as follows:

"7.2.5 Any damage to HP 14x73 piling due to use for temporary bridge piling will be replaced and compensated at the applicable price per linear foot for "Furnish and Deliver Steel H-Piles"."

CHANGES TO THE CONTRACT DRAWINGS: Make pen and ink changes to Johnson Bros. drawings no. 4609-11 thru 13, dated 10-26-95, and 4609-15 thru 18, dated 11-16-95 as follows:

Change all references to the use of "14 inch O.D. x .312 inch wall pipe piles driven to 70 ton capacity, from the LADOTD Structural Pile Handbook, 1988: 28 blows per foot using a Vulcan 512 hammer = 70.7 ton capacity" to "Steel HP14x73 piles - 60 feet long to be driven to grade without the use of jetting."

CHANGES TO THE CONTRACT PRICE: The contract price remains unchanged.

CHANGES TO THE CONTRACT TIME: The contract time remains unchanged.

It is further understood and agreed that this adjustment constitutes compensation in full on behalf of the contractor, its subcontractors and suppliers for all costs and markups directly or indirectly attributable to the changes ordered, for all delays, impacts and extended overhead related thereto, and for performance of the change within the time frame stated.
