



# Affidavit of Provision of Room and Board by U.S. Provider

## University of North Texas International Studies and Programs

To demonstrate the ability to provide room and board for a student applying to the University of North Texas and/or the UNT Intensive English Language Institute, follow these steps:

1. Complete and submit the affirmation on this Affidavit of Provision of Room and Board
2. Submit proof of financial resources:
  - a. Affidavit of Support, U.S. Government Form I-134 - MUST BE NOTARIZED.
  - b. Letter of current employment or a copy of the previous year's U.S. Income Tax form W-2
  - c. F-1 visa holders must show financial documentation equal to current I-20 expenses for their own I-20 liabilities, plus \$2000 toward food for the student
3. Attach a copy of the lease or the deed to the property where the student will be housed. The lease or deed must be in the U.S. Provider's name.

If approved, this Affidavit of Provision of Room and Board by a U.S. Provider will substitute for the amount of required funds on the I-20 form for the student's housing and food. The reduced amount of required funds on the I-20 will include only "school costs" and "other expenses".
