Calendar Year Out-of-Pocket Maximums

Out-of-pocket coinsurance maximums, inpatient copayment maximums and deductibles (non-network benefits and out-of-area only) are accumulated on a calendar year basis. This means that beginning January 1 of every year, participants are required to pay for coinsurance, inpatient copayments and possibly a deductible. Even if the out-of-pocket maximums and/or deductibles are not met until the latter part of the previous year, no amounts are carried over.

Insurance Eligible Graduate Students

New insurance eligible graduate students hired for the Spring semester have until April 28th to enroll in the HealthSelect health insurance program. If enrollment is not completed by that date, the next opportunity to apply through the medical insurability process would be during summer enrollment (generally a portion of July and August). Coverage is not guaranteed after April 28th.

Dependent Care Reimbursement Account Tax Form 2441 Filing

If you contributed to a TexFlex Dependent Care Reimbursement Account during the 2007 calendar year, you must file an IRS Form 2441 with your Federal Income Tax Return. For more information visit www.irs.gov or you may call 1-800-829-1040.

No Loans or Withdrawals from TRS or ORP while Employed

State law governing the Teacher Retirement System and the Optional Retirement Program prohibits employees from withdrawing or borrowing against TRS or ORP funds. You cannot withdraw funds from your TRS or ORP account until termination of employment or retirement.

Earned Income Tax Credit?

Families with two or more qualifying children may qualify for an EIC refund if their total 2008 annual earned income is less than \$38,646 (\$41,646 if married filing jointly.)

Families with one child may qualify for an EIC refund if their total 2008 annual earned income is less than \$33,995 (\$36,995 if married filing jointly).

Families with no qualifying children may be eligible for an EIC refund but are not eligible to claim advance EIC payments.

Advance EIC payments are available to employees who meet the requirements set out on the 2008 Form W-5. These advance payments allow you to receive a portion of the refund in equal amounts on your paychecks. The Form W-5 and instructions are available in the Payroll Office located in Marquis Hall, Room 127.

Employees who are not eligible to receive advance EIC payments may claim the refund when they file their tax return for the year.

Employees who may be eligible for the EIC refund for 2007 should refer to the back of Copy B of their 2007 W-2 Form or to their tax filing instruction booklet for eligibility requirements for 2007.
