  - c. F-1 visa holders must show financial documentation equal to curent I-20 expenses for their own I-20 liabilities, plus \$2000 toward food for the student
- 3. Attach a copy of the lease or the deed to the property where the student will be housed. The lease or deed must be in the U.S. Provider's name.

If approved, this Affidavit of Provision of Room and Board by a U.S. Provider will substitute for the amount of required funds on the I-20 form for the student's housing and food. The reduced amount of required funds on the I-20 will include only "school costs" and "other expenses".
