The entire campus is busy preparing for the graduation of the class of 2004. This year, TCOM will graduate 116 physicians in the DO program, and 26 Physician Assistants in the PASP. The largest classes yet, in both programs. In addition, this year we return to the Tarrant County Convention Center Arena, for the first time since the early 1980s. The change from Will Rogers Auditorium is due to the size of our graduating classes in all three schools. Graduation begins promptly at 2pm on Saturday, May 15th. Graduates need to be there at 1pm! I wish all of our graduates much luck and success in your chosen careers; and ask each of you to always remember your alma mater, which has helped you achieve your dreams and aspirations!

On April 15th, I participated with the AOA and AACOM's DO Day on the Hill in Washington, DC. Students and Faculty from TCOM were joined by physicians and auxiliary members from the Texas Osteopathic Medicine Association (TOMA). Our Texas delegation of over 50 joined representatives from all across the country adding to a total presence of greater than 1,100! Our group met with representatives of Senator John Cornyn, Senator Kay Bailey Hutchinson, Representative Kay Granger, and Representative Michael Burgess, MD offices. We expressed our concerns principally over 2 issues that impact all physicians and medical students, Malpractice Liability Insurance reform, and the reauthorization of the Higher education Act, which assures low interest guaranteed loans for professional students through Title IV. All these offices shared our concern, and will focus on these issues. We are fortunate to have legislators who are very supportive of the issues that impact both our students and practicing physicians. Malpractice Insurance reform has already passed the house, however it is not thought it can get through the Senate with the close party numbers.

Texas House Members Upset More Doctors Not Getting Relief House lawmakers sent a stern message to insurance companies Thursday:

Medical malpractice lawsuit reforms passed last year were meant to help doctors, not boost profits. Republicans and Democrats who supported the legislation suggested lawmakers might consider mandatory rate rollbacks if doctors don't get significant rate relief soon.

Lawmakers nearly approved a rate rollback last year but stopped short when insurance companies promised reductions. "Some of us put ourselves way out on the line for our doctors," said Rep. Joe Nixon, R-Houston, author of the bill and constitutional amendment that allows a cap on jury awards and limits insurance companies' liability. "Profits for (the companies) is not what we intended." Nixon, chairman of the House Civil Practices Committee, said the changes were designed to lower premiums for doctors, many of whom said skyrocketing premiums force them to shutter their practice or leave the state. The committee met Thursday to get an update on the impact of the changes and invited testimony from Texas Insurance Commissioner Jose Montemayor, who took the brunt of lawmakers' concerns. Insurance companies did not testify.

In the seven months since voters approved Proposition 12, the Texas Medical Liability Trust is the only major carrier to agree to reduce rates. Others have tried to raise rates. About 60 percent of Texas doctors have not seen a rate decrease, the commissioner said. Montemayor came under tough questioning about a letter he sent to committee members in March 2003 that estimated rate reductions of up to 19 percent if the legislation passed. But Montemayor said he didn't promise a rate rollback. He said it was an estimate of what doctors might save compared to what they might have paid if costs kept going up. Montemayor said he considered it a victory if doctors' rates remained stable. Committee members said they expected immediate, significant reductions. "Promises were made," said Rep. Patrick Rose, D-Dripping Springs. "Those promises were not kept." Rose sponsored the mandatory 25 percent rate rollback that was stripped out of the bills last year. Committee members said it could be considered again next year if doctors don't get relief. "We could have come down with some significant hammer, but we didn't," said Rep. Dan Gattis, R-Georgetown. "We are watching."

Tom Banning, spokesman for the Texas Academy of Family Physicians, which represents about 5,500 doctors, called the reforms a "tremendous shot in the arm for the morale of physicians around the state. "For some, it's clearly a benefit," Banning said. "Others are still struggling." Montemayor predicted reductions will come. Companies who wanted to raise rates - Montemayor has refused to allow it - tried to cover a spike in lawsuits filed before the law changed in September. The filing of new cases has dropped sharply since then, he said. "Time is on our side," Montemayor said. Two new carriers are writing policies in Texas and several others want in, Montemayor said. But most of the new companies want to participate in an unregulated sector of the market. The state would have no control of their rates. One company already writing policies, GE Medical Protective, which covers about 7,000 doctors, wants to move to the unregulated market with an average rate increase of about 10 percent. Montemayor believes he has the authority to keep the company from making the switch. Nixon said he welcomed the arrival of new companies but told Montemayor "we don't want people doing an

end run around authority." Montemayor said he's confident that market competition will drive down rates. The new providers will have to attract doctors, he said.

Health Policy News:

Herman Testifies, Visits Members of Congress on Health Professions Funding

James M. Herman, M.D., M.S.P.H., chair of the Department of Family and Community Medicine at the Pennsylvania State University College of Medicine (a former colleague of mine) and Project Director of the Pennsylvania Area Health Education Center (AHEC), testified April 27 before the House Subcommittee on Labor, Health and Human Services and Education Appropriations on behalf of the Health Professions and Nursing Education Coalition (HPNEC). Dr. Herman also participated in a Health Professions Capitol Hill Day April 28, where 20 health professionals and students visited with over 30 Congressional offices regarding FY 2005 funding for the Title VII and VIII health professions and nursing programs.

AAMC Submits Statement On FY 2005 HHS Funding

The AAMC April 29 submitted a statement for the record to the House Labor, Health and Human Services and Education Appropriations Subcommittee on FY 2005 funding for the Department of Health and Human Services. The Association's statement outlines its funding recommendations for the National Institutes of Health, the Title VII and VIII health professions education programs, the Agency for Healthcare Research and Quality, the National Health Service Corps, and the Council on Graduate Medical Education.

House Members Call on President To Revise Stem Cell Policy

A bipartisan coalition of more than 200 Members of the House of Representatives sent a letter April 28 urging President Bush to "expand the current policy concerning embryonic stem cell research." The letter, signed by 206 House members, was released at a press briefing on Capitol Hill. The letter, organized by Reps. Mark Castle (R-Del.), Diana DeGette (D-Colo.), Randy "Duke" Cunningham (R-Calif.), and Calvin Dooley (D-Calif.), calls for the Administration to relax the current restrictions on federal support for embryonic stem cell research.

Budget Stalemate Continues

The budget process once again was thrown into limbo April 28 when House GOP leaders rejected a proposed compromise on required offsets for tax cuts. The conference agreement on the FY 2005 budget resolution (S.Con.Res. 95) has been delayed because the House refuses to go along with Senate language that would subject new tax cuts and mandatory spending increases to a 60-vote point of order in the Senate unless they are offset by other revenue increases or spending cuts.

VA Research "Dear Colleague" Attracts 31 Signatures

An April 22 "Dear Colleague" letter to appropriators on behalf of the Department of Veterans Affairs medical and prosthetic research program attracted the signatures of 31 Senators. Organized by Senators Jim Bunning (R-Ky.) and Bob Graham (D-Fla.) the letter was addressed to Senate VA-HUD Appropriations Subcommittee Chairman Christopher Bond (R-Mo.) and Ranking Member Barbara Mikulski (D-Md.) and urged appropriators to "demonstrate this nation's commitment to its veterans* by providing a needed increase" in the FY 2005 appropriation for the program.

CMS Announces New "75% Rule"

CMS published the long-awaited 75% Rule today, April 30, 2004. PPSV will be analyzing the rule and there will be a comprehensive review in next week's Weekly Washington Wire. The 75% rule can be viewed by <u>clicking here</u>.

CBO Estimates US Spending on Drug Reimportation

In a report released today, April 30, 2004, the Congressional Budget Office (CBO) finds that allowing the reimportation of prescription drugs from foreign would reduce total drug spending by \$40 billion over the next 10 years. The CBO states that this represents only 1% of total drug spending and thus, a modest savings. However, the cost of reimportation legislation is averaged to be about \$58 million. Medicare Drug Website Launched

On Thursday, April 29, 2004, CMS activated the prescription drug comparison tool on the Medicare website, allowing consumers to compare savings with different drug discount cards. As a result of the new Medicare Law passed in December, 2003, Medicare beneficiaries can begin purchasing the drug discount cards Monday, May 3, 2004, and use them in the interim between June 1, 2004 and 2006, when the Medicare prescription benefit is set to begin.
