

POLICY ON THE USE OF AIRPORT PARKS GROUP CAMPING SHELTER

1. Reservations for the use of the Group Shelters may be made 360 days in advance of arrival by calling the National Recreation Reservation Service (NRRS) at 1-877-444-6777 or through their website at www.reserveUSA.com. Also reservations can be taken at the gate house.
2. **GOLDEN AGE OR GOLDEN ACCESS PASSPORT DISCOUNTS DO NOT APPLY TOWARD THE RENTAL OF THE GROUP SHELTERS.**
3. The “official” rental period begins at 2:00 p.m. on the first day of the reservation and ends at 2:00 pm on the last day. You may check in early **ONLY** if the previous renters have vacated the site. Additionally, the site may not be occupied unless we have a signed group shelter policy on file. A signed copy of the policy letter **MUST** be mailed to the Waco Lake project office **prior** to your arrival at the campground. **The name of the person on the reservation must be the same as person who signs the group shelter policy.**
4. The open shelter includes 8 campsites, six with water/electric/sewage and two with water/electric only. The shelter accommodates up to 80 guests with a 35 vehicle parking lot. All vehicles and recreational equipment with wheels (including cookers) are required to remain in designated parking areas at all times. Parking and operation of vehicles off developed roadways and/or parking areas is strictly prohibited. A citation may be issued to anyone parking in an undeveloped or undesignated area.
5. The Group Shelter, facilities and grounds will be left in a clean, sanitary condition. The individual reserving the Group Shelter will be responsible for its condition when the group leaves. All trash must be disposed of in an approved container or removed from the park. **Should the Group Shelter be left without being cleaned and/or in an unsanitary condition, a citation may be issued to the responsible individual (the person who reserved the shelter) and could result in a fine and/or appearance before the U.S. Magistrate.**
6. Quiet hours will be observed throughout the park between 10:00 pm and 6:00am. Noises which will unreasonable annoy other campers are prohibited at any time. **NO AMPLIFIED MUSIC IS ALLOWED.**
7. The group will be responsible for any damages/vandalism to the Group Shelter facilities. No alterations of Group Shelter facilities and/or components are allowed. A citation will be issued to the responsible individual (the person who reserves the shelter) should any damages/vandalism occur.
8. The entrance gates at all parks will be closed at 10:00pm and opened at 6:00am. Vehicles will not be allowed to enter the park during this time.
9. This Group Shelter was designed to accommodate a specific number of recreational vehicles (excluding tow vehicles). All unoccupied RV sites may be used for passenger vehicle parking. All parking must be in a designated parking space. No parking will be allowed on the grass or on road shoulders. Anyone parking on the grass, road shoulder, or in violation of posted restrictions will receive a citation. Other designated parking areas are located in the park. **To insure that there is adequate parking for your group, please consult the lake office before signing and returning this policy.**
10. **THE GOVERNMENT IS NOT RESPONSIBLE FOR PROVIDING ADDITIONAL FACILITIES OVER AND ABOVE THAT WHICH PRESENTLY EXIST AT THE GROUP FACILITY.**
11. Bar-B-Q Pits are to be used with wood or charcoal only. No trash, cans, and/or bottles are to be placed in them. Fires may be built only in the Bar-B-Q pits and not on/in the ground. Only Bar-B-Q pits having totally enclosed fire boxes may be brought onto lake property. The cutting or gathering of trees is

prohibited. The gathering of dead wood on the ground is permitted. Wood is not supplied at the Group Shelter.

12. Any signs placed by the reserving group anywhere on lake property (poles, stakes, etc.) must be removed by the individual responsible for reserving the Group Shelter before leaving on the day of departure. If the signs are not removed upon your departure, a citation may be issued to the person reserving the shelter.
13. On holiday weekends, the Group Shelter must be rented for at least two consecutive days. A Group Shelter that has not been reserved within two weeks of the holiday weekend can be reserved one day.
14. Any activities beyond routine use of the group facility, which require more than minimal Corps participation, or convey significant benefits to an identifiable recipient or recipients beyond those afforded the general public, may require an additional permit. Any such activities must be approved in advance by the Lake Manager.
15. The Corps of Engineers reserves the right to refuse future reservations to groups who violate the Group Shelter Policy and/or who have in the past failed to abide by project regulations. Groups not abiding by the terms of this policy may be required to leave the site immediately and forfeit all fees.
16. By signing and returning this policy to the Corps of Engineers, **YOU AGREE TO BE RESPONSIBLE FOR THE GROUP SHELTER AND GROUNDS.** **The name of the person on the reservation must be the same as person who signs the group shelter policy.** Failure to sign or return a copy prior to arrival may result in the cancellation of your reservation. Users of the facilities are subject to the Code of Federal Regulations, Title 36, and the Group Shelter Policy. Violators will be subject to receiving a citation.
17. A complete set of rules and regulations, Title 36, may be obtained from a Gate Attendant, Park Ranger, or the Visitor Center. If you have any questions about the facility contact the Waco Lake Project office @ (254)756-5359.
