This document provides a description of the technical enhancements to the EDEN Submission System (ESS) version 3.7 released November 11, 2007. Later updates made in late December 2007 are also included in this document.

Revisions to the document include system changes that were implemented in subsequent System Change Requests (SCRs).

EDEN is a centralized, coordinated repository of state reported, K through 12, educational data residing at the U.S. Department of Education. The EDEN Submission System is an electronic system that facilitates the efficient and timely transmission of data from SEAs to the U.S. Department of Education.

1.0 PURPOSE

The purpose of this document is to educate the users of the EDEN Submission System about the improvements that have been made to the system and to provide guidance to users on issues that they may encounter with the new software release.

This document lists all system enhancements and documentation updates that were implemented with the ESS Release 3.7. The majority of the enhancements include support for ongoing enhancements and maintenance of the ESS.

Where applicable, items are prefixed with corresponding trouble ticket information. For example, "TT 233" refers to the trouble ticket opened by the software development team. "PSC 05-00367" refers to the ticket number opened by the Partner Support Center.

2.0 SUMMARY OF IMPROVEMENTS (RELEASE 3.7)

2.1 ESS Application Updates

ESS Release 3.7 (November 9, 2007) includes the following new system functionality:

- 1) TT 1862; PSC 07-44690: The system was changed to disable Submission edits S089-R10, S002-R10, S002-R11, S002-R12, S002-R13, and S002-R14.
- 2) TT 1871; PSC 07-44407: The system was changed to disable the validation edit for N/X006 - Child w Disab Susp Expul for SY 2006-07 that compared the subtotal to detail. The file specification was updated to remove reference to unduplicated.
- 3) TT 1872; PSC 07-44675: The system was changed to disable the validation edit for N/X005 - Child w Disab Removal for SY 2006-07 that compared the grand total to the detail.
- 4) TT 2039; PSC 07-44651

The system was changed so that the following business edits produce a warning vs. an error: S005-R08, S009-03, S009-R04, S009-R05, S009-R06, S009-R07, and S089-R08.
- 5) TT 1885; PSC 07-45039: The system was changed to allow the State Agency Reviewer role to view data in the Submission Progress Report.
- 6) TT 1886; PSC 07-44720: The system was changed to remove the association between file specification N054 - Migrant Students Served at the SEA level and the CCD extract.
