PREFACE

This document provides a description of the technical enhancements to the EDEN Submission System (ESS) version 2.2 that was released in March 2006.

Revisions to the document include system changes that were implemented in subsequent System Change Requests (SCRs).

EDEN is a centralized, coordinated repository of state reported, K-12, educational data residing at the U.S. Department of Education. The EDEN Submission System is an electronic system that facilitates the efficient and timely transmission of data from SEAs to the U.S. Department of Education.

1.0 PURPOSE

The purpose of this document is to educate the users of the EDEN Submission System about the improvements that have been made to the system and to provide guidance to users on issues that they may encounter with the new software release.

2.0 SUMMARY OF IMPROVEMENTS (RELEASE 2.2)

2.1 ESS Application Updates

ESS Release 2.2 includes the following new system functionality:

- 1) <u>CSPR Part II</u>: The CSPR Online Submission Tool was modified to allow users to access questions to support the entire lifecycle of CSPR Part II. Additional functionality included in this release includes:
 - Added a new CSPR report that allows the ED (Review/View User) user to report, per state, which questions have been answered versus left blank. The purpose of this report is to provide visibility into incomplete CSPRs and encourage POCs to provide ongoing support to the States to complete the CSPR.
 - Navigation capabilities that allows users to select a page from a drop down list.
 - The system displays the State name corresponding to the user that is logged in.
 - Note: The CSPR Online Submission Tool *does not* calculate percentages nor does it edit data for the correct percentage. The CSPR *does* provide validity checks for percentages greater than 100% (warning) and percentages greater than 999% (error).
- 2) Data Framework fixes:
 - Update Code for "13/PostGraduate" to show correct code value ... was showing "12/PostGraduate".
 - The Definition for AYP Status for the 2003-2005 Reporting Periods was changed to read: "An indication of whether the state, district, or school met the Adequate Yearly Progress (AYP) requirements for the school year, as determined by the state-established criteria." (06-00110)
 - Remove File Specs from the Data Framework and PBDMI website. Civil Rights file specifications N/X011 – N/X026 for the 2003-2004 and 2004-2005 school years were removed because the data is not required for collection. The file specifications were replaced with new documents that explain that the file specification is no longer needed. (06-01100)
 - When clicking on the Current Version button while retrieving file specifications from the Data Framework, currently the new browser window that gets

opened is not re-sizable. This has been changed to allow the user to re-size the window to personal preference. (06-00414)

3) Other fixes:

- Corrected a problem on the Submission Status Report where the report displayed multiple entries for the same file. (06-00581)
- Corrected a problem that displayed duplicate data on the Transmission Status Report, Submission Status Report and Educational Unit Profile. The issue affected the 05-06 Children with Disabilities files. (06-01015)
- Improved error handling for Directory submissions. A validation error is now returned when a Directory file is submitted that is missing the Operational Status field in each record.
- When submitting XML Directory/Grades Offered files, occasionally an error gets thrown that the educational units in the Grades Offered portion of the file are invalid because they are getting processed prior to the corresponding Directory file. This has been corrected. (05-00601)
- When selecting "See Data" or "Show Replacements" from the Transmittal Status Report screen, a non-resizeable pop-up window appears. In most cases, the data are wider than this window so it must be scrolled to see all the columns. This has been changed to allow the user to re-size the window to personal preference.
- Corrected a problem where the Educational Environment codes for Public Separate Facility and Private Separate Facility for the 05-06 reporting period were incorrectly being accepted. The change limits the valid values to: Public Separate School (PUBSS) and Private Separate School (PRIVSS).
- Changes have been made to ensure consistency in the look and feel of Search Buttons in the EDEN User Interface.

3.0 SUMMARY OF IMPROVEMENTS (RELEASE 2.2A)

ESS Release 2.2a includes the following new system functionality:

- 1) Updates were implemented to support the EDFacts reporting system. The database was updated to support report distribution. The changes included implementing two tables to the system for temporary use until the EDFacts system is brought completely on-line and made available to State users. The two tables are used to provide Cognos e-mail bursting functionality to enable automated report distribution to the States. This was implemented as a workaround after the decision was made to withhold State access to the EDFacts reporting system.
- 2) Corrected a problem that caused file to hang during submission. (06-01509)

4.0 SUMMARY OF IMPROVEMENTS (RELEASE 2.2B)

ESS Release 2.2b includes the following new system functionality:

- 1) Corrected a problem in the CSPR section 2.7.1 that prevented data from being displayed after the data was entered and saved. (06-01591)
- Corrected a formatting problem in the CSPR screen and PDF for questions 2.3.1.3.1 and 2.3.1.3.2. Row 3 (Continuation of Service) - Column 1 (Ages 0-2) is grayed out. Row 1 (Served in MEP) - Column 1 (Ages 0-2) is not grayed-out. (06-01532)
- 3) Corrected the CSPR PDF to eliminate incorrect HTML characters from showing up when apostrophes are used (').
- 4) Corrected a spelling error in the CSPR Completeness Review Report to change "1.4.2.2 Title I District Accountability" to "1.4.2.2 Title I District Accountability".
- 5) Corrected a problem in the Data Framework that caused a server error when the reset button was clicked. (06-01313)
- 6) Update the Data Framework to remove all reference to Data Group 623 LEP Accommodations. This Data Group will not be collected for the 2005-2006 school year.
- 7) Corrected a server error that occurred when viewing school level Status Current Year data for the 2003-2004 school year. (06-01588)

5.0 SUMMARY OF IMPROVEMENTS (RELEASE 2.2C)

ESS Release 2.2c includes the following new system functionality:

- 1) Removed duplicate category codes for Age/Grade (Migrant) category (05/06 school year).
- 2) Fixed the Transmittal Status Report to show validation errors properly.
- 3) CSPR Changes:
 - Fixed Question 2.1.3.2. The Grade 5-Local Neglected Cell was incorrectly populating the Grade 5-Total Cell.
 - Fixed Question 2.7.1. The system was adding a semi-colon to the end of the entered value for column "Targets" 2005-2006.
 - Fixed instructions for question 2.3.1.3.1. In the paragraph beginning with "Referred Services", the first sentence ends "...received areferred service.", skipping a space in between "a" and "referred". The sentence should end "...received a referred service.").
 - Fixed Question 2.7.1 to strip out all HTML from submitted data.
 - Updated the comments field to allow ampersands. (06-01571)
 - Added pscScriptModifyTable stored procedure to EDENDB, EDENQ and CSPR to allow replication of metadata.

6.0 SUMMARY OF IMPROVEMENTS (RELEASE 2.2D)

ESS Release 2.2d includes the following new system functionality:

1) Changed the pscScriptModifyTable stored procedure in EDENDB, EDENQ and CSPR to allow replication of metadata.

7.0 SUMMARY OF IMPROVEMENTS (RELEASE 2.2E)

ESS Release 2.2e includes the following new system functionality and documentation updates:

1) Fixed the VersionCSPR stored procedure to correctly copy the duplicateSeqNumber value and the respText value.

- 2) Corrected an issue that caused the Comment to be dropped from the CSPR 2.3.1.5.1 PDF.
- 3) Corrected an error that occurred when attempting to download the Transmittal Status Report to Excel. (06-01571)
- 4) Fixed the logic that checks for duplicate NCES IDs. (06-01801)
- 5) Corrected Directory update logic to use both the State ID Number (with or without leading zeros) and the NCES ID when determining whether to update the Directory record. If both values match, then the Directory record is updated.
- 6) Changed the pscScriptModifyTable to update last modified date field.
- 7) Modified the system to display 2005-2006 as the default school year value in all drop-down boxes.
- 8) Corrected an issue that prevented the transfer of multiple binary files when submitted in succession.

- 3) Changed the fnGetDirStatus function and the spFileProcessErrors stored procedure to implement a validation check to ensure that a school exists in the Directory when submitting School Level Grades Offered files for 05-06. [06-02140]

9.0 SUMMARY OF IMPROVEMENTS (RELEASE 2.2G)

ESS Release 2.2g includes the following new system functionality:

- 1) Changed parameter on the database server to mitigate the recent issues with the execution of DTS packages on the database server.
- 2) Fixed directory stored procedure to gracefully handle format errors generated during Directory file submissions. [06-02187]
- 3) Grades Offered file was accepted for schools that did not exist (fixed directory stored procedure to validate against this). [06-02140]
- 4) Insert/Update records in StateEmailAddress table as requested by PSC.
- 5) Remove/Reassign Schools/LEAs for NC [06-00153]

10.0 SUMMARY OF IMPROVEMENTS (RELEASE 2.2H)

ESS Release 2.2h includes the following new system functionality and documentation updates:

- 1) Insert/Update records in StateEmailAddress table as requested by PSC.
- 2) Updated Directory information for Iowa. Reassigned some School IDs and some LEA IDs. [06-02211]
- 3) Fixed valid category codes for Educational Environment (IDEA) for N002. PUBRF and PRIVRF are now accepted. Also, fixed metric error validation stored procedures -- were not taking into account reporting period when determining if a category code was valid or not. [06-02392]
- 4) Fixed how NOTCOLLECT error validation works (will not allow missing/not collect AND a value to be used for the same Education Unit AND Category Code Set)
