





We continually track various statistical data pertaining to safety. This data is used as an indication of both frequency and severity of accidents. Recent information shows an improvement in both areas. However, we still need to jointly reemphasize safety. I believe that having a safe worksite is not only a contract requirement, but should be important to you for both moral and financial reasons.

Many contractors have implemented an outstanding safety program, and have diligently complied with Corps of Engineers safety guidelines. If you are one of those, you are to be congratulated. However, some contractors fail to place adequate emphasis on safety, especially as required by the Corps' Safety Manual, EM 385-1-1, dtd Oct 92.

All personnel representing the New Orleans Area Office are responsible to monitor and assure jobsite safety. However, the major responsibility for a safe work environment lies with your personnel. I believe that safety must be stressed from the top and then implemented throughout the organization.

New Orleans Area Office's personnel have been instructed to follow these guidelines:

- a. Corps inspectors will diligently conduct daily safety inspections of the job site and minor violations will be pointed out to contractor personnel. Contractors will be given a period of time in which the violations must be corrected. Discovery of a serious violation may result in the inspector ordering the contractor to cease work immediately until the violation is corrected.
- b. Should the contractor fail to take corrective action in a timely manner, or if frequent violations occur, a LMV Form 218, Contract Deficiency Notice, will be issued.
- c. If a contractor's approach to safety is considered less than adequate, additional steps may be taken, i.e., removal of personnel and/or unsatisfactory ratings.

We should strive for job sites which do not have unsafe conditions and continually educate personnel and have our supervisors be on guard for and stop unsafe acts. I request that you support us by assuring that safety problems never pass the notice and correction stage.

Our combined commitment to safety will result in the safest possible work sites.

The following responsibilities have been delegated to Government inspection personnel with regard to enforcement of the provisions of your contract:

- a. GENERAL RESPONSIBILITY GOVERNMENT INSPECTORS
- 1. Government inspectors will inspect contract operations for safety compliance at the same time and in the same manner as required for compliance with other terms of the contract.
- 2. The Government inspector will call the attention of the foreman to any violations of safe practices and will request that the unsafe condition be corrected.
- 3. If the foreman fails to correct the condition after being given a reasonable opportunity to do so, the Government inspector will immediately discuss the matter with his supervisor. With the concurrence of the supervisor, the Government inspector will then require the foreman to suspend the operation until the unsafe condition noted is corrected.

b. ACTION OF INSPECTORS IN CASES OF IMMEDIATE HAZARD

- 1. Whenever any Government inspector observes a condition, work practice or act involving immediate hazard to workers, equipment, materials, or structures, or a work condition is being performed at the risk of life or limb, the Government inspector will immediately require the foreman or other contractor's representative to remove workers immediately from the area of danger, or otherwise desist from the dangerous operation or practice.
- 2. In case the foreman is not at the site of the dangerous condition or operation, the Government inspector will order the workers to remove themselves from the dangerous location and to cease the hazardous operation.
- 3. The Government inspector will see that the work is not resumed in the area of danger and that further use of defective equipment, tools, or other facilities is not made until recommendations for correction are fully complied with.
- 4. The Government inspector will make an immediate report of any cessation of a dangerous operation to his immediate superiors.
- 5. The Government inspector will then follow the same procedure as outlined in paragraph (a) preceding in obtaining immediate corrective action by the contractor for, in the event of a refusal by the contractor to take corrective action, for a suspension of work in the contract by the Area Engineer.

Under the authorities for enforcement delegated to the inspection personnel, the decision of such personnel and/or the undersigned in such matters will be conclusive, except that you are not denied the right of appeal. You are reminded that the primary responsibility for accident prevention is yours, and in that regard, I expect all the provisions and requirements of CONTRACT CLAUSE I.79 - ACCIDENT PREVENTION and SPECIAL CLAUSE H-10 - SAFETY PROVISIONS to be strictly complied with on this project.

I started the meeting by introducing myself as the Administrative Contracting Officer. I advised you that all correspondence relative to the contract should be addressed to me at the New Orleans Area Office.

After further introductions, I asked Mr. Kenyon to give a general overview on how you plan to proceed with the work. Mr. Kenyon stated that the initial construction will be to start on the east side between Filmore Avenue and Pumping Station No. 3. He stated the existing sheet piling will be cut off in this area and the new concrete cap constructed. He stated that this is the only area they could work while the new sheet piling is being ordered and manufactured. After work in this area is completed, he added that construction will then proceed from Mirabeau Avenue on the west side to Robert E. Lee Boulevard and finally back to the east side to finish work on that side of the canal. Prior to actual construction begins, he stated the office trailers will be set up and some initial site preparation done including clearing of the existing levee.

Mr. Dennis Duhon then reviewed the special clauses dealing with the utility owners. He stated that as (SC) H-22 and H-32 specifies, the contractor shall notify each utility owner by certified mail no sooner than 90 days, but at least 45 days prior to the date the utility will be affected, and provide the Contracting Officer a copy of these notifications.

Mr. Duhon then discussed the preconstruction surveys of residences and vibration monitoring that will be conducted by the Orleans Levee Board. Mr. Mineo explained the intention for the vibration monitoring and that any action to be taken if any will be directed by the Government.

The next utility discussed was the Sewerage and Water Board feeder lines. Mr. Duhon stated that four lines will have to be relocated to accommodate construction and that a coordination meeting will be held with the interested parties after all submittals are approved.

At this point, the aerial telephone conduits and underground cables that cross London Avenue Canal were then discussed. Mr. Duhon stated that the sheet piling will be installed in segments on the west bank under TC-1 and the underground cables will be abandoned by South Central Bell prior to driving sheet piling. Mr. Lear, NOPSI representative, stated that the cables are not yet abandoned but would be in the next couple of weeks. Mr. Lear then stated that a coordination meeting should be held with you after the office trailers are set up.

Mr. Duhon then discussed the removal of the pedestrian bridges and concrete steps and the requirements of the Traffic Control Plan including access and detour routes. He stated that coordination with the Department of Streets will be required and then the written plan must be submitted to

us for approval. Mr. Webb stated that you are responsible for any damage and repairs to the streets due to negligence on your part. Mr. Kenyon then stated that videos will be taken of the access routes prior to and at the end of the work to verify any possible damage that may occur.

After a short break was taken, I began the second portion of the pre-construction conference by addressing the authority of government personnel. I explained that I was the Administrative Contracting Officer, and only the Contracting Officer, who is Raymond Burgess and I have the authority to direct changes to the contract. I emphasized that neither the inspector, project engineer, supervisor, other district personnel, nor any local, state, or other federal agency have the authority to direct changes to the contract. I advised you to immediately notify me of any instructions that you receive by my staff or others that you consider to be a change to the contract requirements.

I then explained that Contract Clause I.83, entitled "CHANGES", provided that the Government could make changes to the work within the general scope of the contract. When a change is directed an equitable adjustment in contract time and price will be made (when there is an increase or decrease in the contractor's cost or time of performance) and the contract will be modified in writing. This will be accomplished by execution of Standard Form 30, "Amendment of Solicitation/Modification of Contract." I also pointed out that if you receive any written or oral order from the Contracting Officer or the Administrative Contracting Officer that you consider a change to the contract requirements, you must give written notice that you consider such orders a change within 30 days of receipt of the order.

I also pointed out to you that in accordance with Contract Clause I.69, entitled "Differing Site Conditions", you must, before conditions are disturbed, provide written notice to me of differing site conditions. The clause requires that there be (1) subsurface or latent physical conditions at the site which differ materially from those indicated in the contract or (2) unknown physical conditions at the site, of an unusual nature, which differ materially from those ordinarily encountered and generally recognized as inherent in work of the character provided for in the contract. I also informed you that if any additional borings or other investigations are conducted to notify the project engineer or myself so our Foundations and Material office can send a representative to witness these investigations.

At this time, I explained the Government's actions regarding the "Performance Evaluation of Contractor" for the contract. I explained that you would receive an informal evaluation 90 days after the start of work, a final evaluation at the end of the contract and interim evaluations as deemed necessary. I stated that you would be rated either outstanding, satisfactory, or unsatisfactory in the areas of Quality of Work, Timely

Performance, Effectiveness of Management, Compliance with Labor Standards, and Compliance with Safety Standards, as outlined on LMV Form 665-R, a copy of which was provided to you. I further stated that you will be advised of any unsatisfactory rating, either in an individual element or in the overall rating, prior to completing the evaluation, and all contractor comments will be made a part of the official records. I also stated that Performance Evaluation Reports will be available to all DOD Contracting Offices for their future use in determining contractor responsibility.

I then summarized the following goals of partnering that the Corps of Engineers intends to promote with its local sponsors, contractors, and other state and federal agencies:

Complete the project in on schedule within budget.

2. Develop and maintain good community relations by minimizing impact to the community.

3. Develop and maintain awareness of safety.

4. Establish a forthright approach to modifications and claims in order to avoid litigation.

5. Contractor has the opportunity to make a reasonable profit and enhance reputation and public perception of the project.

The following SPECIAL CLAUSES were then discussed:

- a. H-4 CONTRACTOR QUALITY CONTROL (CQC), Mr. Wagner emphasized the use of the three-phase control inspection system, documentation of quality control activities on reports, correcting deficiencies, the requirement for holding a preconstruction mutual understanding meeting prior to the start of work, the completion inspection punchlist, and that you have not yet submitted the Quality Control Plan for approval.
- b. H-10 SAFETY PROVISIONS, Mr. Duhon stated that the Accident Prevention Plan is approved upon the insertion of some comments made on the plan, a Pre-work Safety Conference shall be held, all equipment shall be inspected for safety, and a safety sign shall be provided on the jobsite.

c. H-14 SUBMITTALS

d. H-20 TIME EXTENSIONS FOR UNUSUALLY SEVERE WEATHER, I explained to you the new procedures for determining time extensions for unusually severe weather.

 $\mbox{Mr.}$ Duhon continued with discussion of the CONTRACT CLAUSES and highlighted the following:

a. I-61 PAYMENTS UNDER FIXED-PRICE CONSTRUCTION CONTRACTS

b. I-64 PROMPT PAYMENT FOR CONSTRUCTION CONTRACTS, it was explained that all information required for prompt payment must be included in a proper invoice with a certification of payment to subcontractors and suppliers.

I then issued you a letter stating that your Accident Prevention Plan was approved upon resubmittal. I also issued you letters on Layout of Work, Inspector's Responsibility, and Safety Awareness.

The Notice to Proceed was issued at this meeting.

The meeting was adjourned at approximately 11 a.m.

- 1. The Preconstruction Safety Conference for the above project was held on 28 September 94 at 0900 hrs. The contractor, B & K Construction Company, Inc. was represented by Mr. Boone Kenyon, President, Mr. Mike Tassin, Project Superintendent, and Mr. Mike Commiskey, CQC Manager. The Government was represented by Mr. Chris Wagner, Project Engineer, and Mr. Zane Bryant, Project Inspector.
- 2. The meeting began with Mr. Wagner stating that the purpose of the meeting was to assure that the job is performed in the safest way possible and to prevent accidents from occurring. To fulfill this, the contractor's workers will be made aware of the safety provisions of the contract specifications, the contractor's Accident Prevention Plan, and the Government's Safety Manual EM 385-1-1, dated October 1992, as well as what the Government considers to be unsafe acts.
- 3. The first item discussed was SPECIAL CLAUSE H-10, SAFETY PROVISIONS, in the contract. I asked Mr. Tassin if he had copies of EM 385-1-1, dated October 1992, and Mr. Tassin stated he did. I then informed Mr. Tassin and Mr. Commiskey that the manual referenced all of the procedures concerning safety, in particular, Section 01.D ACCIDENT REPORTING AND RECORD KEEPING, paragraph 01.D.01 of the Government's safety manual and H-10 (a) which states that accidents shall be investigated by the immediate supervisor of the employee and reported to the Contracting Officer or his representative within one working day after the accident occurs. A followup report shall be submitted when the estimated lost time days differs from actual lost time days.
- 4. I informed the contractor's representatives that he shall perform a daily inspection of the jobsite and/or equipment to assure that all safety requirements are being fulfilled. The inspection reports shall be maintained at the jobsite in accordance with H-4 (j) and documentation shall be on CQC reports or other forms attached to the CQC report. Mr. Tassin was instructed to report what items were checked and indicate if no deficiencies were observed and if any found to report specifically what part of equipment or item was found deficient and corrective action taken,

date and signature of the person responsible for the contents of the report. All safety inspections should be specific as to the phase of work underway, the location and results.

- 5. I also informed Mr. Tassin to carefully read the specifications concerning machinery and mechanized equipment, H-10 (f) and advised those involved to report all inspections and tests on the appropriate Safety Inspection Check List forms. All stability and/or performance tests shall be witnessed by the Contracting Officer or his authorized representative.
- 6. I then informed Mr. Tassin that LMV Form 359-R, Job Hazard Analysis is the responsibility of the CQC representative and he must review it at the preparatory meeting before beginning work on any new definable feature.
- 7. The following areas of safety were discussed:
- a. Hardhats: The entire project is a hardhat area. Hardhats are required for all equipment operators, laborers, and truck drivers.
- b. Shoes: Hard toe shoes are required, whereas canvas and tennis shoes are not permissable.
- c. Coordination With Others Having Operations at Same Location: Contractor was reminded that coordination with Sewerage and Water Board and other facility owners must be maintained so no delays or adverse impacts are experienced.
- d. Truck Hauling: The proper procedures for dumping and the removal of material from trucks were discussed.
- e. Unloading of Equipment and Materials: Use sufficient methods and personnel to avoid accidents and injuries.
- f. Environmental Protection: Methods on disposal of debris and protection of bayous, canals and waterways from harmful chemicals were discussed.
- g. Fire Control Fueling: Fire extinguishers are to be provided within 75 feet of storage and fueling (i.e. 20-B:C). All equipment must be provided with at least a 5-B:C fire extinguisher.

- h. Traffic Control: Contractor was reminded that the gates shall remain locked at all times when work is not being performed.
- i. Construction Facilities: The location, security and anchoring of the office trailers were discussed.
- j. Training Course and Continued Safety Education of Employees: Contractor's Accident Prevention Plan regarding this topic was discussed.
- k. Emergencies Drills and Procedures: Office trailer fire plans and drills in addition to the correct methods of reporting pollution spills were discussed.
- 1. Material Safety Data Sheet (MSDS): The requirements that all sheets be located in the trailer office was stated.
- $8.\,$ I then asked Mr. Tassin the day and time he would hold the weekly safety meeting. He stated that it would be held on Mondays at approximately $0800~hours.\,$ I reminded him that the minutes of the meeting should be attached or included on the CQC reports.
- 9. I informed Mr. Tassin and Mr. Commiskey that the Government had received and approved the contractor's revised Accident Prevention Plan. They were reminded of the prevention and correction of any deficiencies in the APP activities for any definable feature of work.
- 10. I then discussed the contractor's responsibility to coordinate and control the activities of any subcontractors on the jobsite.
- 11. Finally, I informed the contractor's representatives that the Government would continue to monitor the jobsite to assure adherence to all safety provisions of the contract.
