

2. Specifications
 - a. Reference page 02101-1, paragraph 1.2: Please verify measurement and payment paragraphs. There are many items that are given specifics in this paragraph.
 - b. Reference page 02221-1: In the insert paragraph, please specify unit of measurement for "Selective Demolition" as Lump Sum.
 - c. Reference page 02320-1, paragraph 1.2.2.2: Clarify item for Westside Approach Slab.
 - d. Reference page 02365-1 and (a): Title page and Table of Contents sheets needs to be reversed.
 - e. Reference page 02520-1, paragraph 1.2: Removal of Roadway Sec 02070, There is no section numbered 02070. Change to 02221-1 "Selective Demolition".
 - f. Reference page 02520-1, paragraph 1.2: Permanent Pavement Markings, Markers and Signing does not match title in 02845, change to Signing and Striping, sec. 02845.
 - g. Reference page 02722-1, paragraph 1.3: The unit of measurement for "Drainage Structures" needs to be added.
3. Drawings
 - a. Reference Drawing 105, Plan View, Quadrant D5: Please insert drawing number for Straight Web Tee.
 - b. Reference Drawing 106, Notes 2: correct typing error, 50% Bars
 - c. Reference Drawing 114, Quadrant C1: North Curtain Wall, correct typing error.
