We appreciate your interest in the Beaverhead-Deerlodge National Forest. You can help us get you the information you want by letting us know which parts of the forest interest you and what subjects interest you.

We use the mailing list when we try to find out who has interest in major projects we're considering. For instance, if we're starting an "environmental assessment" or "environmental impact statement" to analyze a mining proposal in the Jefferson Ranger District, we'd send a notice to everyone who circled "mining" and "Jefferson" on the other side of this sheet. We also use the mailing list to mail our annual monitoring report, and to contact people interested in special areas like Rock Creek (in Granite County).

**We're currently revising our forest management plan. If you want to be on the special mailing list for this, please indicate on the other side how you'd like to get information (we can mail you printed documents, mail you a CD, or email you to let know there's something to download from our website on the internet).**

Four times a year, we post a listing of all projects undergoing environmental analysis on the internet. It's called the "Summary of Proposed Action."
