Supplemental information needed for proposed limited timber harvest categorical exclusions

Subject: Supplemental information needed for proposed limited timber harvest categorical exclusion

The Forest Service has drafted proposed categorical exclusions for limited timber harvest in consultation with the Council on Environmental Quality (CEQ). The proposal is undergoing review by the Office of Management and Budget and should be published for public comment soon. You made an important contribution to this proposal by reviewing the effects of completed timber harvest projects. To ensure that our record is complete, the Forest Service and CEQ are requesting clarification of your finding of no significant cumulative impacts for the timber sales you reviewed in 2001. (CEQ regulations define cumulative impacts as the impact on the environment which results from the incremental impact of the action when added to other past, present, and reasonably foreseeable future actions regardless of what agency (Federal or non-Federal) or person undertakes such other actions.)

We need your help in responding by August 30.

To keep the impact on your time to a minimum, we developed a set of questions in a Lotus Notes database. This link will take you to the Lotus database. On the left side of the window that opens, you will see an icon for Entry Form. You will have access to create, edit and delete your own records. Others will not be able to modify your data. Once you have opened this database, you will find that an icon called Cat Exclusions has been placed in your list of databases, accessed by the Databases icon on the left side of your Lotus Notes window. The attached document shows the locations of these icons.
