What is a Landscape Assessment?


The Spring Mountains National Recreation Area (NRA), more commonly known to locals as Mt. Charleston, is developing an ecological landscape assessment for its entire 316,000 acres. A landscape assessment is a study to evaluate and characterize:


- social
- biological
- and physical elements of the forest.

Primary focuses will target past management actions and gathering information about historical resources, fire history, facilities, and transportation systems.

Why Prepare a Landscape Assessment?

Just 30 minutes from downtown Las Vegas, the cool mountain range makes a great getaway from the city's fast pace. Las Vegas' phenomenal population growth and its increasing






outdoor demands are greatly affecting the Spring Mountains NRA's precious natural resources. The Spring Mountains NRA is not only a sought-after location for public enjoyment, but is a critically important habitat for numerous plant and animal species that are only found here. The greatest challenge in managing the Spring Mountains NRA's annual two million visitors is providing both quality recreation and protecting this special forest environment.

What Are Some Possible Landscape Assessment Outcomes?

Managers will use assessment information as a strategic tool for creating and prioritizing future projects. For example:

- The **social study** will better explain visitors' wants and needs.
- The biological study will gather information about plant and animal species, habitats, and what is needed to sustain the Spring Mountains NRA.
- The physical study will provide much needed facts about soils, water, and geology.

To ensure that all interested parties are provided appropriate and timely information, a public website will be available by the end of 2004. In addition, a newsletter will be distributed twice a year.

During this event, the landscape assessment results will be shared and discussed through booths, presentations, and visuals. The Spring Mountains Information and Recreation Center will be constructed at the recently acquired Nel Property, which is located at the entrance of lower Kyle Canyon. Both projects will be conducted independently, but the data, public information, and comprehensive findings will complement and enhance each planning effort.
