1 Purpose of Document

USDA DM 3515-002 states: "Agencies are responsible for initiating the PIA in the early stages of the development of a system and to ensure that the PIA is completed as part of the required System Life Cycle (SLC) reviews. Systems include data from applications housed on mainframes, personal computers, and applications developed for the Web and agency databases. Privacy must be considered when requirements are being analyzed and decisions are being made about data usage and system design. This applies to all of the development methodologies and system life cycles used in USDA.

Both the system owners and system developers must work together to complete the PIA. System owners must address what data are used, how the data are used, and who will use the data. System owners also need to address the privacy implications that result from the use of new technologies (e.g., caller identification). The system developers must address whether the implementation of the owner's requirements presents any threats to privacy."

The Privacy Impact Assessment (PIA) document contains information on how PSS affects the privacy of its users and the information stored within. This assessment is in accordance with NIST SP 800-37 *Guide for the Security Certification and Accreditation of Federal Information Systems*.

2.2 System Overview

2.2.1 Cooperative Marketing Association System (CMA)

The FSA Cooperative Marketing Association System (CMA) is a National Computer System that is designed, maintained and operated to allow marketing cooperatives the ability to provide Cooperative Marketing Associations (CMAs) and Loan Servicing Agents (LSAs) timely and accurate eligibility, farm record and payment limitation data in order to determine producer eligibility for obtaining marketing assistance loans, loans and loan deficiency payments (LDP) through CMA's, LSAs and DMAs.

2.2.2 Price Support Systems Market and Assistance Loans

The Market and Assistance Loans automated price support system collects information associated with a producer's personal information and loan collateral (commodity).

Market loan repayment provisions specify, under certain circumstances, that producers may repay loans at less than principal plus accrued interest and other charges. Alternatively, loan deficiency payment (LDP) provisions specify that, in lieu of securing a loan, producers may be eligible for an LDP. For ELS cotton, LDP provisions do not apply and ELS cotton marketing assistance loans must be repaid at the loan rate plus interest.

2.2.3 Price Support

2.2.3.1 Electronic Loan Deficiency Payments (ELDP)-Web

The Electronic Loan Deficiency Payment system is the first e-government system sponsored by the Farm Service Agency. Through this web-based system, eligible producers can request loan deficiency payments via the World Wide Web 24 hours a day, seven days per week. The user interface to the system is hosted on Web Sphere Application Servers. The data is hosted on SQL Server databases residing at KC-ITSDO.

The eLDP application interfaces with Accounting (NPS), Production Adjustment (AGI and Eligibility), Compliance, Producer Name and Address (SCIMS), Role based Representation (eRep), and the Cotton Online Processing System (COPS). The system provides for tracking and reporting of automated farm-stored and warehouse-stored eLDPs issued to entities and producers as an alternative to Loans for Market Price commodities.

State and County Service Center Agency personnel access the eLDP application using OCIO-ITS CCE GSS workstations and the Department standard eAuthentication authorization solution. S/36 dependent payment limitation data and market gain reporting data is transmitted from the web farm to the County Office AS/400 on demand. eLDP resides on the OCIO-ITS Webfarm GSS located at the National Information Technology Center (OCIO-NITC).

2.2.3.2 State Online Reporting System (SORS)

Summary, detail, and history information from legacy Price Support files are partially replicated from VSAM datasets on the OCIO-NITC mainframe to a Sybase database also maintained by OCIO-NITC and used by the SORS Internet and Intranet State Office Reporting Systems.

2.2.3.3 Electronic Warehouse Receipts (EWR) (Rice)

7 CFR, Part 375, Regulations for the United States Warehouse Act (Act) provides that warehouse operators may issue an electronic warehouse receipt (EWR) for the agricultural product stored in their warehouse. The Farm Service Agency (FSA), under the general direction of the Deputy Administrator, Commodity Operations (DACO), has authorized the development of a Beta System for a Web-based centralized Electronic Warehouse Receipt system for rice.

The system shall provide the USDA Service Center the ability to access EWRs from a central EWR repository for price support purposes. The centralized FSA EWR System shall be the repository of EWRs for agricultural commodities requesting price support benefits. The system will interact with a Provider system (this system handles receipts between producers and the warehouse) and the FSA Service Centers in order to access and use EWRs to administer price support programs.

The centralized FSA EWR System shall be operational to handle EWRs for rice loan and LDP activities starting crop year 2005. In the future, the system shall be expanded to handle other EWRs for commodities eligible for price support loan and LDP.

2.2.4 Facility Loans

2.2.4.1 Farm Storage Facility Loans (FSFL)

The Farm Storage Facility Loans (FSFL) program provides loans to producers of certain crops to renovate or build storage and handling facilities. The FSFL mainframe system will track key application information, including State and County Code, application number, applicant/borrower ID, application date, facility type, and application amount. For the application statuses (Approval, Disapproval, Withdrawal or Deletion), the key elements are date of action and the approved application amount,

when applicable. The FSFL disbursement records will monitor disbursement dates and amounts against appropriated funding.

2.2.4.2 Sugar Storage Facility Loans (SFSL)

Section 1402 of the Farm Security and Rural Investment Act of 2002 authorized sugar farm stored facility loans. A new system was developed to manage and monitor FSFLs.

The mainframe system will track key application information: State and County Code, application number, applicant/borrower ID, application date, facility type, and application amount. For the application statuses (Approval, Disapproval, Withdrawal or Deletion), the key elements are date of the applicable action and the approved application amount, when applicable. The FSFL disbursement records will monitor disbursement date and the disbursement amount against appropriated funding.

2.2.5 Market Loss

2.2.5.1 MILC-X

Milk Income Loss Contract Extension (MILC-X), FSA's Milk Income Loss Contract Extension (MILC-X) Program, financially compensates dairy producers when domestic milk prices fall below \$16.94 per hundredweight. The program is available for fiscal years 2006-2007, and eligible producers can apply for program benefits anytime between March 13, 2006, and September 30, 2007.

2.2.5.2 Trade Adjustment Assistance (TAA)

Trade Adjustment Assistance (TAA) Under the Trade Adjustment Assistance (TAA) for Farmers Program, the U.S. Department of Agriculture helps producers of agricultural commodities adjust to competition from imports by providing them technical assistance, cash payments and opportunities for job retraining. TAA provides eligible producers a cash payment based on a formula, which provides partial compensation to producers for the decline in market prices below the 80 percent threshold required for TAA petition approval. The payment rate initially announced may be reduced based on the total number of commodities and producers approved for payment. This may be necessary because TAA funding is limited to \$90 million for each fiscal year. The maximum amount a producer can receive in any Federal fiscal year under TAA is \$10,000. This program is operational.

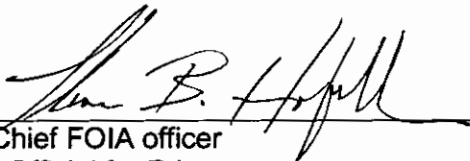

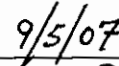

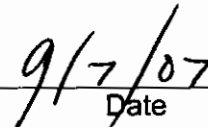
