Dear Mr. Ruehle:

The National Marine Fisheries Service (NMFS) reviewed the Essential Fish Habitat (EFH) assessment, dated June 23, 2003, prepared by the Alaska Department of Transportation and Public Facilities (ADOT&PF) for the above referenced project. The proposed project involves improving Seldovia Airport facilities to meet current state airport design standards including: widening and paving the access road that extends over Fish Creek, installing a water line along the access road, embedding a 12 inch sewer pipeline under Seldovia Slough and Fish Creek, and extending the runway 53 feet to the north.

Under Section 305(b)(2) Magnuson-Stevens Fishery Conservation and Management Act (Magnuson-Stevens Act) Federal agencies are required to consult with the Secretary of Commerce regarding any action that may adversely affect EFH. Federal agencies must prepare an EFH Assessment for any action that may adversely affect EFH. The EFH Assessment may be a separate document or clearly referenced in a support document, such as an environmental assessment (EA) or an environmental impact statement for the project. An EFH Assessment is outlined in 50 CFR Part 600.920 (e) and includes the mandatory contents: (i) a description of the action, (ii) an analysis of the effects on EFH, (iii) the agency's conclusions regarding the effects of the action on EFH, and (iv) proposed mitigation, if applicable.

ADOT&PF has determined that the project may adversely affect EFH. NMFS agrees with this determination. In accordance with 50 CFR 600.920 (f), consultation and commenting under sections 305(b)(2) and 305(b)(4) of the Magnuson-Stevens Act should be consolidated, where appropriate, with interagency consultation, coordination, and environmental review procedures required by other statues such as NEPA. Therefore, to streamline the environmental review process NMFS will defer reviewing the EFH Assessment until we receive the EA, which we understand you intend to provide shortly. NMFS will provide comments on the EA and EFH Assessment at the same time.
