Course Description:

This seminar will explore a range of approaches to environmental history using exemplary readings on North America, Asia, Africa, Latin America, and Europe. Themes covered will include the natural and cultural construction of landscapes, the evolution and impact of global and regional energy regimes, war and the environment, ecological consequences of empire, and the structures and implications of "modern" thought about nature and the environment.
