

## WORKSHOP PRE-TEST

**(Pre-2007 multiple primary/histology rules are used for all sites except CNS)**

1. Colonoscopy with biopsy was performed. The report states that there was a lesion 17 cm from the anal verge. The biopsy was positive for mucinous carcinoma. A partial proctectomy was performed. The pre-operative and post-operative diagnoses were both rectal carcinoma. The final pathologic diagnosis from the partial proctectomy specimen was tumor of the rectum, mucinous carcinoma.

The primary site is:

**C18.9                  C19.9                  C20.9                  C21.8**

2. Mammogram identified a right breast lesion in the upper outer quadrant. The lumpectomy operative report documented the resection of a right breast lesion at the 12 o'clock position of the right breast.

The primary site code is:

**C50.4                  C50.8                  C50.9**

3. Record the ICD-O-3 code for nodular malignant melanoma, mixed epithelioid and spindle cell type.

4. Patient has a single left upper lung lobe lesion. Pathology shows adenocarcinoma with a focus of squamous cell carcinoma.

The ICD-O-3 code for the histology is:

**8070/39                  8140/39                  8255/39                  8560/39**

5. The procedure performed was a re-excision and lymph node dissection for breast cancer. A 1 cm residual ductal carcinoma was identified. The surgical margins were clear. Metastatic carcinoma was identified in 3 of 6 axillary lymph nodes.

The CS lymph nodes code is:

**(25) Movable axillary lymph nodes**  
**(60) Axillary lymph nodes, NOS**

6. Patient had elevated PSA. DRE was normal. Biopsy of the prostate showed adenocarcinoma. Prostatectomy was performed and showed adenocarcinoma of the prostate with involvement of the anterior margins.

7. Pathology report documented that a cerebral meningioma invaded the skull.

8. At the time of surgery for bladder cancer, a single microscopic focus of incidental prostate cancer was diagnosed.

9. An incisional biopsy of the patient's right arm performed on 2/15 showed nodular malignant melanoma. An excision of lesion of the right arm performed on 2/28 showed residual nodular malignant melanoma with a 0.5 cm margin.

The surgical procedure of primary site code is:

**(33) Incisional biopsy followed by gross excision of lesion**

**(35) Mohs surgery with 1 cm margin or less**

**(45) Wide excision or re-excision of lesion with margins more than 1 cm**

10. CT scan was performed on 1/13. The impression was Pancoast tumor. A biopsy of the lung was performed on 1/15 and showed adenocarcinoma.
