<b>General Provisions</b>

Choctaw National Wildlife Refuge is one of over 500 national wildlife refuges. The primary objective of the National Wildlife Refuge System is to provide habitat for the conservation and protection of all species of wildlife. The harvest of surplus animals is one method used to manage wildlife populations. Carefully managed hunting helps maintain wildlife populations at levels compatible with their habitat, provides wholesome recreational opportunities, and permits the use of a valuable renewable resource.

### Accessibility

Those requiring special assistance to participate in all refuge activities are encouraged to contact the refuge manager.

A person with a disability may be given permission to use a vehicle to gain access to areas normally closed to this use.

#### General Hunting Regulations

The regulations listed below supplement the general regulations which govern hunting on National Wildlife Refuges as set forth in Title 50, "Code of Federal Regulations". State bag limits, arms and ammunition, and other applicable State regulations apply.

All U.S. Coast Guard and State boating regulations will be enforced.

Only designated game species may be taken; all other wildlife may not be molested in any manner.

No cutting of trees and no fires or camping are permitted on the refuge.

Camping facilities are available at Corps of Engineers' Lenoir Landing, or Highway #84 Service Area.

Boats may not be left on the refuge overnight.

# One permit good for all 2007 - 2008 Choctaw NWR Hunts for entire season as listed herein.

#### Driving directions

From Coffeeville, Alabama take Highway 84 across Tombigbee River going West. Take County Road 21 to Barrytown. Turn right on County Road 14 to refuge road. Watch for refuge signs from Highway 84 on to the refuge.

#### **Permits**

Permits are required for all hunts and for all hunters regardless of age.

#### Youth hunters

Youth hunters, anyone under the age of 16, must be supervised by an adult 21 years of age or older, and must remain in sight and normal voice contact with that adult.

This regulation sheet must be signed and carried on each person while hunting to serve as a permit.

Permits are non-transferable and must accompany proper state hunting license.

Hunters who fail to abide by all applicable regulations will also be considered to be hunting without permission.


Only permitted firearms are allowed during refuge small game hunting seasons. No loaded weapons are allowed in vehicles and weapons must be unloaded, and disassembled or cased, while vehicles and boats are in motion.

#### **Prohibited**

Possession of toxic shot (ie. lead, copper coated), shotgun shells or shot sizes not permitted is prohibited.

Hunting from a tree in which a metal object has been driven or screwed to support a hunter and all permanent stands are prohibited.

Organized drives are prohibited.



Cutting or trimming branches or brush for clear shooting lanes is prohibited.

Possession or use of any drug for hunting is prohibited.

The middle section of the refuge is accessible only by boat from the waters of Okatuppa Creek, Turkey Creek, or the Tombigbee River.

Hunting hours will be from onehalf hour before sunrise to onehalf hour after sunset.

Hunting will not be permitted within 100 yards of either the fenced-in Refuge Work Center Area, Hiking trail or the Refuge Boat Ramp.

Tree stand users are required to use a safety belt or harness.

Marking of trees, flagging tape and reflective tacks are prohibited.

#### Checkout stations

All hunters harvesting refuge wildlife must record harvest data at one of the checkout stations upon conclusion of each day's hunting.

Checkout stations and scales are available at the following boat ramps:

Bobby's Fish Camp (Highway #84)

Refuge Work Center (Womack Hill)

#### Rabbit and Squirrel

October 13-November 30, 2007 (Archery)

November 10-30, 2007 (Shotgun #4 non-toxic shot or smaller or .22 caliber rimfire rifles — no .22 magnums)

### White-tailed Deer (Archery)

October 13-November 30, 2007

## $Raccoon \ (night\ time)$

February 16-29, 2008 (Shotgun #6 or smaller non-toxic shot or .22 caliber rimfire [State regulations]. No hunting or running of dogs before sunset or after 3:00 am.)

### Feral Hogs (Archery)

March 15 -March 30, 2008

## Incidental Species

Raccoon, opossum, nutria, feral hogs, and coyotes may be taken during Fall hunts with those weapons legal during those hunts. A hunter cannot hunt the refuge with the sole intent of taking just these incidental species.

#### Dogs

Dogs are not permitted in Middle Swamp (between Okatuppa and Turkey Creeks) except during raccoon hunts.
