- 2. Was the 2001 contract a Total Small Business Set-Aside? Were any of the option year contracts (2002 2005) Total Small Business Set-Asides?
 - a. Yes.
- **3.** Is Aguirre International, Inc. eligible to bid on this solicitation, given the small business set-aside requirement and JBS's acquisition of Aguirre?
 - **a.** Aguirre International, Inc. is no longer a Small Business and therefore is not eligible to submit a proposal as a small business.
- 4. On page L-2 of the RFP the following sentence occurs: Offerors that are newly formed entities without prior contracts should list contracts and subcontracts as required above for all key personnel. Doesn't this sentence mean that if key personnel who worked for Aguirre form a new company they could use their work experience from Aguirre to satisfy experience requirements stated in the RFP? Have key personnel from Aguirre formed a new company?
 - **a.** Past performance information from key personnel who formed a new company will be accepted.
 - **b.** Also, as stated in Section M.3 (D), offerors without relevant past performance history or for whom information past performance is not available may not be evaluated favorable or unfavorably on past performance. In this instance the offeror would receive a neutral score.
 - **c.** The Government doesn't know if the key personnel from Aguirre have formed a new company.
- 5. In the Past Performance section on Page L-2, do you require submission of a total of five (5) past performance references collectively (a total for all entities included in the proposal (or individually (5 for the prime contractor, 5 for each subcontractor, etc.)? If it is a collective requirement, is there a specific breakout that we have to follow, i.e., at least 2 references from the offeror or at most 2 references from the major subcontractors?
 - a. Prime contractors are to submit five relevant contracts completed during the past three years. Their subcontractors are also to submit five relevant contracts completed during the past three years. Please make sure the information is correct and up to date on the past performance reference sheet. Failure of offerors to provide the correct information on the past performance reference sheets will hinder the Government's ability to allocate points for past performance.

- **6.** On Page L-2, the solicitation states that "all proposed personnel who handle the employer sampling frame data...must be 1) direct-hire employees of the contractor." Could you clarify the definition of direct-hire employees in this solicitation? If our major subcontractor is a security cleared, non-profit organization, may the employees of this subcontractor be considered "direct-hire employees?
 - a. Direct-hire is defined as a person not currently employed with the offeror but who has executed a binding letter for commitment for employment with the offeror, if the offeror receives award under this solicitation The Bureau of Labor Statistics (BLS) requires all handlers of the BLS-provided confidential employer sampling frame data to be direct-hire employees (not consultants) of the contractor because there are no provisions in the Confidential Information Protection and Statistical Efficiency Act (CIPSEA) that give BLS authoritative reach over consultants and/or subcontractors.
- **7.** Are the degree requirements outlined for the key personnel strict or is there flexibility in the field of study for the graduate degree.
 - a. The degree requirements for the Database Manager and Lead Interviewers are flexible. The degree requirement for the Project Manager is a Ph.D. in either Agricultural Economics or Economics. For the Manager of Training and Field Supervision, the requirement is masters or doctorate in Anthropology or another social science that includes survey and interview methods.
- **8.** Is the Privacy Act incorporated into the proposed contract? If so, what restriction(s) does that place on the handling of questionnaires and survey data?
